**21<sup>ST</sup> CENTURY BACCARAT**  
**DESIGNATED BONUS HAND JACKPOT**

**SUMMARY OF GAME**

Prizes are paid from a prize pool ("Jackpot Fund") funded by a fee paid by participating Players/Dealers. Players may qualify for the full 21st Century Baccarat Jackpot prize without paying a fee, or other consideration, by participating in free instructional games where there is no live wagering, no Jackpot Collection and no table fees ("No Purchase Necessary").

The rules and standards of play for the additional 21st Century Baccarat Jackpots are the same as in 21st Century Baccarat Jackpot Games. The number of cards in the deck, the type of deck, the function of the dealer, the number of players, rotation of the player-dealer position, collection of table fees, betting limits and how winners are determined and paid will all be consistent with the approved version of 21st Century Baccarat.

All designated bonus hand jackpot fee from the Players/Dealers will be collected in a separate collection box, which will be secured to the table and will be designated for the Jackpot Collection and used only for the collection of the jackpot funds. This will ensure that Jackpot Collections are kept separate and apart from the table fee collection.

**THE PRIZE**

A prize ("Jackpot Prize") will be awarded when Player/ Dealers place a fee at a game and Players obtains a specified hand and loses, pushes or win to a player/ dealer. As this is a fixed jackpot, the amount of the Jackpot Prize will remain constant. The available Jackpot Prize will be posted on either an electronic board or poster centrally located in the California Games section of the casino.

When Player/ Dealers or players obtain the specified hand combination and claim the Jackpot Prize, the dealer and a floorperson will verify the qualifying hands. Surveillance cameras will be utilized to assure all employees and customers followed the required procedures. The winning players' identification will be obtained and necessary paper work completed prior to the payout of the Jackpot Prizes. Crystal Park Casino Hotel will record all prizes awarded and the names of the winners as part of its 21st Century Baccarat Jackpot accounting records.

## **FUNDING**

21st Century Baccarat designated bonus hands Jackpot Prizes will be funded by a separate collection fee paid by Players/Dealers prior to the start of each hand ("Jackpot Collection"). The Jackpot Collection will be \$1.00 for Player/ Dealers. The amount of the Jackpot Collection will be posted within view of each participating table.

Jackpot Collections are determined and collected prior to the start of each hand. Jackpot Collections are not calculated based on a percentage of the amount wagered. Crystal Park Casino Hotel will provide the initial seeding of the Jackpot Fund and may from time-to-time provide additional infusions of money to add to the size of the pool and the excitement of the game.

## **JACKPOT COLLECTION & ACCOUNTING PROCEDURES**

The Jackpot Collection from all 21st Century Baccarat will be collected, counted, secured and recorded in the same manner as the table fees paid to Crystal Park Casino Hotel. The dealer will collect this fee (in the form of chips) prior to the start of each hand and deposit the fee in a locked Jackpot Collection Box at the table. The Jackpot Collection Box will be different from the box used for table fees. The locked Jackpot Collection Boxes will be gathered by casino security staff at designated times and transported to the secure Crystal Park Casino Hotel count room. In the count room, the Jackpot Collection Boxes will be unlocked and the contents counted subject to minimum internal control standards similar to those used by Crystal Park Casino Hotel in collecting its table fees and in other United States gaming jurisdictions. In addition, all count team activity is under constant observation of video cameras. The total dollar volume of the chips taken from each Jackpot Collection Box will be recorded on a Daily Jackpot Collection Report (Jackpot Collection Report) that will be maintained as an accounting record and shall be available to the Division of Gambling Control and the City for audit and inspection. The Jackpot Collection Report will document the amount of Jackpot Collections received at each participating 21st Century Baccarat gaming table during each shift.

## **NO PURCHASE NECESSARY PROCEDURES**

21st Century Baccarat Jackpots will be offered for free, on a "general and indiscriminate" basis, to patrons who wish to participate in a No Purchase Necessary game. Crystal Park Casino Hotel will provide instructional tables for all patrons who request to participate in 21st Century Baccarat Jackpots without paying a table fee or a Jackpot Collection. There will not be live wagers at these tables. Participants in No Purchase Necessary instructional tables will be eligible to win the full-posted Jackpot Prize when they obtain the designated Jackpot Hands.

A person(s) that comes to play the jackpot at the "no purchase necessary" table will be dealt the maximum of eight hands. The no purchase necessary player will play only one hand and the casino dealer will play the remaining.

No purchase necessary tables follow the identical rotation procedure as regular player-dealer games. A no purchase necessary player will be offered the opportunity to act as the player dealer for two consecutive hands per round of play. If there are eight live players and everyone accepts the player-dealer position, each player will have the opportunity to act as player-dealer two hands per round. If there are not eight players, the house dealer will play the hands for the vacant seats according to House Way. The house dealer will accept the opportunity to act as the player-dealer each time the opportunity arises.

Crystal Park Casino Hotel will follow the regular game procedure for no purchase necessary tables. The player-dealer button will rotate around the table after every second hand. Players have the opportunity to decline to act as player-dealer. To the extent that a house dealer is playing the hand for a vacant seat, he/she will accept the opportunity to act as player-dealer and will play all hands House Way.

Crystal Park Casino Hotel will do everything possible to make a no purchase necessary table available to patrons within fifteen minutes of a request. If no other patrons are available to participate in a no purchase necessary table within fifteen minutes of a request, Crystal Park Casino Hotel will provide a table where the no purchase necessary player will play only one hand and the casino dealer will play the remaining hands according to House Way.

### **THIRD PARTY PROVIDERS OF PROPOSITION PLAYER SERVICES**

Third Party Providers of Proposition Player Services, as defined by Section 19980 of the California Business and Professions Code, their agents and employees ("Prop Player"), are not eligible to win any portion of the Jackpot Prize. If a Prop Player receives a Qualifying Hand, its portion of the Jackpot Prize will not be paid and will remain in the Jackpot Fund. If a Prop Player is a participant in a Qualifying Hand with another player(s), the Prop Player will not be eligible to receive its portion of the Jackpot Prize and the full Jackpot Prize will be paid to the other players.

#### **Flat Administrative Fee**

Crystal Park Casino Hotel will retain a flat administrative fee from the Jackpot Fund based on the number of table hours that 21st Century Baccarat Jackpots are offered ("Administrative Fee"). The Administrative Fee will not fluctuate based on the amount of money placed into the Jackpot Fund. Crystal Park Casino Hotel will apply an Administrative Fee of \$5.00 per table hour.

### Qualifying Hand for 21st Century Baccarat:

In all California games, the player-dealer's hand plays against each of the other player's hands. If the player-dealer's hand has a lower ranking than a player's hand, the player-dealer loses the wager. If the player-dealer's hand has a higher ranking than a player's hand, the player-dealer wins the wager. If the player-dealer's hand ties with the other player's hand, the wager is a push. The no purchase necessary game rules are the same as regular rules.

The Qualifying designated bonus hands jackpot for 21st Century Baccarat Jackpots are:

1. 5 and 4 of Hearts = \$50. Natural 9 on first two cards.
2. 6 and 3 of Hearts = \$50. Natural 9 on first two cards.
3. 7 and 2 of Hearts = \$50. Natural 9 on first two cards.
4. Three Kings of Hearts = \$500. Two initially dealt cards to one hand plus one hit card to the same hand (first three cards).
5. Three Queen of Hearts = \$200. Two initially dealt cards to one hand plus one hit card to the same hand (first three cards).
6. Three Jacks of Hearts = \$200. Two initially dealt cards to one hand plus one hit card to the same hand (first three cards).
7. Joker- Joker = \$200. Two initially dealt cards to one hand (first two cards).

**SUMMARY OF THE GAME**

Based on customer demand, industry trends and desire to reward players more frequently, the Crystal Park Casino Hotel herein referred to as "CPCH", proposes to add an additional "Fixed Hand Jackpot Prize". The "Fixed Hand Jackpot Prize" will reward a player who receives a "Qualifying Hand" with a fixed prize or a progressive prize. The bonus hand(s) will be in addition to existing and approved Blackjack Jackpots that are offered in the California Games section of the Casino. These additional bonus hands will generate additional prize venues for the Casino patrons. CPCH will continue to offer the California Jackpot Games that may have been previously approved by the Division of Gambling Control.

It will now be possible for a player to win both the "Bad-Beat Jackpot" when applicable and the "Bonus Hand Jackpots" simultaneously with the same hand. Players may qualify for any Jackpot Prize without paying a fee or other considerations, by participating in a demonstration table where there is no live wagering, no fee or Jackpot Collection, or other considerations ("No Purchase Necessary").

**THE PRIZE**

When a player receives a pre-designated Bonus Hand in No Bust Blackjack, they will be awarded a pre-determined and advertised fixed prize or progressive prize which may be cash, merchandise, and/or tournament entries which will be selected prior to advertising of the Blackjack Bonus Hands Prize. CPCH will record all winnings as part of the California Jackpot Games Prize accounting records. The player will be paid regardless of whether their hand receives action in the normal course of a round of play. A player may be eligible to win a designated Bonus Hand and a Bad-Beat hand when applicable if their hand qualifies for both. Players will be aware of the available prizes and qualifying hands by signs placed at the gaming tables where the original jackpot hand is played.

A prize ("Jackpot Prize") will be awarded when one player places an optional fee at a game and obtains a specified hand and loses, pushes or wins to a player/dealer. As this is a Progressive Jackpot, the amount of the Jackpot Prize will vary depending on the volume of play and the frequency in which players obtain a Qualifying Hand. CPCH will control the allocation of the Jackpot Collection to Jackpot Prize. The available Jackpot Prize will be posted on either an electronic board or poster centrally located in the California Games section of the Casino. The posting will be updated as the prize is increased or decreased so that all players will have ample notice of the current Jackpot Prize.

When player(s) obtain the specified hand combination and claim the Jackpot Prize, the qualifying hands will be verified by the dealer and a floor person. Surveillance cameras will be utilized to assure all employees and customers followed the required procedures. The winning

player(s) identification will be obtained and necessary paperwork completed prior to the payout of the Jackpot Prizes. CPCH will record all prizes awarded and the names of the winners as a part of its No Bust Blackjack Jackpot accounting records.

CPCH reserves the right to inspect all reported winning bonus hands and to refuse payment of a Bonus Prize in the event that it is determined that proper rules and procedures were not followed and/or cheating occurred. CPCH will maintain records, including video surveillance, of all instances where a jackpot prize was not paid, for the purposes of future review by the Division of Gambling Control and/or other law enforcement agencies.

## FUNDING

Fixed and Progressive Jackpot Prizes will be funded by the same collection fee paid by the players prior to the start of each hand ("Jackpot Collection"). The Bonus Hand Jackpot Collection will be twenty five cents to one dollar per hand depending on the stakes of the game. The amount of the Jackpot Collection will be posted within view of each participating table. Bonus Hand Jackpot Collections are determined and collected prior to the start of each hand. Jackpot Collections are not calculated based on a percentage of the amount wagered. CPCH will provide the initial seeding of the Jackpot Fund and may, from time-to-time, provide additional infusions of money to add to the size of the pool and excitement of the game.

The Fixed Blackjack Bonus Prize will be funded by the players. Players' participation in this Bonus Jackpot Prize is optional. Players would post the fee for this Bonus Jackpot voluntarily regardless of their seating positions. The prize amount may also be progressive on one or more hands. Once a fixed prize or progressive prize is awarded, the amount will be immediately re-seeded or adjusted and be made available to all participating players. All funds for this prize will come from the California Games or Blackjack Jackpot Fund. The Casino may increase the prize amount in increments of 2x, 3x, 4x, etc., of the wager to the maximum prize amount, to add excitement to the game and to reward the players when there is a large jackpot reserve.

## JACKPOT COLLECTION AND ACCOUNTING PROCEDURES

The Jackpot Collection from all No Bust Blackjack will be collected, counted, secured and recorded in the same manner as the table fees are paid to CPCH. The dealer will collect this fee (in the form of chips) prior to the start of each hand and deposit the fee in a locked Jackpot Collection Box at the table. The Jackpot Collection Box will be different from the box used for table fees. The locked Jackpot Collection Boxes will be gathered by casino security staff at designated times and transported to the secure CPCH count room. In the count room, the Jackpot Collection Boxes will be unlocked and the contents counted subject to minimum internal control standards similar to those used by CPCH in collecting its table fees. In addition, all count team activity is under constant video camera observation. The total dollar volume of the chips taken from each Jackpot Collection Box will be recorded on a Daily Jackpot Collection Report ("Jackpot Collection Report") that will be maintained as an accounting record and shall be available to the Division of Gambling Control and the City for audit and inspection. The Jackpot Collection Report will document the amount of Jackpot Collections received at each participating No Bust Blackjack gaming table during each shift.

## NO PURCHASE NECESSARY PROCEDURES

No Bust Blackjack Bonus Hands Fixed and Progressive Jackpot Prizes will be offered for free, on a "general and indiscriminate" basis, to patrons who wish to participate in a No Purchase Necessary game. CPCH will provide instructional tables for all patrons who request to participate in these Jackpot Prizes without paying a table fee or a Jackpot Collection. There will not be live wagers at these tables. Participants in No Purchase Necessary instructional tables will be eligible to win the full-posted Jackpot Prize if they participate in a game where players obtain the designated Jackpot Hands. Any person(s) that comes to play the jackpot at the "No Purchase Necessary" table will be dealt the maximum of eight hands. The No Purchase Necessary player will play only one hand and the casino dealer will play the remaining. If the player wins the jackpot, only the portion of money that his/her hand qualifies for will be paid. The remainder will remain in the jackpot fund.

This will be done in the interest of fairness and in the spirit of the law, and as to give the No Purchase Necessary player the maximum opportunity to win a portion of the Jackpot Prize. No Purchase Necessary tables follow the identical rotation procedure as regular player/dealer games. A No Purchase Necessary player will be offered the opportunity to act as the player dealer for two consecutive hands per round of play. If there are eight live players and everyone accepts the player/dealer position, each player will have the opportunity to act as player/dealer two hands per round. If there are not eight players, the house dealer will play the hands for the vacant seats according to house way. The house dealer will accept the opportunity to act as the player-dealer each time the opportunity arises.

CPCH will follow the regular game procedure for No Purchase Necessary tables. The player/dealer button will rotate around the table after every second hand. Players have the opportunity to decline to act as player/dealer. When a house dealer is playing the hand for a vacant seat, he will accept the opportunity to act as player/dealer and will play all hands house way. If no other patrons are available to participate in a No Purchase Necessary table within fifteen minutes of a request, CPCH will provide a table where the No Purchase Necessary player(s) will play only one hand and the casino dealer will play the remaining hands according to house way.

## FLAT ADMINISTRATIVE FEE

CPCH will retain a Flat Administrative Fee from the Jackpot Fund based on the number of table hours that No Bust Blackjack Bonus Hands Fixed and Progressive Jackpot Prizes are offered ("Administrative Fee"). The Administrative Fee will not fluctuate based on the amount of money placed into the Jackpot Fund. CPCH reserves the right to adjust its Flat Administrative Fee based on market factors and cost of operating the No Bust Blackjack Jackpots. CPCH projects that its Administrative Fee will be \$6.00 per table hour. CPCH will designate the Flat Administrative Fee and will provide advance ample notice of its flat fee to all customers in accordance with Regulations adopted by the California Gambling Control Commission and/or the California Division of Gambling Control Regulations.

**ELIGIBILITY FOR THE JACKPOT PRIZE**

Any patrons participating in any position is eligible to win the Jackpot Prize. All players in the player position, who have made a wager and have paid the table fee for any betting circle, regardless the amount wagered, are eligible to win the Bonus Hand Jackpot Prize.

All persons seeking to participate in a California Jackpot Game on a No Purchase Necessary basis are eligible to win the fixed prize for the Blackjack Jackpot Games Bonus Hand, without placing a wager, paying a collection fee or other consideration, on a general and indiscriminate basis. California Jackpot Games Bonus Hands will not replace the already approved California Jackpot Games currently offered at CPCH. A player also has the opportunity to win both the California Jackpot Game Prize bad-beat hand when applicable as well as the Blackjack Jackpot Bonus Hand Prize if they receive a qualifying hand.

**FIXED HANDS**

The hands are listed for the particular games below. The alternate hands are provided for possible future use by the Casino. Changes from the original designated fixed hands may be made at the discretion of the Casino but will not be made until the Division is notified in writing. All designated hands and the corresponding prize amount will be prominently displayed on and around the gaming tables within the California section of the Casino as well as in advertisements, brochures, and on the various electronic display boards located around the gaming tables. If the fixed prize is merchandise or a tournament entry, the value of that particular prize will be clearly displayed on all advertisements, brochures, and electronic display board. The proposed initial fixed hands are:

*21<sup>st</sup> Century Blackjack*
2. Is a jackpot or any type of prize awarded?  
*Jackpot*
3. If a cash prize is involved, is the amount of the prize progressive (increases) or a fixed amount?  
*Progressive*
4. Is this gaming activity house funded or player funded?  
*Player Funded*
5. Is a special fee collection involved in this gaming activity, such as a jackpot fee collection?  
*Yes, a Jackpot Fee. Jackpot Fee Collections would be determined and collected prior to the start of each hand.  
Jackpot Collections would be \$1.00 per table per hand paid by the Player/ Dealer.  
The player in the Player-Dealer position would post the Jackpot Collection. When there is more than one player participating in the Player-Dealer position, the player who has the most money in action in the first Player-Dealer position will be responsible for posting the Jackpot Collection.*
6. Will the house seed the jackpot or prizes to be awarded?  
*Yes, \$1,000 seed. The minimum amount for the jackpot will be \$1,000.  
The Casino will update the Jackpot Prize Pool each day by 9:00am*
7. Is there a prize distribution involved to the winner, loser or any other players or customers?  
*Yes. The Player or Player/ Dealer who lost with the designated second hand will receive sixty percent (60%) of the posted Jackpot Prize, the Player or Player/ Dealer with the winning designated hand will receive twenty percent (20%) of the posted Jackpot Prize, and the remaining twenty percent (20%) of the posted Jackpot Prize will be evenly distributed among all other players at the table who have made a wager and paid a table fee collection for that particular hand.*

8. Once the prize is won, will it be re-seeded immediately?  
*Yes, immediately. Crystal Park Casino will update the Jackpot Prize amount on a daily basis, by 9:00AM, and this amount will be recorded on an electronic or text sign located in the 21<sup>st</sup> Century Blackjack table game area.*
9. Is there a minimum number of players required to be dealt into the game for the table to be eligible for the gaming activity and prize?  
*21<sup>st</sup> Century Blackjack is played with up to eight seated players. Two players are the minimum numbers for a valid jackpot.*
10. Is the house retaining any administrative or any other type of fee for operating the promotion?  
*Yes, a \$6.00 administrative fee for each hour on each 21<sup>st</sup> Century Blackjack tables participating.*
11. Is there an opportunity for a person to play for the prize without placing any live wagers or paying any table fees?  
*Yes. Patrons may elect to participate in the 21<sup>st</sup> Century Blackjack Jackpot by means of playing at a free instructional table. If only one patron is playing at the free instructional table, the patron is dealt one hand and seven 'dummy' hands are dealt. If only two patrons are playing at the free instructional table, each patron is dealt a hand, and six 'dummy' hands are dealt. This method would continue when there are only three, four, five, six or seven patrons at the free instructional table. There is no time restrictions applied to patrons at Crystal Park Casino free instructional tables. Patrons will win the jackpot prize amount when the Player/ Dealer received the qualifying jackpot hand. Patrons at a no purchase necessary table will be considered to be playing in the Player/ Dealer position and thus eligible for the jackpot if the qualifying hand is received.  
All advertisements will advise that a no purchase necessary element is available by contacting either a Floor Person or Concierge. Once contacting a Floor Person or Casino Services, the patron (s) will be accommodated at a free instructional table. Patrons only need to contact Casino Services or a Floor Person to play at a free instructional table. Tables will be ready within 10 or 15 minutes from the time requested (a dealer needs to be located and cards from the GECO room will need to be set up).*
12. Are there published/ proposed promotion or advertisement literature? If yes, copies must accompany this application.  
*Literature will not be available until approval of the jackpot is received by the Division of Gambling Control.*

*Since the jackpot element will be added to an existing game, the only change to the equipment will be in the addition of a separate collection box, which will be secured to the table and will be designated for the 21<sup>st</sup> Century Blackjack Jackpot Collection and used only for the collection of the jackpot funds. This will insure that Jackpot Collections are kept separate and apart from the table fee collection.*

**DEFINITIONS:**

**Administrative Fee.**

As described above, the Administrative Fee is a flat fee retained by CPCH from the Jackpot Fund based on the number of table hours that 21st Century Blackjack Jackpots are offered ("Administrative Fee").

**Jackpot Collection Report.**

As described above, the Jackpot Collection Report is an accounting of all Jackpot Collections received at each participating 21st Century Blackjack gaming table during each shift.

**Jackpot Fund.**

As described above, the Jackpot Fund is a prize pool funded by a fee paid by participating players.

**Jackpot Prize.**

As described above, the Jackpot Prize is awarded when the players obtain a Qualifying Hand. As this is a progressive jackpot, the amount of the Jackpot Prize will vary depending on the volume of play and frequency in which players obtain a Qualifying Hand. CPCH will control the allocation of the Jackpot Collection to Jackpot Prizes. The available Jackpot Prize will be posted on an electronic board centrally located in the

**No Purchase Necessary Procedures.**

As described above, No Purchase Necessary Procedures are available to any player who desires to participate in 21st Century Blackjack Jackpots without paying table fees.

**Jackpot Collections**

As described above, the dealer will take a Jackpot Collection, in the amount of \$1.00 per hand, prior to the start of each hand.

**Prop Player.**

Means a Third Party Providers of Proposition Player Services, as defined by Section 19980 of the California Business and Professions Code.

**Qualifying Hand.**

The combination of hands, designated by CPCH that makes players eligible to win the posted Jackpot Prize.

## **Application for Gaming Activity Review: Section III: Question & Answer**

**1. Name of Proposed Gaming Activity:**

Asian Games Promotional Chips/Voucher. Other names may be used. In all instances, the advertisements, signs and the each coupon will have the assigned GEGA number affixed.

**2. Name each controlled game that is associated with this gaming activity:**

No Bust 21<sup>st</sup> Century Blackjack and No Bust Blackjack.

**3. Describe any Jackpot or any other type of prize awarded:**

The prize will be casino chips awarded when a player uses an Asian games promotional chip (PC) and wins that particular hand. The PCs will be distributed by casino personnel in the following way:

1. During the play of a No Bust Blackjack or No Bust 21<sup>st</sup> Century Black Jack game, when a player or the player/dealer makes a "Natural," they will receive a PC. However, Third Party Providers of Propositional Services are in-eligible to receive a PC.

**4. If a cash prize is involved, is the amount progressive or a fixed amount?**

The prize amounts will range from \$5.00 to \$1,000.00.

**5. Explain if the gaming activity is House funded or player funded:**

Player funded. The person(s) in the Player/Dealer position will pay out when their hand is beat and when a player uses a PC to play that particular hand. However, a player wins with a PC, the person in the Player/Dealer position will collect it and pay the winnings in casino chips. The Player/Dealer with the PCs will have them refunded by a floorperson who will document the transaction in the amount listed on the coupon and place the verified PC in the cage.

**6. Describe any special fee collection involved in this gaming activity, for example, a Jackpot collection fee.**

The already approved collection for the controlled game will be taken when a bet is made utilizing PC.

**7. Describe how the Jackpot will be seeded and how prizes will be awarded.**

**8. Explain any prize distribution including prizes given to the winner, loser, or any other player or patron.**

When a player presents a AG coupon to play a particular hand in a Blackjack game, and they win that particular hand, they will be awarded that amount of money (in casino chips). When a patron receives a coupon they may use it in any of the controlled games listed above. Each coupon will state the specific qualifying game(s) that the coupon may be used on as well as the value of the coupon ranging from \$5 to \$1,000. The player will simply place this coupon on an eligible table and that will represent the amount that they are wagering on that particular hand. If a player has more than one AG coupon they can only use one per wager. Additionally, the player is still responsible for any collection fees that apply to a wager, as part of the base game.

**EXAMPLE:** A person receives a PC coupon with a value of \$5.00 that specifically states it may be used to place a wager on the Pure 21.5 Blackjack table. The player would place the coupon on the gaming table and pay the posted collection for a single hand of play. If the player wins the hand, he/she will receive \$5.00 just as if they had placed a \$5.00 bet and the player/dealer will collect the coupon. The player/dealer shall then have a floor person verify that it was used by a player and won against the player/dealer position. Once verified, the floorperson will document the use of the promotional chip in a log as well as the amount of the PC, and exchange the promotional chip with a casino chip of equal value. The floorperson will then take the verified promotional chip to the cage where it will be stored. All losing coupons will not have the option. If the player loses, the coupon is forfeited and the coupon will be collected by the casino dealer. If the player pushes (receives no action), the coupon may be played again until the player wins or loses a hand.

The floorperson will monitor the play of PCs and all collected ones will be tracked, document each PC transaction on a log as shown below, and stored in the casino's cage area.

There is no minimum or maximum number of players required to be participating in a game in order for a player to use a PC. Additionally, seated players as well as backline bettors can place a PC.

The promotional chip shall only be used as the player's initial wager and may not be used to double down or split. If a player splits or doubles down on their hand, they must use their own chips to do so.

The Bureau reserves the right to: (1) review the lawfulness of the Blackjack Progressive Jackpot; (2) notify all law enforcement agencies and gambling establishments if further review determines the Blackjack Progressive Jackpot to be unlawful; (3) require gambling establishments to cease and desist offering for play the Blackjack Progressive Jackpot if found to be unlawful; and (4) take action against those gambling establishments that decline to abide by the Bureau's cease and desist notification.*

### **Bureau Requirements**

#### **Advertising**

Crystal Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEGA-004732) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in Crystal Casino at all times the gaming activity is being offered for play

- Eligible games and time periods
- Qualifying hands and corresponding prize amounts
- Administrative fees
- No Purchase Necessary Information
- Any other restrictions that apply to this gaming activity

#### **Eligible Controlled Games**

The Blackjack Progressive Jackpot shall be attached to the following Bureau approved controlled games offered at Crystal Casino, as shown below, at all times that this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

- No Bust 21<sup>st</sup> Century Blackjack 4.0a Perfect Pairs (GEGA-004002)
- 21<sup>st</sup> Century Free Bet Blackjack (GEGA-004514)

#### **Object and Summary**

1. A player that achieves one of the qualifying hands listed below for the Blackjack Progressive Jackpot is eligible to win a fixed or progressive prize.
2. To begin each round, players must make their regular base game wager. They may optionally place any bonus bets along with the optional jackpot fee of \$1. "Hockey Puck" discs will be attached to the table in front of each betting position. These discs have a sensor and will detect when a casino chip is placed on them. Players must place the optional jackpot fee on the sensor. The sensor will then light up.
3. Once all players place their bets and/or jackpot fee, the house dealer will press "Game Start" on the keypad. The sensors will then light up, indicating participation in the progressive jackpot. The house dealer will then remove all jackpot fees from the table. The jackpot fees shall be dropped into a separate and locked jackpot collection box and accounted for separately.
4. The house dealer then follows standard approved procedures for dealing the base game. A player can qualify for the jackpot element of the game regardless of the outcome of the base game.

## Blackjack Progressive Jackpot

- When a player has achieved a winning hand, the house dealer shall press the appropriate button on the keypad. A casino representative will then be responsible for verifying the winning hand.

### Qualifying Hands

Players that make one of the advertised qualifying hands, as shown below, shall be eligible to win their share of the posted prize amount, according to the payout options, as shown below. All qualifying hands within a chart shall be offered together at all times.

Qualifying Hands

### Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours designated and posted for the gaming activity.

- Only seated players, who are dealt a designated hand and who have placed the optional \$1 jackpot fee are eligible for payouts. Backline bettors are not eligible to participate in this gaming activity.
- A minimum of two players, a player and the player-dealer, are required for this gaming activity.
- A minimum of three decks must be used in the base game in order for the game to qualify for the promotion.
- A player can qualify for the jackpot element of the game, regardless of the outcome of the base game.
- Winning players will be paid in live casino chips by a casino representative at their seat once their hand has been verified by a casino representative.
- There is no limit to the number of times a player can qualify for and win either the fixed or the progressive prize during any given promotional period.
- A player may place a base game wager as well as the optional jackpot fee on any unoccupied seat, as well as their own, and become eligible for multiple payouts.
- Casino employees are eligible to play when off duty and out of uniform.
- The player-dealer position is not eligible to participate in this promotion.
- Third-Party Providers of Proposition Player Services (TPPPS) are not eligible to place a jackpot collection fee and become eligible for the Blackjack Progressive Jackpot gaming activity when either in the player-dealer or player capacity.
- Tournament games are not eligible for this promotion.

### Prize

#### **Progressive Prize**

- Three seven's (7s) suited is paid 100% of the progressive jackpot amount shown on the progressive meter.

## Blackjack Progressive Jackpot

- All progressive payouts will be paid by a casino representative. Once the proper paperwork has been filled out, the casino representative will pay the winner in live casino chips. The payouts will not be made from the house dealer's tray.
- All other hands are paid from the reserve fund. They do not get deducted from the amount shown on the meter. In the event the reserve fund is depleted, the Casino will make up any shortfall and will be reimbursed when sufficient funds are available in the reserve fund.
- In the event more than one progressive meter payout or any other qualifying hand hits during the same round, all players with a qualifying hand will be paid the posted progressive prize or the posted fixed amount. When more than one progressive meter payout hits, one progressive pay will be paid from the meter and the others will be paid from the reserve fund. In the event the reserve fund is depleted, the Casino will make up any shortfall and will be reimbursed when sufficient funds are available in the reserve fund. All hands will be paid the posted prize.

### Fixed Prize

- All fixed payouts will be paid by a casino representative. Once the proper paperwork has been filled out, the casino representative will pay the winner in live casino chips. The payouts will not be made from the house dealer's tray.
- All fixed payouts will be deducted from the amount in the reserve fund and not from the progressive meter.
- In the event that more than one qualifying hand hits during the same round, all fixed prize winning players will be paid 100% of the posted fixed prize amount. In the event that the reserve fund is depleted, the Casino will cover any shortfall at their own expense and will be reimbursed when sufficient funds are available in the reserve fund. All hands will be paid the posted prize as shown in the pay table below.

### Funding

The Blackjack Progressive Jackpot is a player-funded jackpot with both fixed and progressive elements. The Casino will initially seed the jackpot at \$1,000. Once there are sufficient monies in the Blackjack Progressive Jackpot reserve fund, the initial seed will be reimbursed to the Casino from the reserve fund and shall be documented in the accounting records. After the progressive jackpot is hit, the progressive meter will be re-seeded by the reserve fund at a minimum of \$1,000. The progressive prize pool shall increase daily based solely on the number of jackpot collection fees placed and collected each day. There is no cap on the progressive jackpot. Furthermore, the Casino will cover any shortfall and will be reimbursed from the reserve fund once sufficient monies are collected.

Each \$1 jackpot fee paid by a player will be broken down as follows:

- \$0.20 will be immediately posted on the progressive meter.
- \$0.80 will be tracked in the reserve fund. The reserve fund will be utilized to immediately reseed the metered progressive jackpot at a minimum of \$1,000 following a progressive prize win. In addition, this reserve fund will be used to pay all fixed amount prizes and administrative fees.

**All monies collected and paid out shall be tracked both electronically and on a hand written log that shall be maintained by the Casino, for examination by regulatory and law enforcement personnel.**

## Blackjack Progressive Jackpot

### Administrative Fees

The Casino will take an administrative fee ranging from \$5-\$20 per table per hour. The administrative fee will be taken from the reserve fund. The fee will cover the costs associated with the complicated computer system and program in addition to technicians having to service the systems.

### No Purchase Necessary

The Blackjack Progressive Jackpot shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the Blackjack Progressive Jackpot. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

### Equipment

The electronic software and digital reader related to and used in conjunction with this jackpot, which is used on each table eligible for this jackpot, has been tested, approved, and certified by the Gaming Laboratories International, LLC (GLI).

- When a player has a progressive winner, the house dealer shall press the appropriate hand button on the keypad.
- The house dealer shall then contact the casino representative.
- Once the Casino verifies the progressive win, the casino representative shall press "Confirm", then swipe the authorization card. This records the win onto the Game Manager. House procedures are then followed for paying the prize.
- When the house dealer reconciles all action (on behalf of the player-dealer), he/she presses "Game Over." This resets the system to begin the next hand.
- Once the "Confirm" button is pressed and the authorization card swiped, the prize is logged into Game Manager.
- If the electronic software or digital reader malfunctions or breaks down, the jackpot will not be offered.

### **SUMMARY**

Based on customer demand and industry trends, the Crystal Casino & Hotel (CC) proposes to add a gaming activity to the currently approved Poker games. The promotion will award players who play the posted amount of time with instant cash in the form of casino chips.

### **PRIZE**

The prize will be a fixed cash amount ranging from \$10.00 to \$100.00. The monies will be offered to players who buy in a predetermined and posted amount of money and play in a designated game for a predetermined and posted amount of time.

### **FUNDING**

This promotion will be solely funded by CC. There will be no extra collection or fees of any kind assessed to the players.

### **NO PURCHASE NECESSARY**

Since there is not a “chance” element attached to this promotion there is not a requirement for the “no purchase necessary” procedure.

### **ELIGIBILITY**

The promotion will be open to all players who sign up for a new player card and who either never had a players card or had not played within a designated window of time at CC and who after obtaining a new player card play for a predetermined and posted amount of time and then buy in again for a predetermined amount of chips in a designated game. Current or past player cards holders at the time of the promotion are not eligible unless they have not played within the designated window of time which will be prominently posted.

The time for a session of play by a participant will be verified by the floorperson. After the player has participated in a game for the specified amount of time, the player will receive the bonus cash in the form of CC chips the next time the player buys in for a pre-determined amount of chips in a designated game.

*Example: The promotion states that if a new player card holder, after 2 hours of play, buys in to play for \$20 that the player will receive \$40 in chips.*

### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at an approved controlled table game during the pre-determined and specified hours designated for the promotion.

- There is no minimum or maximum number of players required to be playing in a designated game in order for the table game to be eligible for the promotion, other than what is previously required for game play.
- In the event that during a round of play, two or more players have qualifying hands, each player shall receive the posted prize amount.
- Tournament game tables are not eligible for this gaming activity.
- Casino employees are eligible to participate in the promotion when off duty and out of uniform.

This additional hand combination will generate additional prizes without additional cost to the poker players. The Crystal Park Casino will continue to offer the current Poker Jackpot games as they were approved by the Division of Gambling Control (Division). The Crystal Park Casino reserves the right to change the designated hands currently offered in the Poker Jackpot bad-beat hands to one of the variations listed in this proposal, and to notify the Division of such change.

The Crystal Park Casino will provide ample advance notice to the Division in writing as to anticipated changes in the designated hands for the existing bad-beat Qualifying Hands. The Crystal Park Casino will not deviate from the proposed Qualifying Hands listed in this proposal. The Crystal Park Casino will provide ample notice to the patrons via flyers, and the electronic Jackpot Prize Board which has a scrolling message display, of any changes to the Qualifying Hands. The additional Jackpot element will be funded by the existing Jackpot Fund. No additional collections or fees will be required. The existing Jackpot Fund is generated by a fixed, per hand table fee, previously approved by the Division.

Players may qualify for any Jackpot Prize without paying a fee or other consideration by participating at a demonstration table where there is no live wagering, no fee or Jackpot Collection, or other consideration ("No Purchase Necessary").

## THE PRIZE

During posted times, the Bonus Poker Jackpot Prize will be awarded when one player at a designated game obtains a specified Qualifying Hand regardless of whether the player wins or loses. The Crystal Park Casino will advertise the Bonus Jackpot Prize throughout the Poker section as well as with flyers and on the electronic Jackpot Prize Board. The Crystal Park Casino may infuse the Bonus Poker Jackpot Prize by multiples (i.e. 2x, 3 xs, etc.) during designated hours. The postings of the available Bonus Poker Jackpot Prize will be updated as it increases or decreases or is awarded. The postings will be immediately updated so players will have ample and current notice of the available Bonus Poker Jackpot Prize.

When players obtain the Qualifying Hands for the Bonus Poker Jackpot Prize, and claim the same, the hand will be verified in the same manner that the current Poker Jackpot Hand is verified by casino personnel. This includes physical verification by The Crystal Park Casino dealer, floorperson, and/or supervisor. Surveillance cameras will be utilized to ensure all employees and customers have followed the required rules and procedures. The winning player's identification will be obtained and all required paperwork will be completed prior to the payout of the Bonus Poker Jackpot Prize. The Crystal Park Casino will record all winnings as part of the Bonus Poker Jackpot Prize accounting records.

After a winning hand is confirmed, the player's hand will be verified by a floorperson. The fixed Jackpot Prize may be cash, merchandise, and/or tournament entries which will be selected prior to advertising of the Bonus Poker Jackpot Prize. A fixed Jackpot Prize will also be awarded among all other players at the table who have made a wager and paid a table collection fee for that particular hand. In the very unlikely event that two (2) players achieve a Qualifying Hand in the same round of play, only the highest two ranking hands will qualify. The remaining players will still share a fixed Jackpot Prize.

The Crystal Park Casino reserves the right to inspect all purported Qualifying Hands and to refuse payment of a Bonus Poker Jackpot Prize in the event that it is determined that proper rules and procedures were not followed and/or cheating occurred. The Crystal Park Casino will maintain records, including video surveillance, of all instances where a Bonus Poker Jackpot Prize was not paid, for the purposes of future Division and/or law enforcement review. The Jackpot Prize will be offered at \$25.00.

## **FUNDING**

The fixed Jackpot Prize will be funded by the same Jackpot Fund that is used for Poker Jackpot Prizes currently available at The Crystal Park Casino. The Jackpot Collection will not change from the current rate, nor will an additional rate be implemented for this proposal. In no way is the collection rate based on a percentage of the amount wagered in a game. There will be no additional cost to the poker customers. The Jackpot Collection is determined and posted prior to the start of each designated game. The amount of the collection is clearly displayed on each table where the Jackpot element is offered as well as in brochures and flyers.

The Crystal Park Casino may provide initial seeding of the Bonus Poker Jackpot Prize and may from time to time provide additional infusions of money to add to the size of the Bonus Poker Jackpot Prize as well as to the excitement of the game.

## **NO PURCHASE NECESSARY PROCEDURES**

The Bonus Poker Jackpot Prize will be offered to customers who wish to participate for free, on a general and indiscriminate basis. The Crystal Park Casino will offer a demonstration table for all customers requesting to participate for the Bonus Poker Jackpot Prize without requiring them to pay a table fee, Jackpot Collection or any type of consideration. There will be no live wagers at these tables. Participants in the no purchase necessary tables will be eligible to win their portion of the Bonus Poker Jackpot Prize if they receive the Qualifying Hand. The remainder of the Bonus Poker Jackpot Prize will remain in the Jackpot Fund.

As in other Jackpot games, in the event that only one patron requests to participate at a demonstration table for no purchase necessary, The Crystal Park Casino dealer at the demonstration table will deal additional hands to all empty seat positions at the table to simulate a full game, thus providing the patron the optimum chance to receive a designated Qualifying Hand. The dealer will monitor and play all hands dealt to the empty seat positions and play them according to the published house rules. Advertisements and rule sheets will advise all patrons that there is a general and indiscriminate opportunity to participate in a no purchase necessary game.

## **FLAT ADMINISTRATIVE FEE**

The Crystal Park Casino will retain a flat administrative fee from the Jackpot Fund based on the number of table hours played in the Jackpot Poker Games. This fee will be predetermined and accounted for. The fee is not based on the amount of money in the Jackpot Fund. The fee will take into consideration market conditions and the administrative cost of operating and administering the Jackpot Fund. The Crystal Park Casino has currently determined the administrative fee will be in the range of \$2.00 to \$6.00 per table hour for Poker Jackpot games. This is the same administrative fee that has been previously approved by the Division. The Crystal Park Casino does not anticipate any change in the fee at this time. There is no additional fee for the Bonus Poker Jackpot promotion.

## **ELIGIBILITY FOR THE JACKPOT PRIZE**

All players participating at a designated Bonus Poker Jackpot Prize table who place a wager and pay a collection fee are eligible for their share of the Bonus Poker Jackpot Prize. All persons seeking to participate in a Jackpot game on a no purchase necessary basis are eligible to win their share of the Bonus Poker Jackpot Prize as well, without placing a wager, paying a collection fee or other consideration, on a general and indiscriminate basis. The Bonus Poker Jackpot will not replace the already approved California Poker Jackpot games currently offered at The Crystal Park Casino, but will be an addition to it.

### **THIRD PARTY PROVIDER OF PROPOSITION PLAYER SERVICES**

**SUMMARY OF THE GAME**

Based on customer demand, industry trends, and the desire to reward players more frequently from the reserve of the California Jackpot Games Fund, The Crystal Park Casino proposes to add an additional fixed hand Jackpot Prize which will reward a player who receives a Qualifying Hand with a fixed prize. The fixed hand will be in addition to the currently approved California Jackpot Games offered in the California/Asian section of the Casino. This additional fixed hand combination will generate additional prizes for the patrons without additional costs or fees assessed to the players of California/Asian games. The Crystal Park Casino will continue to offer the California Jackpot Games as they were previously approved by the Division of Gambling Control (Division).

A player may win both a bad-beat jackpot and the fixed hand jackpot with the same hand. Players may qualify for any Jackpot Prize without paying a fee or other consideration by participating at a demonstration table where there is no live wagering, no fee or Jackpot Collection, or other consideration ("No Purchase Necessary").

**THE PRIZE**

When a player receives a pre-designated fixed hand for that particular California/Asian game, they will be awarded a pre-determined and advertised fixed prize which may be cash, bet vouchers, drawing tickets, merchandise, the opportunity to spin a five foot diameter wheel and/or tournament entries which will be selected prior to advertising of the California Jackpot Games Bonus Hand Prize. The Crystal Park Casino will record all winnings as part of the California Jackpot Games Prize accounting records. The opportunity to spin a five foot diameter wheel which contains 37 spaces on it where the spaces will be divided as follows: 1- \$1,000; 2-\$500; 3-\$300; 4-\$200; 5-\$100; and 20-\$50. A player may be eligible to win a designated fixed hand and a bad-beat hand if their hand qualifies for both. ### **FUNDING**

The fixed California Games Jackpot Prize will be funded via the current California/Asian Jackpot fund already approved by the Division at the Crystal Park Casino. There will be no additional cost to the California/Asian customers. The prize amount is not progressive. Once a fixed prize is awarded, the amount will be immediately re-seeded and available to all participating players. All funds for this prize will come from the California Games Jackpot Fund. The Casino may increase the prize amount in increments of 2x, 3x, 4x, etc., of the wager to the maximum prize amount, to add excitement to the game and to reward the players when there is a large jackpot reserve.

### **NO PURCHASE NECESSARY PROCEDURES**

The California Jackpot Games Bonus Prize will be offered to customers who wish to participate for free, on a general and indiscriminate basis. The Crystal Park Casino will offer a demonstration table for all customers requesting to participate for the California Jackpot Games Bonus Prize without requiring them to pay a table fee, Jackpot Collection or any type of consideration. There will be no live wagers at these tables. Participants at the no purchase necessary tables will be eligible to win the fixed prize of the California Jackpot Games Bonus Prize if they receive the designated fixed hand.

As in other Jackpot games, in the event that only one patron requests to participate at a demonstration table for no purchase necessary, The Crystal Park Casino dealer at the demonstration table will deal additional hands to all empty seat positions at the table to simulate a full game, thus providing the patron the optimum chance to receive a fixed hand for the California Jackpot Games Bonus Prize. The dealer will monitor and play all hands dealt to the empty seat positions and play them according to the published house rules. The Player/Dealer position will also rotate as if played in a live game. Advertisements and rule sheets will advise all patrons that there is a general and indiscriminate opportunity to participate in a no purchase necessary game for the California Jackpot Games Bonus Prize.

### **FLAT ADMINISTRATIVE FEE**

There is no additional administrative fee.

### **ELIGIBILITY FOR THE JACKPOT PRIZE**

All players participating in a designated California/Asian game that has a jackpot element attached and who places a wager and pays a collection fee are eligible for their share of the California Jackpot Games Bonus Prize. The fixed hands and the California Jackpot Games Bonus Prize will be made available for Pai Gow Poker, Pai Gow Tiles, No Bust Blackjack, Pan-9, 21st Century Baccarat, and Caribbean Stud Poker.

The hands are listed for the particular games below. The alternate hands are provided for possible future use by the Casino. Changes from the original designated fixed hands may be made at the discretion of the Casino but will not be made until the Division is notified in writing. All designated hands and the corresponding prize amount will be prominently displayed on and around the gaming tables within the California/Asian section of The Crystal Park Casino as well as in advertisements, brochures, and on the various electronic display boards located around the gaming tables. If the fixed prize is merchandise or a tournament entry, the value of that particular prize will be clearly displayed on all advertisements, brochures, and electronic display boards.

### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at an approved controlled table game during the pre-determined and specified times designated and posted for the gaming activity.

- There is no minimum or maximum number of players required to be playing in a designated game in order for the table game to be eligible for the drawing.
- In order to qualify for the drawing on Poker games, the player must complete the applicable bets on each round. If the player goes all-in, this is considered to have completed all bets.

## **Customer Appreciation Promotion**

### **Bureau Requirements**

#### **Advertising**

The Crystal Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEGA-004315) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for this gaming activity, including but not limited to the following, shall be prominently displayed in the Crystal Casino at all times the gaming activity is being offered:

- The date(s) and time(s) the gaming activity shall be offered.
- Time played and corresponding prize amount.
- The prize(s) offered for meeting the requirements of the gaming activity.
- How time will be tracked.
- Any other applicable restrictions.

#### **Eligible Controlled Games**

The EZ Baccarat Progressive Jackpot adds an optional \$1.00 player funded progressive and fixed jackpot elements to the game of EZ Baccarat (GEGA-002997). The EZ Baccarat Progressive Jackpot considers both the player and banker hands. To begin each round, players must make their regular base game wager. Players may optionally place any bonus bet wagers along with the jackpot fee of \$1.00. Once the house dealer removes all jackpot fees from the table, the jackpot fees will be dropped into a separate and locked jackpot collection box. The house dealer then follows standard approved procedures for dealing the base game. A player is NOT required to place a wager on the Dragon 7 Bonus Bet or the Panda 8 Bonus Bet in order to be eligible to place a wager on the EZ Baccarat Progressive Jackpot. This promotion will be available at predetermined dates and times posted in the Casino. When a winning hand is confirmed, the player with the qualifying jackpot hand will receive either a posted percentage of the progressive jackpot prize or a fixed prize, depending on the winning qualifying hand. A prize is awarded to players participating in the progressive jackpot when a qualifying hand is made.

1. "Hockey Puck" discs will be attached to the table in front of each betting position. These discs have a sensor and will detect when a casino chip is placed on them. Players must place the jackpot fee on the sensor. The sensor will then light up.
2. Once all players have placed their base wagers and jackpot fees, the house dealer will press "Start Game" on the keypad. The sensors will then light up, indicating participation in the progressive jackpot gaming activity. The house dealer will then remove all jackpot fees from the table. The jackpot fees will be dropped into a separate and locked jackpot collection box and accounted for separately.

## EZ Baccarat Progressive Jackpot

### Qualifying Hands

If the banker hand wins with a two or three-card total of 7 points, and the player hand totals 0, all EZ Baccarat Progressive Jackpot wagers will win, according to the qualifying hands listed below. Only hands that have been Bureau approved and pre-determined and designated by the Casino are eligible. Patrons will be provided with ample advance notice of what the qualifying hands are, as well as the requirements for completing the qualifying hands. Furthermore, the qualifying hands will be displayed prominently within the Casino at all times the EZ Baccarat Progressive Jackpot is being offered for play.

Players that make one of the advertised qualifying hands, as shown below, will be eligible to win their share of the posted prize amount, according to the payout options, as shown below. All qualifying progressive and fixed hands within a chart must be offered together at all times.

### Progressive Hands

Qualifying Hand	Description
Dragon 7 - Player 0 Suited	The banker hand wins with a three-card total of 7 points and the player hand totals 0. Cards in both the banker and player hands must be the same suit. <b>Example:</b> All cards in the banker hand are spades and all cards in the player hand are hearts.

### Fixed Hands

Qualifying Hand	Description
Dragon 7 - Player 0 Same Color	The banker hand wins with a three-card total of 7 points and the player hand totals 0. Cards in both the banker and player hands must be the same color. <b>Example:</b> All cards in the banker hand are red and all cards in the player hand are black.
Dragon 7 - Player 0	The bankers hand wins with a three-card total of 7 points and the player hand totals 0.
Banker Two-Card 7 - Player 0	The banker hand wins with a two-card total of 7 points and the player hand totals 0.

### Eligibility Requirements

This gaming activity will be open to all players who are seated and playing at any of the above listed controlled games during the pre-determined specified hours designated and posted for the gaming activity.

- There is no time requirement for how long a game must be played in order to be eligible for an EZ Baccarat Progressive Jackpot payout
- There is no limit to the number of times a player may win the EZ Baccarat Progressive Jackpot during the promotional period
- A player must make a base game wager in order to be eligible for this jackpot
- A minimum of two players, a player and a player-dealer, are required in order for the table to be eligible to participate in the EZ Baccarat Progressive Jackpot
- A player can qualify for the jackpot regardless of the outcome of the controlled game.
- Only seated players, who are dealt a designated hand, are eligible for payouts
- Casino employees are eligible for the EZ Baccarat Progressive Jackpot prize when they are off duty and out of uniform
- Tournament games do not qualify for the EZ Baccarat Progressive Jackpot

## EZ Baccarat Progressive Jackpot

- Backline bettors are not eligible to place a progressive jackpot fee
- The player-dealer position is not eligible for the promotion

### **Prize**

All monies collected and paid out will be tracked both electronically and on an excel spreadsheet that will be maintained by the gambling establishment, for examination by regulatory and law enforcement personnel. There is no cap to the jackpot.

A Casino floor person will pay all fixed payouts. Once the proper paperwork has been filled out, the floor person will pay the winner(s) in live casino chips. The payouts will not be made from the house dealer's tray; the live casino chips will come from the cage. All fixed payouts will be deducted from the amount in the reserve fund.

### **Prize Payout Structure**

Players that make one of the advertised qualifying hands, as shown above, will be eligible to win their share of the posted EZ Baccarat Progressive Jackpot prize amounts, according to the payout option as shown below. Patrons will be provided with ample advance notice of the prize payout being offered for play. Furthermore, it will be displayed prominently within the Casino at all times the EZ Baccarat Progressive Jackpot is being offered for play.

### **Funding**

The EZ Baccarat Progressive Jackpot is a player funded progressive jackpot. The Casino will initially seed the jackpot at a minimum of \$1,000 and to a maximum of \$50,000. Once there are sufficient monies in the EZ Baccarat Progressive Jackpot reserve fund, the initial seed will be reimbursed to the Casino from the reserve fund and will be documented in the accounting records.

After the progressive jackpot is hit, it will be re-seeded from the reserve fund at an amount between \$1,000-\$50,000. In addition this reserve fund will payout all fixed prize amounts. In the event the reserve fund is depleted, the Casino will make up any shortfall. Once there are sufficient monies in the reserve fund, the re-seed amount, up to the amount that the Casino funded, will be reimbursed to the Casino from the reserve fund and will be documented in the accounting records. All increases and decreases to the EZ Baccarat Progressive Jackpot reserve fund will be documented in the accounting records.

- Dragon 7 – Player 0 Suited is paid 100% of the progressive jackpot amount shown on the progressive meter
- All other hands are paid a fixed amount from the reserve fund, they do not get deducted from the amount shown on the meter
- In the event more than one progressive qualifying hand is hit during the same round, all winning players will share, in equal amounts, the posted progressive prize amount
- In the event the reserve fund is depleted, the Casino will make up any shortfall and will be reimbursed from the reserve fund once there are sufficient funds

## **EZ Baccarat Progressive Jackpot**

### **Administrative Fees**

Each \$1.00 jackpot fee paid by a player will be broken down as follows:

- a. \$0.15 will be immediately posted on the meter
- b. \$0.85 will be tracked in a reserve fund

The Casino will retain an administrative fee ranging in an amount between \$5 and \$20, taken per table hour. The administrative fee will be taken from the reserve fund. The fee will cover the cost associated with the complicated computer system and program in addition to technicians having to service the systems.

### **No Purchase Necessary**

The EZ Baccarat Progressive Jackpot will be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**, to patrons who wish to participate in a No Purchase Necessary game. The Casino will provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material will state "No Purchase Necessary" when referencing the EZ Baccarat Progressive Jackpot. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

### **Equipment**

The electronic software and digital reader related to and used in conjunction with this gaming activity has been tested, approved, and certified by the Gaming Laboratories International, LLC (GLI). If there is a malfunction or the digital reader breaks, the jackpot will not be offered.

- When a player has a progressive qualifying hand, the house dealer will press the appropriate hand button on the keypad
- The house dealer will then contact a supervisor
- Once a supervisor verifies the progressive win, the supervisor will press the confirm button. To complete the action, a supervisor or executive card (depending on jackpot level) swipe is required. This records the win onto the Game Manager computer and adjusts the meter appropriately for the prize won. House procedures are then followed for paying the prize. (Reviewing the monitor connected to the Game Manager will show the prize amount to be paid, and pressing the "money bag" icon will print a win page, which can be used to help record the payout for accounting)
- When the house dealer reconciles all action, he/she presses "END GAME." This resets the system to begin the next hand
- Once the supervisor or executive card (depending on jackpot level) is swiped the prize is logged into Game Manager
  - If the progressive pay needs to be backed out (voided) at this point, the prize will need to be manually backed out using the Game Manager manual adjustment feature

## Fortune Pai Gow Poker Progressive

*Although the Bureau has approved this jackpot modification, jackpots with an electronic component are currently under Bureau review. The Bureau reserves the right to: (1) review the lawfulness of the Fortune Pai Gow Poker Progressive; (2) notify all law enforcement agencies and gambling establishments if further review determines the Fortune Pai Gow Poker Progressive to be unlawful; (3) require gambling establishments to cease and desist offering for play the Fortune Pai Gow Poker Progressive if found to be unlawful; and (4) take action against those gambling establishments that decline to abide by the Bureau's cease and desist notification.*

### **Bureau Requirements**

#### **Advertising**

Crystal Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEGA-003245) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in Crystal Casino at all times the gaming activity is being offered for play:

- Eligible games and time periods.
- Qualifying hands and corresponding prize amounts.
- Administrative fees.
- No Purchase Necessary Information.
- Any other restrictions that apply to this gaming activity.

#### **Eligible Controlled Games**

The Fortune Pai Gow Poker Progressive Jackpot shall be attached to the following Bureau approved controlled games offered at Crystal Casino, as shown below, at all times this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

- Fortune Pai Gow Poker (GEGA-002060)

#### **Object and Summary**

1. The Fortune Pai Gow Poker Progressive considers the best hand possible among each individual player's cards.
2. To begin each round, players must make their regular base game wager. They may optionally place any bonus bets along with the optional jackpot fee of \$1. A minimum of two players are required to play for the progressive jackpot.
3. "Hockey Puck" discs will be attached to the table in front of each betting position. These discs have a sensor and will detect when a casino chip is placed on them. Players must place the optional jackpot fee on the sensor. The sensor will then light up.
4. Once all players place their bets and/or jackpot fee, the house dealer will press "Game Start" on the keypad. The sensors will then light up, indicating participation in the progressive jackpot. The house dealer will then remove all jackpot fees from the table. The jackpot fees shall be dropped into a separate and locked jackpot collection box and accounted for separately.

## Fortune Pai Gow Poker Progressive

5. The house dealer then follows standard approved procedures for dealing the base game. All seven cards will be considered. If the base game includes a joker, the joker shall be played per the base game rules. A player can qualify for the jackpot element of the game regardless of the outcome of the base game.
6. When a player has achieved a winning hand, the house dealer shall press the appropriate button on the keypad. A casino representative will then be responsible for verifying the winning hand.

### **Qualifying Hands**

Players that make one of the advertised qualifying hands, as shown below, shall be eligible to win their share of the posted prize amount, according to the payout options, as shown below.

### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the pre-determined specified hours designated and posted for the gaming activity.

- Only seated players, who are dealt a designated hand and who have placed the \$1 jackpot fee are eligible for payouts. Backline bettors are not eligible to participate in this gaming activity.
- A minimum of two players (player and player-dealer) are required for this gaming activity.
- A player can qualify for the jackpot element of the game, regardless of the outcome of the base game.
- Winning players will be paid in live casino chips by a casino representative at their seat once their hand has been verified by a casino representative.
- There is no limit to the number of times a player can qualify for and win either the fixed or the progressive prize.
- A player may place a base game wager as well as the optional jackpot fee on any unoccupied seat, as well as their own, and become eligible for multiple payouts.
- Casino employees are eligible to play when off duty and out of uniform.
- The player-dealer position is not eligible to participate in this promotion.
- Third-Party Providers of Proposition Player Services (TPPPS) are not eligible to place a jackpot collection fee and become eligible for the Fortune Pai Gow Poker Progressive gaming activity when either in the player-dealer or player capacity.
- Tournament games are not eligible for this promotion.

## Fortune Pai Gow Poker Progressive

### Prize

#### **Progressive Prize**

- A 7 Card Straight Flush (No Joker) is paid 100% of the progressive jackpot amount shown on the progressive meter.
- A 7 Card Straight Flush (with Joker) is paid 25% of the progressive jackpot amount shown on the progressive meter.
- All other hands are paid from the reserve fund. They do not get deducted from the amount shown on the meter. In the event the reserve fund is depleted, the Casino will make up any shortfall.
- In the event more than one progressive meter pay or any other qualifying hand hits during the same round, all winning players will be paid the posted progressive prize or the posted fixed amount. When more than one progressive meter pay hits, one progressive pay will be paid from the meter and the others will be paid from the reserve fund. In the event the reserve fund is depleted, the Casino will make up any shortfall. All hands will be paid the posted prize.

#### **Fixed Prize**

- All fixed payouts will be paid by a casino representative. Once the proper paperwork has been filled out, the casino representative will pay the winner in live casino chips. The payouts will not be made from the house dealer's tray.
- All fixed payouts will be deducted from the amount in the reserve fund and not from the progressive meter.
- In the event that more than one qualifying hand hits during the same round, all fixed prize winning players will be paid 100% of the posted fixed prize amount. In the event that the reserve fund is depleted, the Casino will cover any shortfall at their own expense. All hands will be paid the posted prize as shown in the pay table below.

### Funding

The Fortune Pai Gow Poker Progressive Jackpot is player funded with both fixed and progressive elements. The Casino will initially seed the jackpot at \$1,000. Once there are sufficient monies in the Fortune Pai Gow Poker Progressive Jackpot fund reserve, the initial seed will be reimbursed to the Casino from the reserve fund and shall be documented in the accounting records. After the progressive jackpot is hit, the progressive meter will be re-seeded by the reserve fund at \$1,000. The progressive prize pool shall increase daily based solely on the number of jackpot collection fees placed and collected each day. There is no cap on the progressive jackpot. Furthermore, the Casino will cover any shortfall.

Each \$1 jackpot fee paid by a player will be broken down as follows:

- \$0.14 will be immediately posted on the progressive meter.
- \$0.86 will be tracked in the reserve fund. The reserve fund will be utilized to immediately reseed the metered progressive jackpot at \$1,000 following a progressive prize win. In addition, this reserve fund will be used to pay all fixed amount prizes and administrative fees.

**All monies collected and paid out shall be tracked both electronically and on a hand written log that shall be maintained by the Casino, for examination by regulatory and law enforcement personnel.**

## Fortune Pai Gow Poker Progressive

### **Administrative Fees**

The Casino will take an administrative fee ranging from \$5 to \$20 per table per hour. The administrative fee will be taken from the reserve fund. The fee will cover the costs associated with the complicated computer system and program in addition to technicians having to service the systems.

### **No Purchase Necessary**

The Fortune Pai Gow Poker Progressive shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the Fortune Pai Gow Poker Progressive. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

### **Equipment**

The electronic software and digital reader related to and used in conjunction with this jackpot, which is used on each table eligible for this jackpot, has been tested, approved, and certified by the Gaming Laboratories International, LLC (GLI).

- When a player has a progressive winner, the house dealer shall press the appropriate hand button on the keypad.
- The house dealer shall then contact the casino representative.
- Once the Casino verifies the progressive win, the casino representative shall press "Confirm", then swipe the authorization card. This records the win onto the Game Manager. House procedures are then followed for paying the prize.
- When the house dealer reconciles all action (on behalf of the player-dealer), he/she presses "Game Over." This resets the system to begin the next hand.
- Once the "Confirm" button is pressed and the authorization card swiped, the prize is logged into Game Manager.
- If the electronic software or digital reader malfunctions or breaks down, the jackpot will not be offered.



## **Free Play Bet Voucher Promotion**

### **Bureau Requirements**

#### **Advertising**

The Crystal Casino may advertise various names for this gaming activity. Should the Crystal Casino advertise a different name, the BGC ID (GEGA-004314) shall be referenced on all advertisements relating to the Free Play Bet Voucher Promotion.

Furthermore, all rules and procedures for this promotion, including but not limited to the following, shall be prominently displayed in the Crystal Casino at all times the promotion is being offered:

- Eligible games and time periods.
- Free play bet voucher value(s).
- Procedures to redeem free play bet vouchers.
- Any other applicable restrictions.

#### **Eligible Controlled Game**

The Free Play Bet Voucher Promotion may be attached to all Bureau approved California controlled games offered at the Crystal Casino at all times that the gaming activity is being offered for play. All controlled game rules will be played as previously approved by the Bureau.

#### **Rules of Play**

Casino guests may receive Free Play Bet Vouchers via hand-delivery on or off the premises by authorized gambling establishment personnel, printed advertisements, websites, mailers, or by winning a Bureau approved promotion. Players who receive a Free Play Bet Voucher will be eligible to win the specific amount printed on the Free Play Bet Voucher if they have played it on a Bureau approved California Table Game without being required to place a bet.

#### **Voucher Redemption**

When a player has played the Free Play Bet Voucher on a Bureau approved California Table Game, and the hand wins, the player wins the specified amount printed on the voucher in chips only. The player must pay the posted collection fee per hand as if the Voucher was a regular wager. The Free Play Bet Vouchers shall state if it is a one time use voucher or if the voucher can be replayed until the hand loses.

#### **One Time Use Voucher**

When a player has played the one time use Free Play Bet Voucher on a Bureau approved California Table Game, and the hand pushes (receives no action), the player may continue to play the one time use Free Play Bet Voucher until the casino guest wins or loses a hand (receives action).

When the hand loses, the voucher will be collected by the house dealer and be voided and destroyed. If the hand wins, the one time use voucher will be collected and verified by a Casino Employee. The Casino Employee will then redeem the voucher at the casino cage for chips only and return the chips to the player that won. All vouchers received by the casino cage for redemption are then verified and stored by the casino cage staff.

The Free Play Bet Vouchers may not be used for bets with payouts greater than 3:2.

## **Free Play Bet Voucher Promotion**

### **Multiple Use Voucher**

When a player has played the Free Play Bet Voucher that can be replayed until the hand loses, on a Bureau approved California Table Game, and the hand wins, the Free Play Bet Voucher will be collected and verified by a Casino Employee. The Casino Employee will then redeem the voucher at the casino cage for chips only and return the chips to the player that won. The voucher will be given back to the player and it can be played again until the player loses. Once the hand does lose, the voucher is collected by the house dealer, at the table, to be immediately voided and destroyed by the player-dealer.

The Free Play Bet Vouchers may not be used for bets with payouts greater than 3:2.

### **Voucher Description**

The Free Play Bet Voucher shall include the card room name, a spot for the player's name to be written, how much can be redeemed from the voucher, dates that the voucher is valid, the associated games if applicable, and the appropriate BGC ID numbers.

### **Eligibility**

The promotion will be open to all players who are seated and playing at the above listed games during the pre-determined and specified hours designated for the promotion.

- A minimum of two (2) players, a player and a player-dealer, is required to be playing in any of the games, as listed above, in order for the game to qualify.
- Players shall not exchange the vouchers for live chips.
- Vouchers are non-transferable.
- The vouchers and chips shall only be redeemed after having been played and verified by a key employee.
- Players do not have to play for a specified time in order to qualify for this promotion.
- Casino Employees, on and off duty and in and out of uniform, are not eligible for the promotion.
- Third-Party Providers of Proposition Player Services (TPPPPS), on and off duty, are not eligible for the promotion.

### **Prize**

The Free Play Bet Vouchers shall have a value ranging from \$5 - \$500 for each voucher. Players shall not exchange Free Play Bet Vouchers for live chips. Additionally, players shall not give them to another player. The Free Play Bet Vouchers cannot be exchanged for cash. The vouchers shall only be redeemed after having been played and verified by a key employee.

### **Funding**

The Free Play Bet Voucher Promotion shall be fully funded by the Crystal Casino. There shall be no additional promotion fees or jackpot fees taken in order to fund this gaming activity or for players to participate.

### **No Purchase Necessary**

The Free Play Bet Voucher Promotion does not contain the element of chance. Therefore, it does not constitute an illegal lottery and does not require a No Purchase Necessary table to be offered while conducting this gaming activity.

# Crystal Casino Game Voucher Promotion

## Advertisement Requirements

The Crystal Casino may advertise various names for this gaming activity. Should The Crystal Casino advertise a different name, the BGC ID listed shall be referenced on all advertisements relating to the Voucher Promotion.

Furthermore, all rules and procedures for this promotion, including but not limited to the following, shall be displayed conspicuously and prominently in The Crystal Casino at all times the promotion is being offered:

- Eligible games and time periods.
- Voucher and Match Play Voucher value.
- Procedures to redeem Vouchers and Match Play Vouchers.
- Any other applicable restrictions.

## Controlled Game

The Voucher Promotion may be attached to all limits and versions of the approved California games offered at The Crystal Casino. All base game rules will be played as previously approved by the Bureau of Gambling Control.

## Rules of Play

Patrons are awarded vouchers via advertisements in magazines, websites, mailing advertisements, winning a Bureau approved promotion, winning or signing up for a Bureau approved tournament, etc. Players who receive a Voucher or Match Play Voucher will be eligible to win the specific amount printed on the coupon.

## Voucher

The prize will be awarded to a player when placing a Voucher in place of a regular game wager and the hand is a winning hand. The player must pay the posted collection fee per hand as if the Voucher was a regular wager. A winning hand will be paid the amount listed on the Voucher. If the player loses the hand, the Voucher is forfeited and will be collected by the Casino dealer. If the player pushes (receives no action), the Voucher may be played again until the player wins or loses a hand. Winning Match Play Vouchers must be verified and signed by a Casino employee. The Vouchers are then taken to the Casino cage by the Casino employee, where they are exchanged for the value listed on the voucher. The player-dealer will then have a Casino employee sign the voucher verifying that it has been won. All winning vouchers are verified and signed by a Casino employee. If a player loses, the money part of the wager is collected by the player-dealer, and the voucher is voided and collected as well. If the player pushes (receives no action), the voucher may be played again until the player wins or loses a hand.

**EXAMPLE:** *A person receives a voucher for \$10.00 that specifically states it can be used to place a wager on the No Bust Blackjack table. The player would place the voucher on the gaming table; pay the posted collection and the game would play. If the player wins the hand, they will receive \$10.00.*

# Crystal Casino Game Voucher Promotion

## Match Play Voucher

The Crystal Casino may also use the Voucher to offer a match play option for the player. This will be clearly stated on the Voucher. The prize will be awarded to a player when placing a wager combined with Match Play Voucher and the hand is a winning hand. The wager must be equal to the amount of the Match Play Voucher and a player's winning hand will be paid their wager as well as the listed amount on the match play coupon. When the player uses a Match Play Voucher and the hand loses, the player will only lose his/her original wager and the Match Play Voucher is collected and voided. Winning Match Play Vouchers must be verified and signed by a Casino employee. The Vouchers are then taken to the Casino cage by the Casino employee, where they are exchanged for the value listed on the voucher. The player-dealer will then have a Casino employee sign the voucher verifying that it has been won. All winning vouchers are verified and signed by a Casino employee. If a player loses, the money part of the wager is collected by the player-dealer, and the voucher is voided and collected as well. If the player pushes (receives no action), the voucher may be played again until the player wins or loses a hand.

**EXAMPLE:** *A person receives a Match Play Voucher with a value of \$5.00 that specifically states it may be used to place a wager on the Pai Gow Poker table. The person would place the voucher on the gaming table; place a bet that matches the amount on the voucher, and pay the posted collection (if applicable) for a single hand of play. The collection fee is the total amount of the live wager as well as the game voucher. If the player wins the hand, he/she will receive \$10.00 just as if they had placed a \$10.00 bet and the player-dealer will collect the voucher.*

## Prize

The Vouchers and Match Play Vouchers shall have a value ranging from \$5 to \$500 for each voucher. Players shall not exchange Vouchers or Match Play Vouchers for live chips. Additionally, players shall not give Vouchers or Match Play Vouchers to another player. The Vouchers and Match Play Vouchers shall only be redeemed after having been played and verified by a Casino employee.

## Eligibility

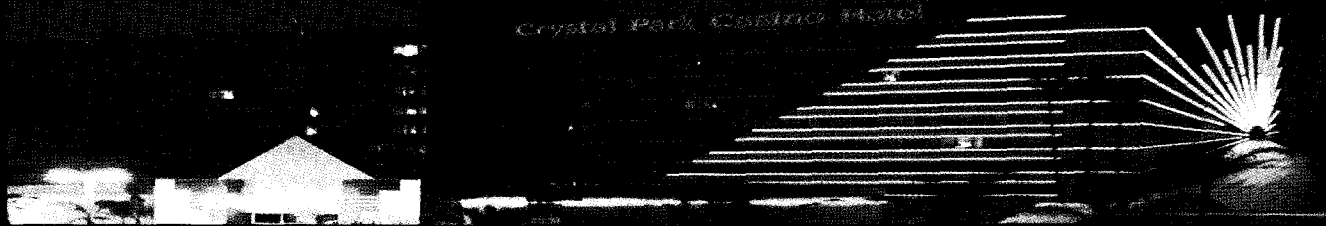

In regards to your June 17, 2002 letter addressed to Jim Smith – Director of Gaming, Crystal Park Casino Hotel (CPCH), the following will address your questions:

#### High Hand Hi-Lo


1. What games are involved in High Hand Hi-Lo?  
All approved Poker games
2. Provide details on the games offered under High Hand Hi-Lo to include: table limits, any fee collection and who pays and when paid.  
Please refer to the December 21, 2001 gaming report submitted to the attention of Ed Ching for details on game play, table limits and fee collections. Patrons pay collection rates at the start of the game.
3. What constitutes a qualifying hand for each game that is involved in High Hand Hi-Lo?  
Top five ranking Poker hands from all Poker games for the week beginning on each Sunday at 9:01 PM qualify.
4. Is an ID required for players who are not playing at a free table?  
No identification is requested at either no purchase/ free instructional tables. The only exception would be for patrons who appear to be under the age of twenty-one.

RE: High Hand/ Casino Fever Promotion

Casino Fever Hi-Lo

1. In Pan 9, what constitutes a Natural nine on the first three cards?  
A total of a '9' in the first three cards dealt.  
Example: 3 + 3 + 3 = Natural nine
2. A suited twenty one is referenced in Blackjack as a winning hand that would receive a free entry ticket? Explain how this does constitute not a prohibited game and does not violate the Penal Code?  
Ace plus a ten-value card is a Blackjack. A suited is when the Ace plus the ten-value card are of the same suite.  
Example: Ace of heart plus ten of heart.
3. Explain how the Hi-Lo contest operation does not constitute a game of chance and an illegal lottery under the Penal Code?  
Penal Code Section 330 proscribe certain specifically identified card and gambling games, as well as any banking or percentage game (In Sullivan vs. Fox, 1987, 189 Cal. App. 3D 673, 678-679). The Court of Appeals identified a banking game as one in which the house or bank is the principal participant in the game. A percentage game is one in which the house does not directly participate in the game, but collects a percentage from the game which may be computed from the amount of the bets made, winnings collected.  
Since the Hi-Lo contest has no banking or percentage format and the game is not one of the eleven games prohibited under Section 330 of the Penal Code, CPOCH is of the opinion that this promotion violates no state or local laws and should be allowed to be offered to our patrons.

## Mississippi Stud Progressive Jackpot

*Although the Bureau has approved this jackpot, jackpots with an electronic component are currently under Bureau review. The Bureau reserves the right to: (1) review the lawfulness of the Mississippi Stud Progressive Jackpot; (2) notify all law enforcement agencies and gambling establishments if further review determines the Mississippi Stud Progressive Jackpot to be unlawful; (3) require gambling establishments to cease and desist offering for play the Mississippi Stud Progressive Jackpot if found to be unlawful; and (4) take action against those gambling establishments that decline to abide by the Bureau's cease and desist notification.*

### **Bureau Requirements**

#### **Advertising**

Crystal Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEAR-001248) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in Crystal Casino at all times the gaming activity is being offered for play:

- Eligible games and time periods
- Qualifying hands and corresponding prize amounts
- Prize payout structure
- Administrative fees
- Availability of No Purchase Necessary
- Any other restrictions that apply to this gaming activity

#### **Eligible Controlled Games**

The Mississippi Stud Progressive Jackpot shall be attached to the following Bureau approved controlled games offered at Crystal Casino, as shown below, at all times this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

- Mississippi Stud Poker (GEGR-002150)

#### **Object and Summary**

A player may win a progressive or fixed jackpot prize by placing an optional \$1 jackpot fee and making a predetermined qualifying hand listed below. Also, a player who places an optional \$1 jackpot fee qualifies to win an Envy payout.

- To begin each round, players must make their regular base game wager. They may place any bonus bets along with the optional jackpot fee of \$1. A minimum of two players, a player and a player-dealer, are required to play for the progressive jackpot.
- "Hockey Puck" discs will be attached to the table in front of each betting position. These discs have a sensor and will detect when a casino chip is placed on them. Players must place the optional jackpot fee on the sensor. The sensor will then light up.
- Once all players place their bets and/or jackpot fee, the house dealer will press "Coin In" on the keypad. The sensors will then light up, indicating participation in the progressive jackpot. The house dealer will then remove all jackpot fees from the table. The jackpot fees are dropped in a separate and locked jackpot collection box affixed to the gaming table.



## Mississippi Stud Progressive Jackpot

- The house dealer then follows standard approved procedures for dealing the base game.

### Qualifying Hands

Players that make one of the advertised qualifying hands, as shown below, will be eligible to win their share of the posted prize amount, according to the payout options, as shown below. All qualifying progressive and fixed hands within a chart and listed below must be offered together at all times

### Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours posted for the gaming activity.

- Backline bettors are not eligible to place a jackpot fee nor receive the prize amount for a designated hand.
- There is no limit to the number of times a player can win either the progressive or fixed jackpots.
- Casino employees are eligible for the Mississippi Stud Progressive Jackpot only when off duty and out of uniform.
- Third-Party Providers of Proposition Player Services (TPPPS) are not eligible to place a jackpot collection fee and become eligible for the prize when either in the player-dealer or player capacity.
- The player-dealer position is not eligible to place an optional jackpot fee nor win a prize.
- Players who are playing multiple hands may place a jackpot fee for each hand and be eligible to win multiple prizes.
- In the event more than one fixed qualifying hand is hit during the same round, all winning players will receive the posted prize amount.
- In the event more than one progressive qualifying hand is hit during the same round, all winning players will share, in equal amounts, the posted progressive prize amount.
  - In the event there is an odd number of chips, the extra dollar will be awarded to the patron who received action on the hand first according to the game rules.
- In the event that more than one player achieves a hand associated with an Envy pay, all other players will receive multiple Envy payouts.

## Mississippi Stud Progressive Jackpot

### **Prize**

All monies collected and paid out will be tracked both electronically and on a hand written log that will be maintained by the gambling establishment, for examination by regulatory and law enforcement personnel.

### **Fixed Prize**

- When a player is dealt a Straight, Flush, Full House or Four of a Kind, they are paid a fixed prize amount according to the payout table above.
- All fixed prize payouts will be paid by a casino representative. Once the proper paperwork has been filled out, the casino representative will pay the winner(s) in live casino chips. The payouts will not be made from the house dealer's tray. All fixed prize payouts will be deducted from the amount in the reserve fund. Any shortfall will be covered by the Casino.

### **Progressive Prize**

- When a player is dealt a Royal Flush, the player is awarded 100% of the progressive jackpot shown on the progressive meter.
- When a player is dealt a Straight Flush, the player is awarded 10% of the progressive jackpot shown on the progressive meter.
- All other hands are paid from the reserve fund. They do not get deducted from the amount shown on the meter.
- All progressive prize payouts will be paid by a casino representative. Once the proper paperwork has been filled out, the casino representative will pay the winner(s) in live casino chips. The progressive prize payouts will not be made from the house dealer's tray; the live casino chips will come from the cage.

### **Envy Bonus**

- A player who placed the optional \$1 jackpot fee qualifies to win an Envy payout. If another player at the table achieves a hand associated with an Envy pay, all other players who paid the optional \$1 jackpot fee will win the Envy pay. The player who achieves a qualifying hand is only eligible for the normal prize and will NOT receive the Envy pay.
- In the event that more than one player achieves a hand associated with an Envy pay, all other players will receive multiple Envy payouts. The players who achieved the qualifying hands are only eligible for the normal prize and will NOT receive the Envy pay.
- If a player's hand triggers an Envy payout, the house dealer will leave the hand face-up on the layout; otherwise, the house dealer will lock up the cards. The house dealer will then move on to the next player.
- All Envy Bonus payouts will be paid by a casino representative at the end of the round. Once the proper paperwork has been filled out, the casino representative will pay the winner(s) in live casino chips. The payouts will not be made from the house dealer's tray. All Envy Bonus payouts will be deducted from the amount in the reserve fund.

### **Funding**

The Mississippi Stud Progressive Jackpot is a player funded progressive jackpot. The jackpot features both fixed and progressive prizes. There is an optional \$1 jackpot fee required to be eligible for the prize. The jackpot fee must be placed along with a base game wager in order to participate in the jackpot.

## Mississippi Stud Progressive Jackpot

Each \$1 jackpot fee will be broken down as follows:

- \$0.20 will be immediately posted on the meter.
- \$0.80 will be tracked in a reserve fund.

The Casino will initially seed the jackpot at \$1,000. Once there are sufficient monies in the Mississippi Stud Progressive Jackpot reserve fund, the initial seed will be reimbursed to the Casino. There is no cap to the Mississippi Stud Progressive Jackpot.

After the progressive jackpot is hit, it will be re-seeded by the reserve fund at a minimum of \$1,000. In the event the reserve fund is depleted, the Casino will make up any shortfall.

Once there are sufficient monies in the reserve fund, the re-seed amount will be reimbursed to the Casino from the reserve fund and shall be documented in the accounting records. All increases and decreases to the Mississippi Stud Progressive Jackpot fund shall be documented in the accounting records.

The reserve fund will also be used to pay out all fixed prize and Envy payout amounts. In the event the reserve fund is depleted, the Casino will make up any shortfall and will not be reimbursed.

### **Administrative Fees**

Crystal Casino shall retain an administrative fee of \$5-\$20 per table per hour and is taken from the jackpot reserve fund. The administrative fee shall be utilized to cover expenses incurred for administering the Mississippi Stud Progressive Jackpot.

### **No Purchase Necessary**

The Mississippi Stud Progressive Jackpot shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the Mississippi Stud Progressive Jackpot. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

### **Equipment**

The electronic software and digital reader related to and used in conjunction with this jackpot, which is used on each table eligible for this jackpot, has been tested, approved, and certified by the Gaming Laboratories International, LLC (GLI).

- When a player has a progressive winner, the house dealer shall press the appropriate hand button on the keypad.
- The house dealer shall then contact a Casino representative.
- Once the casino verifies the progressive win, the Casino representative shall insert the key and rotate it to "JPH" and then press "J-pot" button. This records the win onto the Game Manager. House procedures are then followed for paying the prize.
- Returning the key to the "Run" position will restore normal operation of the table, and adjust the meter appropriately for the prize won.
- When the house dealer reconciles all action (on behalf of the player-dealer), the house dealer presses "Game Over." This resets the system to begin the next hand.



Crystal Park Table Jackpot will be offered for free to all persons who wish to participate in a No Purchase Necessary. CPCH will provide free instructional tables for all patrons who wish to participate in a Crystal Park Table Jackpot without paying a table fee or a Jackpot Collection. There will not be live wagers at these tables. Participants in No Purchase Necessary free instructional tables will be eligible to win the full-posted Jackpot prize when a designated Jackpot Hand has been achieved. There are no time restraints for patrons participating in a Jackpot by means of a free instructional table. Either a Shift Manager or a Floor Manager explains how the game is played and what constitutes a qualifying Jackpot hand to all patrons at free instructional tables.
  
8. Explain how the Casino will accommodate only one person wishing to play without placing a live wager or paying any table fees?  
The one patron would be accommodated and be eligible for the jackpot in the same manner as if there were more than one patron at either a fee table or a free instructional table. If only one patron is participating in the Jackpot, the dealer would deal one hand to that patron and would deal four (4) dummy hands. If only two patrons are participating in the Jackpot, the dealer would deal one hand each to those two patrons and three (3) dummy hands, and so on. There are no time restrictions on patrons participating at a No Purchase Necessary table.

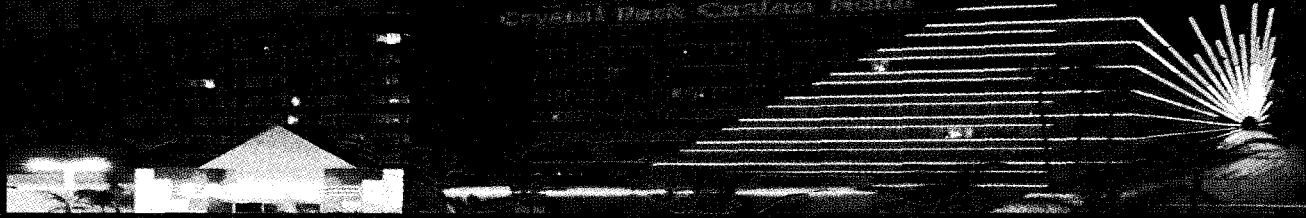

Please accept this letter as further clarification to my request for approval of a Crystal Park Table Jackpot.

## Summary of Jackpot Proposal:

Crystal Park Casino Hotel (CPCH) proposes to add a progressive jackpot element ("Crystal Park Table Jackpot") to Poker games in which a prize is awarded to players who are participating in a game where a player with the second best possible hand is beaten by a player who obtains the best possible hand. Prizes are paid from a prize pool ("Jackpot Fund") funded by a fee paid by participating players. Players can qualify for the full prize without paying a fee, or other consideration, by participating in free instructional games where there is no live wagering, no jackpot collection and no table fees ("No Purchase Necessary").

## Funding:

The Jackpot prizes will be funded by a separate collection fee paid by players prior to the start of each hand ("Jackpot Collection"). Depending on the stakes of the game, Jackpot Collections range from \$0.50 to \$2.00 per table hand. Jackpot Collections are not calculated based on a percentage of the amount wagered and are not removed from the "pot" or the amount wagered. CPCH will provide the initial seeding of the Jackpot Fund and may from time-to-time provide additional infusions of money to add to the size of the pool and the excitement of the game.

**Jackpot Collection Procedure:**

Prior to the start of each hand, players will contribute a set amount for the jackpot collection. Jackpot fees from each game will be deposited at the table into a collection box, which is separate and apart from the box used for collecting table fees. The jackpot collection will be collected, counted and recorded separately on a Jackpot prize pool collection report, which will be maintained by our Accounting Department. The same accounting principals and safeguards as CPCH utilizes in the collection, counting and recording of its table fees will be utilized when dealing with jackpot collections. All jackpot funds will be maintained in a secure and separate account.

In No Purchase Necessary games, no table fee or Jackpot Collection will be posted.

**Distribution of Prizes:**

All of the money posted by players to the Jackpot Fund, minus a flat administrative fee, will be placed in the prize pool and distributed as prizes to participating players. CPCH will post the amount of the prize that participants in each game are eligible to win on a sign in the Poker section. CPCH will control the allocation of Jackpot prizes. When a player obtains a Jackpot hand, the player with the bad beat qualifying hand will receive fifty percent (50%) of the posted amount. The player who beats the bad beat qualifying hand will receive twenty five percent (25%) of the posted amount. The remaining twenty five percent (25%) is distributed evenly to the other players at the winning table. This percentage distribution may change if market conditions warrant. The amount of the each paid Jackpot Prize will then immediately be subtracted from the Jackpot Fund.

**Flat Administrative Fee:**

CPCH will retain a flat administrative fee from the Jackpot Fund based on the number of table hours that Crystal Park Table Jackpot is offered ("Administrative Fee"). The Administrative Fee will not fluctuate based on the amount of money placed into the Jackpot Fund. CPCH reserves the right to adjust its flat Administrative Fee based on market factors and costs of operating Crystal Park Table Jackpot. CPCH projects that its Administrative Fee will be in the range of \$2.00 to \$6.00 per table hour. CPCH will designate the flat Administrative Fee and will provide advance notice of its flat fee to all customers in its rulebook/ brochures in accordance with Regulations adopted by the California Gambling Commission and/ or the California Division of Gambling Control Regulations.

**No Purchase Necessary Procedures:**

Crystal Park Table Jackpot will be offered for free to all persons who wish to participate in a No Purchase Necessary. CPCH will provide free instructional tables for all patrons who wish to participate in a Crystal Park Table Jackpot without paying a table fee or a Jackpot Collection. There will not be live wagers at these tables. Participants in No Purchase Necessary free instructional tables will be eligible to win the full-posted Jackpot prize if they participate in a game where a player obtains the designated Jackpot Hand.

**Accounting Procedures:**

The Jackpot Collection from all poker games will be collected, counted, secured and recorded in the same manner as the table fees paid to CPCH. The dealer will collect this fee (in the form of chips only) from the designated player prior to the start of each hand and deposit the fee in locked Jackpot Collection box at the table. The Jackpot Collection box will be different from the box used for table fees. The locked Jackpot Collection boxes will be gathered by casino security staff at designated times and transported to the secure casino count room. In the count room, the Jackpot Collection boxes will be unlocked and the contents counted subject to minimum internal control standards similar to those used by CPCH in collecting its table fees and in other United States gaming jurisdictions. In addition, all count team activity will always be under constant observation of video cameras. The total dollar volume of the chips taken from each Jackpot Collection box shall be recorded on a Daily Jackpot Collection Report ("Jackpot Collection Report") that will be maintained as an accounting record and shall be available for audit and inspection. The Jackpot Collection Report will document the amount of Jackpot Collections received at each participating gaming table during each shift.



Crystal Park Hotel Casino (CPHC) proposes to add a progressive jackpot element to the game of Pai-Gow Poker. Similar to the poker Jackpot games, players will be assessed a fixed fee, per hand and will qualify for a prize when a designated second hand is beaten by a designated first hand. Prizes are paid from a prize pool ("Jackpot Fund") funded by a fee paid by participating players. Players may qualify for the full Pai-Gow Poker Jackpot prize without paying a fee, or other consideration, by participating in free instructional games where there is no live wagering, no Jackpot Collection and no table fees ("No Purchase Necessary").

The rules and standards of play for the Pai-Gow Poker Jackpots are the same as in Caribbean Stud Poker Jackpot Game. The number of cards in the deck, the type of deck, the function of the dealer, the number of players, rotation of the player-dealer position, collection of table fees, betting limits and how winners are determined and paid will all be consistent with the approved version of Caribbean Stud Poker.

Since the jackpot element will be added to an existing game, the only change to the equipment will be in the addition of a separate collection box, which will be secured to the table and will be designated for the Jackpot Collection and used only for the collection of the jackpot funds. This will insure that Jackpot Collections are kept separate and apart from the table fee collection.

A prize ("Jackpot Prize") will be awarded when one player at a game obtains a specified second hand but loses to a player who obtains a better specified first hand ("Qualifying Hand"). #### **Rules of Play**

The Poker Jackpot gaming activity features a progressive jackpot prize. A prize is awarded to players participating in any designated poker game, as stated above, when a designated second hand is beaten by a better qualifying hand at the showdown. When the winning and losing hands are confirmed, those players with the qualifying jackpot hands shall receive the posted percentage of the progressive jackpot prize payout structure. Additionally, a posted percentage of the jackpot prize, known as the table share, shall be evenly distributed amongst all the other players at the qualifying table who have participated in the designated game, as shown below.

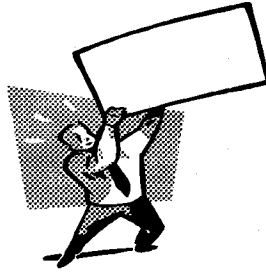

- If there is a bounty(s) offered for the tournament; when "player x" knocks out the "advertised bounty" player(s) by ending their play in the tournament, then "player x" will be awarded their bounty.
- The bounty(s) will be paid to "player x" during the tournament or as soon as their tournament play ends; casino will determine.
- The bounty amount will range from \$0.00 to \$10,000.00.
- If a bounty or bounties are advertised then this prize amount will be deducted from the total number of buy-ins, rebuy(s) and add-on(s) or the casino will pay this prize amount.

POINTS SYSTEM

- During a large tournament (i.e. month long), several tournaments may offer a predetermined amount of points that will entitle a player to a prize and/or entry into a grand finale tournament.

EXAMPLE: There are twenty-four (24) tournament events held during a month long tournament at the Crystal. Ten (10) of the tournaments will be pre-designated as points tournaments where the players who finish in the top 25 will be awarded a predetermined number of points (depending on which place they finish in) that will accumulate during the month. At the end of the point qualification, the top points winner could win a car or the top nine (9) winners will be granted a free entry into the \$10,000 main event.

- A point system could also be used where live poker play is tracked via an awards card. We realize this is a separate gaming activity and would submit an application to the Bureau before offering the point system in live play.

#### DISCOUNT FOR SELECTED ENTRANTS

- At times, the Casino may offer a discount (in percentage form) to certain groups or classifications in recognition of their job duties, public services, etc. The discount will be from the total amount of the buy-in and/or entry fee.
- These discounts will be clearly displayed on all advertisements and in-house advertisement throughout the Casino.
- No one will be discriminated based on gender, race, creed, religion, etc.
- As an example, a 10% discount will be given to any Casino employee who shows proof of such employment.

### **6. Tournament Structure:**

#### METHOD OF ENTRY

- A patron may enter a tournament by paying a buy-in and entry fee.
- Gain entry via points earned during tournament play or live poker play via a pre-approved gaming activity.
- Partial or full entry may also be gained via approved promotion(s). All promotions will be approved, by the Bureau, before they are offered for play.
- Patrons may gain entry by winning designated tournaments.
- More than one method of entry for a specific tournament will be allowed.

#### BUY-IN

- The buy-in amount will range from \$0.00 to \$10,000.00.

#### RE-BUY/ADD-ON

- The re-buy amount will range from \$0.00 to \$10,000.00. Re-buys will range from 0 to 25.
- The add-on amount will range from \$0.00 to \$10,000.00. Add-ons will range from 0 to 25.

### **7. Prize amounts; source of funds:**

The prize amounts will be calculated from the total number of the buy-ins, rebuy(s) and add-on(s). If a guarantee is advertised and the total number of the buy-ins, rebuy(s), and add-on(s) do not meet the guarantee, then the casino will make up the difference. Special tournaments may have the prizes fully funded by the house.

**8. Prize Structure:**

The prize pool will be awarded via a flat amount or percentage. Whether a flat amount or percentage, the casino will clearly and prominently display such method prior to offering the tournament.

Additional Prizes: The prize may be a fixed cash amount, merchandise, jewelry, trips, tournament entries, extra tournament chips, and vehicles.

The pay out table is attached.

**9. Amount of any administrative or other type of fee retained by the house for operating the Tournament or Special Event:**

The entry fee will range from \$0 - \$2,000. The entry fee will be income for the casino and/or to pay expenses and tips for the dealers and staff.

The service charge will range from \$0 - \$500.00. The service charge is used exclusively to pay the tournament staff for tips, etc. This is not income for the Casino.

# Shuffle Master Classic Qualifier Promotion

## **Bureau Requirements**

### **Advertising**

The Crystal Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEGA-004546) must be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for this gaming activity, including but not limited to the following, shall be prominently displayed in the Crystal Casino at all times that the gaming activity is being offered for play:

- Eligible games, dates, and time periods.
- Procedures and requirements for participating in the qualifying games.
- Qualifying Hands.
- Prize Amount(s).
- No Purchase Necessary opportunity.
- Any other restrictions that apply to this gaming activity.

### **Eligible Controlled Games**

The Shuffle Master Classic Qualifier Promotion shall be attached to the following Bureau approved controlled games offered at the Crystal Casino, as shown below, at all times that this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

- Three Card Poker (GEGA-000054)
- Three Card Poker Six Card Bonus (GEGA-003893)
- Ultimate Texas Hold'em (GEGA-003558)

### **Object and Summary**

The Shuffle Master Classic Qualifier Promotion features a fixed promotional prize attached to the pre-determined and designated controlled games, as listed above. A player will be awarded entry into the Shuffle Master Classic tournament event when a player in an eligible game obtains a designated qualifying hand, as described below.

### **Qualifying Hands**

Players that make one of the following advertised hands shall win entry into the Shuffle Master Classic tournament event in Las Vegas. The qualifying hands within the chart below shall be offered together at all times this gaming activity is being offered for play. Patrons shall be provided with ample advance notice of which qualifying hands are being offered for play, as well as the requirement for the qualifying hand. Furthermore, the qualifying hands shall be displayed prominently within the Crystal Casino at all times the Shuffle Master Classic Qualifier Promotion is being offered. When a qualifying hand is announced, a casino employee shall verify that the hand qualifies for the promotion.

## **Shuffle Master Classic Qualifier Promotion**

### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games, during the pre-determined and specified times designated and posted for the gaming activity.

- A minimum of two players (for California games) must be dealt into the game in order for the table to qualify for the gaming activity.
- All players who qualify for the Shuffle Master Classic in Las Vegas are subject to review and verification.
- Players cannot transfer their entry to the Shuffle Master Classic in Las Vegas to another person.
- Players must claim the prize within 24 hours of receiving the qualifying hand. Prizes unclaimed by players shall not be awarded to other participants.
- Tournament game tables are not eligible for this gaming activity.
- Employees of the Casino, Shuffle Master, and any of their subsidiaries, affiliates or parent companies and immediate family members of employees and the employees of the advertising agency affiliated with this promotion are not eligible to participate in the Promotion. Immediate family members are defined as spouse, child or anyone sharing the same residence as the applicable employee.
- A Third Party Provider of Proposition Player is not eligible to participate in this gaming activity.

### **Prize**

The Shuffle Master Classic Qualifier Promotion features a fixed prize element. A player that makes one of the pre-determined and posted qualifying hands (as shown above) shall be awarded a prize and entry into the Shuffle Master Classic tournament event in Las Vegas. The value of the prize won is \$1,000. Prizes shall be in the form of a \$1,000 travel voucher to cover airfare to and from Las Vegas from the continental United States and a two night hotel stay in Las Vegas, NV. Any airfare and hotel expenditures above \$1,000 will be the responsibility of the player. The player shall not receive the remaining balance of the \$1,000 travel voucher if the player spends less than \$1,000 on the airfare and hotel accommodations. Players are responsible for payment of all food, beverages, taxes, and gratuities in connection with travel and stay in Las Vegas. Qualifiers are responsible for transportation expenses during their stay in Las Vegas and are responsible for any accommodation expenses at the hotel in excess of two nights. In the event the Shuffle Master Classic is cancelled for any reason, the player will receive the \$1,000 travel voucher in full satisfaction and no additional compensation will be paid in lieu of the Shuffle Master Classic cancellation.

### **Funding**

The Shuffle Master Classic Qualifier Promotion is fully funded by the Casino. Therefore, there shall be no additional jackpot fees or collection fees taken for this promotion.

### **Administrative Fees**

The Casino shall not retain an administrative fee as this promotion is house funded.

### **No Purchase Necessary**

Any person that wishes to participate in this gaming activity on a No Purchase Necessary (NPN) basis may do so by requesting such from a casino floor person or customer service representative. Within a reasonable amount of time, a gaming table shall be made available that includes a casino dealer. The dealer will deal a simulated game with the NPN participant

receiving one hand and the dealer playing the other hands to simulate a full game thus offering the NPN participant the optimum opportunity to receive a qualifying hand. There shall be no time constraints or any restrictions placed on the NPN participant. There shall be no live wagers or fees of any kind collected at the NPN table.



# **SUPER 9 JACKPOTS**

## **Summary of Game**

Crystal Park Casino ("Casino") proposes to add a progressive jackpot element to Super 9. Similar to the existing Jackpot games attached to Poker, Blackjack, Pai Gow Poker and Caribbean Stud, players will be assessed a fixed fee, per hand, and will qualify for prizes when a designated hand is beaten. Prizes are paid from a prize pool ("California Games Jackpot Fund") funded by the fee paid by participating players. As discussed in more detail below, one hundred (100%) percent of the money received in Jackpot collections are either paid out in the form of prizes to customers or retained as an Administrative Fee by the Casino.

Players may qualify for the full Super 9 Jackpot prizes without paying a fee, or other consideration, by participating in free instructional games where there is no live wagering, no Jackpot Collection and no table fees ("No Purchase Necessary").

## **The Prize**

Super 9 Jackpots three levels of prizes to participating players: (1) Bad Beat Jackpot Prize and (2) Super Jackpot Prize and (3) Royal Jackpot Prize. A prize is awarded when one player in a game obtains a specified hand but loses to a player with a better specified hand ("Qualifying Hands"). The Bad Beat Jackpot Prize and the Super Jackpot Prize are progressive. The amount of the Bad Beat Jackpot Prize and Super Jackpot Prize will vary depending on the volume of play and frequency with which players obtain a Qualifying Hand. The Royal Jackpot Prizes are fixed amounts.

Casino will control the allocation of the Jackpot Collection to Jackpot Prizes in the various games. The Jackpot Prizes will be posted on either an electronic board or poster centrally located in the California Games section of the Casino. The posting will be updated as the prize is increased or decreased so that all players will have ample notice of the current Jackpot Prize. Initial seeding of the Bad Beat Jackpot Prize will be a minimum of \$1,000.00; Super Jackpot Prize will be a minimum of \$3,000.00; and Royal Jackpot Prize will be a minimum of \$5,000.00. All Jackpots will be reseeded to at least the minimum immediately after a Jackpot Prize is paid to a winning player. The Bad Beat Jackpot Prize and the Super Jackpot Prize will be increased two (2) times per day. Casino will provide ample notice to patrons of the time and amount that the Jackpot seed will be increased. The Royal Jackpot is not progressive and will not be increased. Casino may provide multiples (i.e., 2x or 3x, etc.) of the Bad Beat, Super and Royal Jackpot Prizes during designated posted hours.

When players obtain the specified hand combination and claim the Jackpot Prize, the Qualifying Hands will be verified by the dealer and a floorperson. Surveillance cameras will be utilized to assure all employees and customers followed the required procedures.

The winning player's identification will be obtained and necessary paper work completed prior to the payout of the Jackpot Prizes. Casino will record all prizes awarded and the names of the winners as part of its California Games Jackpot accounting records.

After a winning hand is confirmed, the player who lost with the designated hand will receive sixty (60%) percent of the posted Jackpot Prize for that game, the player with the designated better hand will receive twenty (20%) percent of the posted Jackpot Prize and the remaining twenty (20%) percent of the posted Jackpot Prize will be evenly distributed among all other players at the table who have made a wager and paid a table fee collection for that particular hand.

Only one Jackpot Prize will be paid per round of play. In the unlikely event that more than two players achieve a Qualifying Hand in the same round of play, only the two highest ranking hands qualify. The remaining players at the table will share the twenty percent (20%) portion. Casino reserves the right to inspect all Qualifying Hands and to refuse payment of a jackpot prize in the event that it is determined that proper procedures were not followed.

## **Funding**

California Games Jackpot Prizes will be funded by a separate collection fee paid by players prior to the start of each hand ("Jackpot Collection"). Initially, the Jackpot Collection will be \$1.00 per hand. Casino reserves the right to raise the Jackpot Collection in designated tables to \$2.00 or \$3.00 per hand after giving ample notice to both patrons and the California Division of Gambling Control. At all times, the amount of the Jackpot Collection will be conspicuously posted within view of each participating table.

Jackpot Collections are determined and collected prior to the start of each hand. Jackpot Collections are not calculated based on a percentage of the amount wagered. Casino will provide the initial seeding of the California Games Jackpot Fund and may from time-to-time provide additional infusions of money to add to the size of the pool and the excitement of the game.

The full Jackpot Collection will be posted by the player in the first Player-Dealer position. When there is more than one player participating in the first Player-Dealer position, the player who has the most money in action in the first Player-Dealer position will be responsible for posting the full Jackpot Collection.

## **Jackpot Collection & Accounting Procedures**

The Jackpot Collection from all California Games will be collected, counted, secured and recorded in the same manner as the table fees paid to Casino. The dealer will collect this

fee (in the form of chips) prior to the start of each hand and deposit the fee in a locked Jackpot Collection Box at the table. The Jackpot Collection Box will be different from the box used for table fees. The locked Jackpot Collection Boxes will be gathered by casino security staff at designated times and transported to the secure Casino count room. In the count room, the Jackpot Collection Boxes will be unlocked and the contents counted subject to minimum internal control standards similar to those used by Casino in collecting its table fees and in other United States gaming jurisdictions. In addition, all count team activity is under constant observation of video cameras. The total dollar volume of the chips taken from each Jackpot Collection Box will be recorded on a Daily Jackpot Collection Report (AJackpot Collection Report@) that will be maintained as an accounting record and shall be available to the Division of Gambling Control and the City of Compton for audit and inspection. The Jackpot Collection Report will document the amount of Jackpot Collections received at each participating California Games gaming table during each shift.

### **No Purchase Necessary Procedures**

California Games Jackpots will be offered for free and general and indiscriminate basis, to patrons who wish to participate in a No Purchase Necessary game. Casino will provide instructional tables for all patrons who request to participate in California Games Jackpot Games without paying a table fee or a Jackpot Collection. There will not be live wagers at these tables. No purchase necessary tables will follow the ALive Game@ rules regarding rotation of the player-dealer position. Participants in No Purchase Necessary instructional tables will be eligible to win the full posted Jackpot Prize if they participate in a game where a player obtains the designated Jackpot Hand.

In the event that only one-player requests to participate at an instructional table, Casino will do everything possible to make a no purchase necessary table available to patrons within fifteen minutes of a request. Casino will attempt to locate other customers that desire to participate. If no other patrons are available to participate in a no purchase necessary table, Casino will provide a table where the no purchase necessary player will play only one hand and the house dealer will play the remaining hands according to House Way.

A person(s) that comes to play the jackpot at the "no purchase necessary" table will be dealt the maximum of eight hands. The no purchase necessary player will play only one hand and the casino dealer will play the remaining.

If the player wins the jackpot, only the portion of money that his/her hand qualifies for will be paid. The remainder will remain in the jackpot fund.

### **Third Party Providers of Proposition Player Services**

Third Party Providers of Proposition Player Services, as defined by Section 19980 of the California Business and Professions Code, their agents and employees ("TPPPPS"), are not eligible to win any portion of the Jackpot Prize. If a TPPPPS receives a Qualifying Hand, its portion of the Jackpot Prize will not be paid and will remain in the California Games Jackpot Fund. If a TPPPPS is a participant in a Qualifying Hand with another player(s), the TPPPPS will not be eligible to receive its portion of the Jackpot Prize and the full Jackpot Prize will be paid to the other players.

### **Flat Administrative Fee**

Casino will retain a flat administrative fee from the California Games Jackpot Fund based on the number of table hours that California Games Jackpot Games are offered ("Administrative Fee"). The Administrative Fee will not fluctuate based on the amount of money placed into the California Games Jackpot Fund. Casino projects that its Administrative Fee will be \$5.00 per table hour. Casino will provide advance ample notice of its flat fee to all customers in accordance with Regulations adopted by the California Gambling Control Commission and/or the California Division of Gambling Control Regulations.

### **Eligibility for the Jackpot Prizes**

All players in participating games (other than TPPPPS) that obtain a Qualifying Hand who and who have made a wager in the first player-dealer position or who have made a wager and paid the table fee in any non-player-dealer betting circle, regardless of the amount wagered, are eligible to win either the Bad Beat or Super Jackpot Prize.

Patrons participating in the second or higher Player-Dealer position are not eligible to win the Jackpot Prize. If there is more than one player with a wager in the first player-dealer position, the Jackpot Prize will be divided pro-rata, based on size of wagers, between the players.

All players in the player position, with the exception of TPPPPS, who have made a wager and have paid the table fee for any betting circle, regardless the amount wagered, are eligible to win the Jackpot. Eligible players in the player position will share the Jackpot Prize in equal shares regardless of the amount of their wagers.

### **No Free Play**

Casino will not reduce, waive, refund or provide a free collection ("Courtesy Button") token to any patron in either the base game or the jackpot element of any game included in this proposal.

After the winning hands in a Bad Beat Jackpot are confirmed, the player who lost with the designated second hand will receive sixty (60%) percent of the posted Jackpot Prize for that game, the player with the designated first hand will receive twenty (20%) percent of the posted Jackpot Prize and the remaining twenty (20%) percent of the posted Jackpot Prize will be evenly distributed among all other players at the table who have made a wager and paid a table fee collection for that particular hand

► **Super Jackpot:** A hand that contains 6-6-6 of the same color (first hand) loses to 2-3-4 of the same color (second hand).

### **Super Jackpot Variations:**

- A hand that contains 6-6-6 of the same color (first hand) loses to 3-3-3 of the same color (second hand).
- A hand that contains K-K-K-K (first hand) loses to 5-5-5-5, and one of the hands contains the cards of the same color (second hand).
- A hand that contains Q-Q-Q-Q (first hand) loses to 5-5-5-5, and one of the hands contains the cards of the same color (second hand).
- A hand that contains J-J-J-J (first hand) loses to 5-5-5-5, and one of the hands contains the cards of the same color (second hand).

- A hand that contains K-K-K-K, Q-Q-Q-Q or J-J-J-J (first hand) loses to 5-5-5-5, and one of the hands contains the cards of the same color (second hand).

After the winning hands in a Super Jackpot are confirmed, the player who lost with the designated second hand will receive sixty (60%) percent of the posted Jackpot Prize for that game, the player with the designated first hand will receive twenty (20%) percent of the posted Jackpot Prize and the remaining twenty (20%) percent of the posted Jackpot Prize will be evenly distributed among all other players at the table who have made a wager and paid a table fee collection for that particular hand.

► **Royal Jackpot:** A hand that contains 6-6-6 of the same suit loses to 2-3-4 of the same suit.

**Royal Jackpot Variations:**

- A hand that contains 6-6-6 of the same suit (first hand) loses to 3-3-3 of the same suit (second hand).
- A hand that contains K-K-K-K (first hand) loses to 5-5-5-5, and one of the hands contains the cards of the same suit (second hand).
- A hand that contains Q-Q-Q-Q (first hand) loses to 5-5-5-5, and one of the hands contains the cards of the same suit (second hand).
- A hand that contains J-J-J-J (first hand) loses to 5-5-5-5, and one of the hands contains the cards of the same suit (second hand).
- A hand that contains K-K-K-K, Q-Q-Q-Q or J-J-J-J of the same color (first hand) loses to 5-5-5-5 of the same suit (second hand).
- A hand that contains K-K-K-K of the same suit (first hand) loses to 5-5-5-5 of the same suit (second hand).

After the winning hands in a Royal Jackpot are confirmed, the player who lost with the designated hand will receive twenty (20%) percent of the posted Jackpot Prize

for that game, the player with the designated best hand will receive sixty (60%) percent of the posted Jackpot Prize and the remaining twenty (20%) percent of the posted Jackpot Prize will be evenly distributed among all other players at the table who have made a wager and paid a table fee collection for that particular hand.

## **Progressive Jackpot for Three Card Poker**

### **SUMMARY OF THE GAME**

Based on customer demand and industry trends, The Crystal Casino & Hotel (CC) proposes to add player funded progressive jackpot specifically for the approved game of Three Card Poker. The player who wishes to participate will be a fixed amount that will be dropped in the casino's jackpot drop box which will be attached to the table and accounted for separately from the casino collection drop box.

### **THE PRIZE**

When a player(s) is dealt a Royal Flush or Straight Flush, the hand will be verified in the same manner that the currently approved jackpots are verified by casino personnel. This includes physical verification by the CC dealer, floorperson, and/or supervisor. Surveillance cameras will be utilized to ensure all employees and customers have followed the required rules and procedures. The winning player's identification will be obtained and all required paperwork will be completed prior to the payout of the Progressive Jackpot Prize. CC will record all winnings as part of the jackpot accounting records.

The prize pool will be initially at \$1,000.00 by the CC and will be increased by a minimum of \$50.00 per day. When a winning hand is confirmed, the progressive amount of money displayed at the table will be paid to the winner(s) and the Jackpot Fund will be immediately reseeded at \$1,000.00. At certain times CC may offer a higher amount than the posted Jackpot Prize (2x, 3x, etc.) to increase excitement and to offer the players a chance of winning more money.

When a player receives a Straight Flush, they will be awarded \$100.00. At certain times CC may offer a higher amount than the posted Jackpot Prize (2x, 3x, etc.) to increase excitement and to offer the players a chance of winning more money.

CC reserves the right to inspect all purported Qualifying Hands and to refuse payment of a Progressive Jackpot Prize in the event that it is determined that proper rules and procedures were not followed and/or cheating occurred. The CC will maintain records, including video surveillance, of all instances where a Progressive Jackpot Prize was not paid, for the purposes of future Division and/or law enforcement review.



## **FUNDING**

The Progressive Jackpot Prize will be funded by a jackpot collection fee that will be collected from each player that wishes to participate in the Progressive Jackpot Prize. The Progressive Jackpot Prize collection fee is a fixed fee of \$.25\*. The Progressive Jackpot Prize collection fee is in no way based on a percentage of the amount wagered in a game. The Jackpot Collection is determined and posted prior to the start of each designated game. The amount of the collection is clearly displayed on each table where the Progressive Jackpot Prize element is offered as well as listed in brochures and flyers.

The CC will provide initial seeding of the Progressive Jackpot Prize and may from time to time provide additional infusions of money to add to the size of the as well as to the excitement of the game. After the Progressive Jackpot fund has reached a reserve amount of \$3,000.00, CC may be refunded the initial seed amount.

## **NO PURCHASE NECESSARY PROCEDURES**

The Progressive Jackpot Prize will be offered to customers who wish to participate for free, on a general and indiscriminate basis. CC will offer a demonstration table for all customers requesting to participate for the Progressive Jackpot Prize without requiring them to pay a table fee, Jackpot Collection or any type of consideration. There will be no live wagers at these tables. Participants in the no purchase necessary tables will be eligible to win the Progressive Jackpot Prize if they receive a Royal Flush or Straight Flush.

As in other jackpot games, in the event that only one patron requests to participate at a demonstration table for no purchase necessary, the CC dealer at the demonstration table will deal additional hands to all empty seat positions at the table to simulate a full game, thus providing the patron the optimum chance to receive a Royal Flush or Straight Flush. The dealer will monitor and play all hands dealt to the empty seat positions and play them according to the published house rules. Advertisements and rule sheets will advise all patrons that there is a general and indiscriminate opportunity to participate in a no purchase necessary game.

## **ADMINISTRATIVE FEE**

CC will retain an administrative fee from the Progressive Jackpot Fund based on the number of table hours played on the Three Card Poker game(s). This fee will be predetermined, fixed and accounted for separately from other casino collections. The fee is not based on the amount of money in the Jackpot Fund. The fee will take into consideration market conditions and the administrative cost of operating and administering the Jackpot Fund. CC has

currently determined the administrative fee will be \$8.00 per table hour for the Progressive Jackpot.

### **ELIGIBILITY FOR THE JACKPOT PRIZE**

All players participating at a designated Three Card Poker game table who place a wager and pay a collection fee and the Progressive Jackpot collection fee are eligible for the Progressive Jackpot Prize. All persons seeking to participate in the Progressive Jackpot on a no purchase necessary basis are eligible to do so, without placing a wager, paying a collection fee or other consideration, on a general and indiscriminate basis.

### **ALTERNATE COLLECTION RATE**

In lieu of the \$.25 collection rate from participating player(s), CC reserves the right to change the collection rate to either \$.50 or \$1.00. Prior to implementing such a change in rates, CC will first notify the Division of Gambling Control and give ample notification to customers prior to any change.

### **GOLOSSARY**

**Administrative Fee:** As described above, the Administrative Fee is retained by the CC from the Jackpot Fund based on the number of table hours that the Progressive Jackpot Prize promotion is offered. All records of the administrative fee will be recorded on the CC Jackpot records.

**Jackpot Collection:** The amount of money predetermined by CC, and previously approved by the Division, which is paid by a player wishing to participate in the promotion.

**Jackpot Fund:** A prize pool funded by the poker players who participate in a Three Card Poker game with a jackpot element attached.

**Jackpot Prize:** The Jackpot Prize for the Royal Flush is a progressive amount of cash a player obtains after they receive a Royal Flush. The Jackpot Prize will be posted in the Three Card Poker section of the CC, as well as in flyers and the electronic display board throughout the casino.

The Jackpot Prize for the Straight Flush is \$100.00. The Jackpot Prize will be posted in the Three Card Poker section of the CC, as well as in flyers and the electronic display board throughout the casino.

**No Purchase Necessary:** As described above, No Purchase Necessary procedures are available to any customer on a general and indiscriminate basis.

Please note that the Bureau is making the details of this game available to the public as required by subdivision (g) of Business and Professions Code section 19826, but the posting does not waive any rights to the game content which may be held by Owner. The terms of any agreement with Owner are to be negotiated between the gambling establishment and Owner, and any dispute or asserted breach related thereto are private matters which will not be resolved by the Bureau.

### **Advertising Requirements**

The Crystal Casino may advertise various names for this gaming activity. Should The Crystal Casino advertise a different name, the BGC ID for this gaming activity shall be referenced on all advertisements relating to the Three Card Poker Progressive gaming activity.

Furthermore, all rules and procedures for this gaming activity, including but not limited to the following, shall be displayed conspicuously and prominently in The Crystal Casino at all times:

- Eligible games and time periods.
- Qualifying hands and corresponding prize amounts.
- Gaming activity collection fees.
- Availability of No Purchase Necessary.
- Any other restrictions that apply to this gaming activity.

### **Rules of Play**

1. Three Card Poker Progressive gaming activity shall be attached to all limits and versions of the currently approved games offered at The Crystal Casino, as listed below.

- Three Card Poker

All base game rules shall be played as previously approved by the Bureau.

2. Three Card Poker progressive considers the best hand possible among each individual player's cards.
3. To begin each round, players must make their regular base game wager. They may optionally place any bonus bet wagers along with the jackpot fee of \$1.00. A minimum of two players are required to play for the progressive jackpot.
4. "Hockey Puck" discs will be attached to the table in front of each betting position. These discs have a sensor and will detect when a casino chip is placed on them. Players must place the optional jackpot fee on the sensor. The sensor will then light up.
5. Once all players place their bets and/or jackpot fee, the house dealer will press "Coin In" on the keypad. The sensors will then light up, indicating participation in the progressive jackpot. The house dealer will then remove all jackpot fees from the table. The jackpot fees are dropped in a separate and locked jackpot collection box affixed to the left side of the gaming table.
6. The house dealer then follows standard approved procedures for dealing the base game.



7. Progressive Winners:

- a. The AKQ (any suit) is paid from the progressive jackpot shown on the progressive meter.
- b. All other hands are paid from the reserve fund. They do not get deducted from the amount shown on the meter.
- c. In the event more than one progressive meter pay or any other qualifying hand hits during the same round, all winning players will be paid the posted progressive prize or the posted fixed amount. - Qualifying hands and corresponding prize amounts
- Jackpot fee amount and breakdown
- Administrative fees
- Availability of No Purchase Necessary
- Any other restrictions that apply to this gaming activity

### **Eligible Controlled Games**

The Ultimate Texas Hold'em Progressive Jackpot will be attached to the following Bureau approved controlled games offered at Crystal Casino, as shown below, at all times this gaming activity is being offered for play. All controlled game rules will be played as previously approved by the Bureau.

### **Object and Summary**

Players may place an optional \$1 jackpot fee for a chance to win the Ultimate Texas Hold'em Progressive Jackpot. The Ultimate Texas Hold'em Progressive Jackpot considers the best advertised qualifying hand(s) among each individual player's cards. In addition, when a player places the optional \$1 jackpot fee, the player is eligible to win an Envy payout.

1. To begin each round, players must make their regular base game wager. They may optionally place any bonus bets along with the jackpot fee of \$1. A minimum of two players, a player and a player-dealer, are required to play to qualify for the progressive jackpot.
2. "Hockey Puck" discs will be attached to the table in front of each betting position. These discs have a sensor and will detect when a casino chip is placed on them. Players must place the optional jackpot fee on the sensor. The sensor will then light up.
3. Once all players place their bets and/or optional jackpot fee, the house dealer will press "Game Start" on the keypad. ## Eligibility Requirements

This gaming activity will be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours posted for the gaming activity.

- A minimum of two players, a player and a player-dealer, are required for this gaming activity.
- Only seated players, who have paid the optional jackpot collection fee and dealt a designated hand, are eligible for the progressive prize.
- There is no limit on the number of times a player may win the progressive prize or a fixed prize.
- A player may place a base game wager as well as the optional jackpot fee on any unoccupied seat, as well as their own, and become eligible for multiple payouts.
- Casino employees are eligible for the jackpot prize when off-duty and out of uniform only.

- When a player has a progressive winner, the house dealer will press the appropriate hand button on the keypad.
- The house dealer will then contact the casino representative.
- Once the Casino verifies the progressive win, the casino representative will press "Confirm", then swipe the authorization card. This records the win onto the Game Manager. House procedures are then followed for paying the prize.

- Eligible games and time periods
- Qualifying hands and corresponding prize amounts
- Administrative fees
- No Purchase Necessary Information
- Any other restrictions that apply to this gaming activity

### **Eligible Controlled Games**

The Three Card Poker Progressive shall be attached to the following Bureau approved controlled games offered at Crystal Casino, as shown below, at all times that this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

- Three Card Poker 6 Card Bonus (GEGR-002209)

### **Object and Summary**

The Three Card Poker Progressive considers the best possible hand among each individual player's first three cards dealt. The player-dealer's hand is not used in any way to make or aid in the qualifying hand.

- To begin each round, players must make their regular base game wager. They may place any bonus bets along with the optional jackpot fee of \$1.
- A "Hockey Puck" disc will be attached to the table in front of each betting position. These discs have a sensor and will detect when a casino chip is placed on them. Players must place the optional jackpot fee on the sensor.
- Once all players place their bets and/or jackpot fee, the house dealer will press "Check Bets" on the Table Control. The sensors will then light up, indicating participation in the progressive jackpot. The house dealer will then remove all jackpot fees from the table. The jackpot fees are dropped in a separate and locked jackpot collection box affixed to the left side of the gaming table.
- The house dealer then follows standard approved procedures for dealing the base game. A player can qualify for the jackpot element of the game regardless of the outcome of the base game.
- When a player has achieved a winning hand, a casino representative will be responsible for verifying the winning hand. If the winning hand wins a percentage-based progressive meter, the casino representative will press the appropriate buttons on the Table Control to log the win. If the winning hand wins a fixed progressive payout the casino representative will pay the winner in live casino chips after the proper paperwork has been filled out. The payouts will not be made from the house dealer's tray.

## Three Card Poker Progressive

### Qualifying Hands

- Only active players, who have placed an Ante wager, a jackpot fee, and are dealt a designated hand are eligible for the jackpot.
- There is no restriction on the number of times a player can win a fixed or progressive prize during any promotional period.
- Backline bettors are not eligible to place a jackpot collection fee or receive a prize.
- Casino employees are eligible for the Three Card Poker Progressive prize only when off duty and out of uniform.
- Player's may place a base game wager as well as the optional jackpot fee on any unoccupied seat, as well as their own, and become eligible for multiple payouts.
- Tournament games are not eligible for this promotion.
- The player-dealer position is not eligible for this promotion.

- \$0.35 will be immediately posted on the meter.
- \$0.65 will be tracked in a reserve fund. The reserve fund will be utilized to immediately re-seed the metered progressive jackpot prize. In addition, this reserve fund will payout all fixed amounts and administrative fees.

There is no cap on the progressive prize pool. The progressive prize will increase every time a jackpot fee is collected and placed on the progressive prize meter. The prize pool will be re-seeded when the 100% progressive jackpot is awarded to a player(s). The reseed amount will be a minimum of \$1,000 and come from the reserve account. Crystal Casino shall retain an administrative fee of \$5 - \$20 per table per hour, which shall be taken from the reserve fund. The administrative fee shall be utilized to cover expenses incurred by Crystal Casino for administering the Three Card Poker Progressive.

### **No Purchase Necessary**

The Three Card Poker Progressive shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**. Crystal Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the Three Card Poker Progressive. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

## Three Card Poker Progressive

### Equipment

The electronic software and digital reader related to and used in conjunction with this jackpot, which is used on each table eligible for this jackpot, has been tested, approved, and certified by Masque Publishing inc.

- When a player has a progressive winner, the dealer shall press the appropriate hand button on the keypad.
- The house dealer shall then contact a casino representative.
- Once a casino representative verifies the progressive win, the casino representative shall press “Jackpot Hit” on the Table Control and then enter in the appropriate code to release the funds off the progressive meter. This records the win onto the Casino Control Computer. House procedures are then followed for paying the prize.
- When the house reconciles all action (on behalf of the player-dealer), they wait for new bets to be made for the next and then presses the “Check Bets” button on the Table Control to begin the next hand.
- Once the “Jackpot Hit” button is pressed and appropriate code is entered on the Table Control, the prize is logged into the Casino Control Computer.
- If the electronic software or digital reader malfunctions or breaks down, the jackpot will not be offered.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in Crystal Casino at all times the gaming activity is being offered for play:

- Eligible games and time periods
- Qualifying hands and corresponding prize amounts
- Administrative fees
- No Purchase Necessary Information
- Any other restrictions that apply to this gaming activity

#### **Eligible Controlled Games**

The Match the Dealer Progressive Jackpot shall be attached to the following Bureau approved controlled games offered at Crystal Casino, as shown below, at all times that this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

- Pure Spanish 21.5 (GEGA-003694)

#### **Object and Summary**

Players are betting that both of their first two cards will match the player-dealer's up card in rank. A player that achieves one of the qualifying hands listed below for the Match the Dealer Progressive Jackpot is eligible to win a fixed or progressive prize.

1. To begin each round, players must make their regular base game wager. They may optionally place any bonus bets along with the optional jackpot fee of \$1. "Hockey Puck" discs will be attached to the table in front of each betting position. These discs have a sensor and will detect when a casino chip is placed on them. Players must place the optional jackpot fee on the sensor.
2. Once all players place their bets and/or jackpot fee, the house dealer will press "Check Bets" on the Table Control. The sensors will then light up, indicating participation in the progressive jackpot. The house dealer will then remove all jackpot fees from the table. The jackpot fees shall be dropped into a separate and locked jackpot collection box and accounted for separately.

Furthermore, all rules and procedures for this promotion, including but not limited to the following, shall be prominently displayed in the Crystal Casino at all times the promotion is being offered:

- All rules and procedures for this gaming activity
- Required minimum buy-ins to participate in this promotion
- Eligible games and time periods
- Amount of Bonus Chips awarded
- Procedures to wager and redeem the Dead Chips and Bonus Chips
- Any other restrictions that apply to this gaming activity

### **Eligible Controlled Games**

The Dead Chip Promotion shall be attached to all Bureau approved California games offered at the Crystal Casino at all times that the gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

### **Object and Summary**

The Dead Chip Promotion shall be open to all patrons who buy-in to a predetermined game for a predetermined amount ranging from \$250 to \$500,000. Participants shall receive a specific amount of multi-use Dead Chips for their buy-in amount and an additional amount of single-use Bonus Chips as a prize in the amount between \$10 and \$100,000.

### **Dead Chips**

The multi-use Dead Chips are of a different style and design from the standard casino chip. Dead Chips cannot be exchanged for live casino chips or cash, but they can be deposited into a Player Bank Account for future use. Once the Dead Chips have been placed as a wager the following applies:

- If the wager wins, the player shall receive live casino chips for their wager from the player-dealer. The player retains the Dead Chips and can reuse the Dead Chips on another wager until lost.
- If the player pushes, the Dead Chips shall remain with the player until the hand loses.
- If the wager loses, the Dead Chips are given to the player-dealer. The losing Dead Chips can be redeemed with help from a casino representative. The casino representative shall exchange the Dead Chips with live casino chips or cash for the player-dealer.

- Dead Chips cannot be used to pay collections.

## **Dead Chip Promotion**

### **Bonus Chips**

The single-use Bonus Chips are of a different style and design from the standard casino chip. Bonus Chips cannot be exchanged for live casino chips or cash, but they can be deposited into a Player Bank Account for future use. Once the Bonus Chips have been placed as a wager the following applies:

- If the wager wins, the player shall receive live casino chips for their wager from the player-dealer. The used Bonus Chip is given to the player-dealer to be redeemed.
- If the player pushes, the Bonus Chips shall remain with the player until the hand loses.
- If the wager loses, the Bonus Chips are given to the player-dealer.

- Qualifying hands
- Prize payout structure
- The prize amount that will be awarded
- Availability of No Purchase Necessary
- Any other restrictions that apply to this gaming activity

#### **Eligible Controlled Games**

The Baccarat Progressive Jackpot will be attached to the following Bureau approved controlled games offered at Crystal Casino, as shown below, at all times this gaming activity is being offered for play. All controlled game rules will be played as previously approved by the Bureau.

- EZ Baccarat (GEGA-002997)
- California Baccarat (GEGR-002115)
- Dragon Dai Bacc (GEGR-002135)
- RUYI Baccarat (GEGR-002272)

#### **Object and Summary**

The Baccarat Progressive Jackpot adds an optional \$1 player funded progressive and fixed jackpot elements to the game listed above. The Baccarat Progressive Jackpot considers both the player and banker hands. To begin each round, players must make their regular base game wager. Players may optionally place any bonus bet wagers along with the jackpot fee of \$1. Once the house dealer removes all jackpot fees from the table, the jackpot fees will be dropped into a separate and locked jackpot collection box. The house dealer then follows standard approved procedures for dealing the base game. A player is NOT required to place a wager on the Dragon 7 Bonus Bet or the Panda 8 Bonus Bet in order to be eligible to place a wager on the Baccarat Progressive Jackpot. This promotion will be available at predetermined dates and times posted in the Casino. When a winning hand is confirmed, the player with the qualifying jackpot hand will receive either a posted percentage of the progressive jackpot prize or a fixed prize, depending on the winning qualifying hand. A prize is awarded to players participating in the progressive jackpot when a qualifying hand is made.

1. "Hockey Puck" discs will be attached to the table in front of each betting position. These discs have a sensor and will detect when a casino chip is placed on them. Players must place the jackpot fee on the sensor. The sensor will then light up.

2. Once all players have placed their base wagers and jackpot fees, the house dealer will press “Start Game” on the keypad. Only hands that have been Bureau approved and pre-determined and designated by the Casino are eligible. Patrons will be provided with ample advance notice of what the qualifying hands are, as well as the requirements for completing the qualifying hands. Furthermore, the qualifying hands will be displayed prominently within the Casino at all times the Baccarat Progressive Jackpot is being offered for play.

Players that make one of the advertised qualifying hands, as shown below, will be eligible to win their share of the posted prize amount, according to the payout options, as shown below. All qualifying progressive and fixed hands within a chart must be offered together at all times.

### **Progressive Hands**

Dragon 7 - Player 0 Same Color	The banker hand wins with a three-card total of 7 points and the player hand totals 0. Cards in both the banker and player hands must be the same color. <b>Example:</b> <i>All cards in the banker hand are red and all cards in the player hand are black.</i>
Dragon 7 - Player 0	The bankers hand wins with a three-card total of 7 points and the player hand totals 0.
Banker Two-Card 7 - Player 0	The banker hand wins with a two-card total of 7 points and the player hand totals 0.

### **Eligibility Requirements**

This gaming activity will be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours designated and posted for the gaming activity.

- There is no time requirement for how long a game must be played in order to be eligible for an Baccarat Progressive Jackpot payout
- There is no limit to the number of times a player may win the Baccarat Progressive Jackpot during the promotional period.
- A player must make a base game wager in order to be eligible for this jackpot.

## Baccarat Progressive Jackpot

- A minimum of two players, a player and a player-dealer, are required in order for the table to be eligible to participate in the Baccarat Progressive Jackpot.
- A player can qualify for the jackpot regardless of the outcome of the controlled game.
- Only seated players, who are dealt a designated hand, are eligible for payouts.
- Casino employees are eligible for the Baccarat Progressive Jackpot prize when they are off duty and out of uniform.

### **Prize Payout Structure**

Players that make one of the advertised qualifying hands, as shown above, will be eligible to win their share of the posted Baccarat Progressive Jackpot prize amounts, according to the payout option as shown below. Patrons will be provided with ample advance notice of the prize payout being offered for play. Furthermore, it will be displayed prominently within the Casino at all times the Baccarat Progressive Jackpot is being offered for play.

### **Funding**

The Baccarat Progressive Jackpot is a player funded progressive jackpot. The Casino will initially seed the jackpot at a minimum of \$1,000 and to a maximum of \$50,000. Once there are sufficient monies in the Baccarat Progressive Jackpot reserve fund, the initial seed will be reimbursed to the Casino from the reserve fund and will be documented in the accounting records.

After the progressive jackpot is hit, it will be re-seeded from the reserve fund at an amount between \$1,000-\$50,000. In addition this reserve fund will payout all fixed prize amounts. In the event the reserve fund is depleted, the Casino will make up any shortfall. Once there are sufficient monies in the reserve fund, the re-seed amount, up to the amount that the Casino funded, will be reimbursed to the Casino from the reserve fund and will be documented in the accounting records. All increases and decreases to the Baccarat Progressive Jackpot reserve fund will be documented in the accounting records.

- Dragon 7 – Player 0 Suited is paid 100% of the progressive jackpot amount shown on the progressive meter

## Baccarat Progressive Jackpot

- All other hands are paid a fixed amount from the reserve fund, they do not get deducted from the amount shown on the meter
- In the event more than one progressive qualifying hand is hit during the same round, all winning players will share, in equal amounts, the posted progressive prize amount
- In the event the reserve fund is depleted, the Casino will make up any shortfall and will be reimbursed from the reserve fund once there are sufficient funds

### **Administrative Fees**

Each \$1 jackpot fee paid by a player will be broken down as follows:

- a. \$0.15 will be immediately posted on the meter
- b. \$0.85 will be tracked in a reserve fund

The Casino will retain an administrative fee ranging in an amount between \$5 and \$20, taken per table hour. The administrative fee will be taken from the reserve fund. ### **No Purchase Necessary**

The Baccarat Progressive Jackpot will be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**. The Casino will provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material will state "No Purchase Necessary" when referencing the Baccarat Progressive Jackpot. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

### **Equipment**

The electronic software and digital reader related to and used in conjunction with this gaming activity has been tested, approved, and certified by the Gaming Laboratories International, LLC (GLI). If there is a malfunction or the digital reader breaks, the jackpot will not be offered.

- When a player has a progressive qualifying hand, the house dealer will press the appropriate hand button on the keypad
- The house dealer will then contact a supervisor
- Once a supervisor verifies the progressive win, the supervisor will press the confirm button. To complete the action, a supervisor or executive card (depending on jackpot level) swipe is required. This records the win onto the Game Manager computer and adjusts the meter appropriately for the prize won. House procedures are then followed for paying the prize. (Reviewing the monitor connected to the Game Manager will show the prize amount to be paid, and pressing the "money bag" icon will print a win page, which can be used to help record the payout for accounting)
- When the house dealer reconciles all action, he/she presses "END GAME." This resets the system to begin the next hand
- Once the supervisor or executive card (depending on jackpot level) is swiped the prize is logged into Game Manager
  - If the progressive pay needs to be backed out (voided) at this point, the prize will need to be manually backed out using the Game Manager manual adjustment feature
