Bureau Requirements

The Lodi Casino may advertise various names for this gaming activity. Should the Lodi Casino advertise a different name, the BGC ID (GEGA-004207) listed below, shall be referenced on all advertisements relating to the Bargain Buy-In Promotion.

Furthermore, all rules and procedures for this promotion, including but not limited to the following, shall be displayed prominently in the Lodi Casino at all times the promotion is being offered:

- Eligible games, dates and time periods.
- Lucky Chips value.
- Procedures to wager with Lucky Chips.
- Procedures for purchasing a Bargain Buy-In Card.
- All procedures, times, qualifying hands, and prize amounts must be displayed via any form of advertising that the Lodi Casino wishes to use, including but not limited to printed flyers, digital display, the Casino's website, etc
- Any other applicable restrictions.

Controlled Game

The Bargain Buy-In Promotion may be attached to all limits and versions of the currently approved California games offered at the Lodi Casino. All base game rules will be played as previously approved by the Bureau of Gambling Control.

Rules of Play

Patrons who purchase a Bargain Buy-In Card for \$50 are eligible for a 20% buy-in bonus in the form of Lucky Chips. For example, if a player purchases \$100 in regular chips, he/she would receive an additional \$20 in Lucky Chips for a total of \$120 in Lucky Chips.

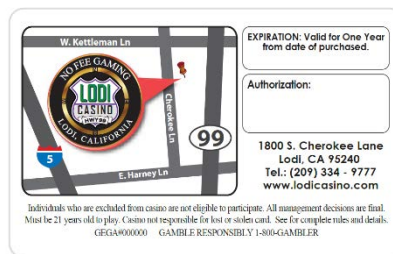
Bargain Buy-In Card

The Bargain Buy-In Card is non-transferrable. An example of the Bargain Buy-In Card is shown below:

Lucky Chips

The Lucky Chips are used in live games exactly like regular chips, the difference being that they cannot be exchanged for regular chips or cash by the player unless they were obtained while acting as the player-dealer. The rules for the Lucky Chips are as follows:

- Lucky Chips shall be used as the player's bet (including bonus bets or payment of fees, when applicable) and placed on the betting circle.

Bargain Buy-In Promotion

- They shall not be taken into the dealer's tray, nor shall they be paid from the dealer's tray.
- If the player wins the hand, he/she would be paid the winning amount by the person in the player-dealer position, just as if he/she had placed a regular bet.
- The Lucky Chips remain in play if the player pushes or wins the bet.
- If the player loses the hand, the Lucky Chips are forfeited and will be collected by the casino dealer and given to the player-dealer.
- All played Lucky Chips are verified by a key employee before they are played.
- The player-dealer may cash in the Lucky Chip by contacting a Floor Service Representative who will exchange the Lucky Chips at the cage for live chips.
- Lucky Chips may be used to pay the collection.

Prize

The Lucky Chips shall have a pre-determined and posted value. Players shall not exchange Lucky Chips for live chips. Additionally, players shall not give Lucky Chips to another player. The Lucky Chips shall only be redeemed after having been played and verified by a key employee.

Eligibility

The promotion will be open to all players who have purchased a Bargain Buy-In Card and are seated and playing at the above listed games during the pre-determined and specified hours designated for the promotion.

- A minimum of two players, a player and a player-dealer, is required to be playing in any of the games, as listed above, in order for the game to qualify.
- A player may only redeem their Bargain Buy-In Card one time per day in order to receive the 20% buy-in bonus in Lucky Chips.
- Players are responsible for purchasing a replacement Bargain Buy-In Card that was lost or stolen for the full \$50 purchase price. Lost or stolen Bargain Buy-In Cards are not the responsibility of the Lodi Casino.
- The Bargain Buy-In Card is valid for one year from the date of purchase.
- Players shall not exchange Lucky Chips for live chips unless they received the Lucky Chips while playing in the player-dealer position.

Funding

Object and Summary

The California Games Jackpot gaming activity features a fixed and progressive jackpot prize. After the hand has been confirmed, those players who paid the jackpot fee shall receive the posted prize from the progressive jackpot.

Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at an above listed controlled game during the pre-determined and specified hours designated and posted for the gaming activity.

- When a qualifying hand is announced, a floor person shall verify that the hand qualifies. Any deviation from a standard deck will nullify the jackpot.

Object and Summary

The Cash and Prize Drawing Promotion is house funded and awards players with 1-20 drawing tickets for achieving a designated qualifying hand or for playing in designated games for a predetermined amount of time. The drawing tickets allow players to win predetermined and posted prizes during a drawing to be held at a later time. - The card shall be non-transferable and can only be used by the player who the card is assigned.

- Player information shall be maintained in a secure database accessed only by casino management. Access to the database shall also be tracked by casino management.
- Player's time played is tracked by having their card scanned. They will receive a player's card once they sign up for the Customer Incentive Program at the cashier. An iTouch, iPad, or similar tablet computer device, with a bar code reader, will be affixed to the gaming table and a gambling establishment employee will scan the player's card. The gambling establishment employee will then input the player's average wager and time played into the computer tablet device.

- A printable record of the amount of time a player has accumulated during the period of time that the gaming activity is being offered, shall be available at anytime at their request.

How Player Rewards Points are Earned Based on Time Played

Points shall be earned based on the amount of time played. Each player that plays a certain table game during live play will, at certain times, receive points, which will gain them eligibility to win pre-determined and designated prizes. The range of points will be 1 to 200,000 points for each hour of play. The Lodi Casino may offer bonus rates (for example, double points) on play during off-peak hours or in specific games, within the range as shown above. At the end of the gaming session, the player will be logged out by the gambling establishment employee. The program tabulates the amount of points the player has earned and records it in the player's account. The player may check their point balance and redeem points with a gambling establishment employee at any time during the promotion.

How Player Rewards Points are Redeemed

Players may either redeem their points at any time during the promotion or at the end of the promotional period. The redemption period will be displayed in The Lodi Casino to give players ample notice. Points not redeemed by the end of the promotional period will expire within 30 days of the promotional period. All prizes shall have a pre-determined and designated value. The point to dollars ratio for the rewards program is 1 point is worth \$0.10 - \$100. After a player has accumulated a pre-determined and specific amount of points, based on time of play, a player may redeem the accrued points for a pre-determined and designated prize.

- After a player has been awarded a prize, they may also be eligible for second and subsequent prize(s) until the end of the promotion.
- Players may redeem their points for multiple prizes as long as the total amount of points required for the prizes are within the player's point balance.
- Once the points are redeemed, these points will be subtracted from their point balance.
- Upon request, a player may check their point balance with a Casino Floor Services Representative at any time during the promotion.
- Points are non-transferrable, and can only be used by the player who earned them.
- Points are eligible for redemption at anytime during the promotion or at the end of the promotional period. Points not redeemed at the end of that period will expire.

Customer Incentive Program

- All reward points are subject to review and verification. The Casino reserves the right to adjust balances or void any points due to error or fraud.

Prize

The prize amount shall be a fixed amount ranging from \$1 to \$100,000 in the form of cash, casino chips, free play chips (GEGA-003025), bonus chips (GEGA-004403), coupons, vehicles, promotional merchandise, food, entries into tournaments, entries into a Bureau approval gaming activity, etc. In addition to the fixed amount, during pre-determined and posted times throughout the promotion, there will be bonus prizes awarded when players reach a certain point level. The bonus prize will range from \$1 - \$100,000. In all instances, the actual prize(s) that players are eligible to redeem their points for shall be pre-determined and conspicuously posted in The Lodi Casino at all times that this gaming activity is being offered.

Eligibility

This gaming activity shall be open to all players 21 years of age and older with valid I.D. who sign up for a Player Reward Card and participate in an eligible game for a designated period of time to earn points. When the player chooses to exchange their accrued points, they shall win a corresponding prize.

The Customer Incentive Program does not contain the element of chance. Therefore, it does not constitute an illegal lottery and does not require No Purchase Necessary tables to be offered while conducting this gaming activity.

Daily Bad-Beat Jackpots

Bureau Requirements

Advertising

The Lodi Casino may advertise various names for this gaming activity. Should the Lodi Casino advertise a different name, the BGC ID (GEGA-004464) shall be referenced on all advertisements relating to the Daily Bad Beat Jackpot.

Furthermore, all rules and procedures for this jackpot, including but not limited to the following, shall be prominently displayed in the Lodi Casino at all times the jackpot is being offered:

- Eligible games and time periods.
- Qualifying winning and losing hands.
- Prize payout structure & how many players must be playing to receive which prize.
- Jackpot prize amount
- No Purchase Necessary (NPN) information.
- Any other restrictions that apply to this jackpot.

Eligible Controlled Game

The Daily Bad Beat Jackpot shall be attached to the following Bureau approved controlled game offered at the Lodi Casino, as shown below, at all times that this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

- Texas Hold'em (GEGA-000255)

Object and Summary

The Daily Bad Beat Jackpot features a fixed jackpot prize, which is awarded to players participating in an eligible controlled game when a designated second hand is beaten by a better qualifying hand at the showdown. The Daily Bad Beat Jackpot pays \$100 during pre-determined and posted hours once per day. When the winning and losing hands are confirmed by a floor person, those players with the qualifying jackpot hands shall receive the posted percentage of the fixed jackpot prize.

Qualifying Hands

Players that make the following advertised qualifying hands shall be eligible to win the Daily Bad Beat Jackpot prize amount, as shown below. Only winning and losing hands that have been Bureau approved, pre-determined, and designated by the Lodi Casino are eligible. In order to qualify for the jackpots, both the winning and losing hands must use two hole cards.

Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at an above listed controlled game during the pre-determined and specified hours designated and posted for the gaming activity.

The fixed jackpot prize pool shall be initially seeded in the amount of \$100 by the reserve jackpot fund. Once the jackpot is hit, the fixed jackpot prize pool will be reseeded in the amount of \$100 from the jackpot fund.

Administrative Fees

The Lodi Casino shall not retain an administrative fee.

No Purchase Necessary

A No Purchase Necessary (NPN) player can request to play, at no cost to themselves, for the displayed and advertised jackpot prize. Within 15 minutes of the request, the card room shall have a poker table set up where the NPN player can choose a seat and the dealer will deal cards to simulate a full game. The NPN player will play his/her hand as if it were a live game and the other hands (all seats are dealt a hand to simulate a full game thus offering the NPN the optimum chance to win) will be monitored/played, by the dealer. If the player makes one of the qualifying hands for the jackpot and the dealer the other, the NPN player will be awarded their share as currently displayed and approved per the gaming activity. There will be no live wagering and no live chips played at the NPN table. The NPN player shall have no restrictions placed on them and shall be able to play on an indiscriminate and unlimited basis. All advertisement material shall state "No Purchase Necessary" when referencing the Bad Beat Jackpot gaming activity. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

The house dealer will ask before each hand is dealt on any baccarat game if they would like to participate in the jackpot. Any player who would like to participate in the jackpot places a \$5 jackpot fee before the house dealer pulls the first card of the hand. The dealer will collect the participating player's jackpot fees after they deal the initial two cards to the player and the banker spots and replace the jackpot fee with a "Dragon Slayer" lamer to identify the players that have paid the Dragon Slayer jackpot fee. The dealer will then drop the collected fees in the drop box designated for the jackpot fees.

Qualifying Hands

To qualify for the jackpot prize the player and the banker must draw a third card. Below are the qualifying hands and associated prize payouts.

Dragon Slayer Jackpot

Prize Amount

The prize will be in the form of cash or casino chips and given to any player who paid a jackpot fee and made a qualifying hand. All prizes for this promotion shall be pre-determined and posted in advance, throughout the gaming floor and in all literature promoting such an event.

Eligibility

The promotion shall be open to all players who have paid the designated fee and playing at an eligible game.

High Hand Progressive Promotion

Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the pre-determined specified hours designated and posted for the gaming activity.

No Purchase Necessary

The High Hand Progressive Promotion shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the High Hand Progressive Promotion. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

Highlighted Quad Promotion Rules

Wine Country Casino

The Highlighted Quad Promotion will be a jackpot associated with all limits and versions of Texas Hold'em excluding tournaments. One of the 13 ranks (Ace-King) will be highlighted each day. If a player makes quads on the highlighted rank, the player will win the jackpot. The jackpot will be a progressive amount ranging from \$50 to \$10,000 and will be funded from the Super Bad Beat jackpot collections. The jackpot will be seeded from the Super Bad Beat jackpot fund with an amount ranging from \$50 to \$10,000 and increase with an amount ranging from \$25 to \$1,000 daily.

- Day 8 the highlighted hand will be 4 nines.
- Day 9 the highlighted hand will be 4 tens.
- Day 10 the highlighted hand will be 4 Jacks.
- Day 11 the highlighted hand will be 4 Queens.
- Day 12 the highlighted hand will be 4 Kings.
- Day 13 the highlighted hand will be 4 aces.
- Day 14 restart the above schedule.

If the jackpot has not been hit by the 14th day, the highlighted hand will reset to 4 twos, but the prize amount will continue to increase. Once the prize has been claimed the jackpot will reseed from the Super Bad Beat jackpot fund (GEGA-000259) in the amount of \$50 to \$10,000, but the highlighted hand remains the same for the rest of the day. If the same highlighted hand is hit on that day, the jackpot will be awarded at the reseeded amount. If the highlighted hand is hit and the hand qualifies for another approved promotion the player will only win the promotion that pays the most. A minimum of two (2) players are required to be dealt in during a qualifying game in order for players to be eligible and the table to qualify for the promotion.

When a qualifying hand is announced, a floor person shall verify that the hand qualifies. Any deviation from a standard deck shall nullify the promotion.

Prize

wager is collected by the player/dealer, and the voucher is voided and collected as well. If the player pushes (receives no action), the voucher may be played again until the player wins or loses a hand.

“Free Play Chip(s)”

The Casino will offer free play chips having a face value from \$5.00 to \$500.00 per chip. The chips are used in live games exactly like regular chips, the difference being that they cannot be exchanged for cash.

The free play chips are initially in the form of a coupon which will be offered to all patrons that wish to come into the Casino and use them to play. Patrons may be awarded free play coupons via advertisements in magazines, websites, mailing advertisements, winning a Bureau approved promotion, winning or signing up for a Bureau approved tournament, etc. When a patron receives a free play coupon he/she shall take the coupon to the cage for verification, logging, and redemption of the free play chip(s) to be used in a live game. Cage personnel would log the redemption code of the coupon and exchange the coupon for a promotional free play chip. The player would then place the free play chip on the gaming table, pay the posted collection (if applicable), and the game would play. If the player wins the hand, he/she would be paid \$10.00 by the person in the player/dealer position just as if he/she had placed a \$10 bet. The free play chip will be collected by the person in the player/dealer position. The player/dealer will then have a key employee verify that the chip has been played. All played free play chips are verified by a key employee. The free play chip is taken to the cage by a key employee, logged, and exchanged for the value listed on the chip. If the player loses the hand, the free play chip is forfeited and will be collected by the casino dealer and dropped in the drop box for accounting purposes. If the player pushes (receives no action), the chip may be played again until the player wins or loses a hand.

SUMMARY

Based on customer demand and industry trends, Wine Country Casino (WCC) proposes to add a gaming activity for all currently approved controlled games. The promotion will offer a Pai Gow Poker Bad Beat Jackpot.

PRIZE

The type of prize may be a cash and or casino chips ranging from \$10.00 to \$100,000.00. In addition to or in lieu of a cash prize, merchandise may also be awarded. This includes but is not limited to; free play chips, clothing, electronics, merchandise, trips, Poker Tournament entries, and various other prizes.

To win the prize a Player or Player/Dealer beaten by any valid hand consisting of a pair in the front (two card hand) and Ace High Flush or better in the back (five card hand), to a hand with a higher pair and higher Flush or better in the back (with or without the Joker). One of the qualifying hands must be in the Player/Dealer position for the jackpot to be valid.

FUNDING

This promotion will be player funded. The funding will go as follows; There will be a \$1.00 charge on the player/dealer position per hand that will be collected for the Jackpot .

ELIGIBILITY TO WIN

All persons wishing to participate in the promotion may do so while it is being offered. A minimum of three players are required to be dealt in during a qualifying game in order for players to be eligible and the table to qualify for the jackpot. 5. Explain if the gaming activity is house funded or player funded.

The activity is player funded.

6. Describe any special fee collection involved in this gaming activity. For example: jackpot fee collection.

There will be a \$1.00 charge on the player/dealer position per hand that will be collected for the Jackpot

7. Describe how the jackpot will be awarded.

Player or Player/Dealer beaten by any valid hand consisting of a pair in the front (two card hand) and Ace High Flush or better in the back (five card hand), to a hand with a higher pair and higher Flush or better in the back (with or without the Joker). One of the qualifying hands must be in the Player/Dealer position for the jackpot to be valid.

Any player occupying the player/Dealer position is eligible to participate in any Jackpot pay-off.

- A minimum of three active players, including the player-dealer, are required to be dealt in during a qualifying game in order for players to be eligible and the table to qualify for the Pai Gow Tiles Bad Beat Jackpot. If there are fewer than three active players, the table is not eligible for the jackpot and the jackpot collection fee shall not be taken.
- One hand must be held by the player-dealer and one hand must be held by the player in order to qualify for this jackpot.

Funding

The Pai Gow Tiles Bad Beat Jackpot utilizes a progressive prize pool which will be player-dealer funded via a \$1 jackpot collection fee. A collection fee shall be taken from the player-dealer position per hand before the tiles are distributed. The jackpot shall be initially seeded by Parkwest Casino Lodi in the amount of \$5,000. The house will be reimbursed the seed money from the reserve account once a sufficient amount has been collected. The jackpot will not increase past the initial seeding amount until the house is reimbursed. Additionally, when the casino is required to seed the jackpot or cover the shortfall due to inadequate funds in the reserve account, the casino shall be repaid from the jackpot reserve account once the reserve is sufficient and the funds become available. When the qualifying jackpot hands are achieved and the progressive prize is paid out, it shall be reseeded by the reserve fund in an amount ranging between \$10 and \$10,000. The jackpot shall increase daily by an amount ranging between \$10 and \$300 based on the average amount collected daily. Any monies not posted to the meter will go directly to the reserve fund. This jackpot has a cap amount of \$100,000. Once the progressive jackpot has reached the cap, all monies collected over the cap will be placed in a reserve fund. Object and Summary

The Poker Pyramid Promotion is house funded, and features a specific fixed prize amount to each achieved qualifying hand. A board is used to place the prizes in a pyramid fashion with the hands used to make the base; see below for an example of a pyramid. Players who achieve a qualifying hand while participating in a Bureau approved controlled game, as listed above, are awarded a predetermined prize. When a casino representative confirms the winning hand, the player with the qualifying hand will immediately receive the posted prize amount; the casino representative removes the prize and the qualifying hand from the list of eligible hands on the pyramid. After the removal of a prize, the next prize in sequence will be awarded to the next qualifying hand. No specific sequence is required to make the qualifying hands. Prizes are awarded from left to right, one row at a time until the row is empty, then the next row of prizes awarded begins (a row of prizes must be won before the next row of prizes will be offered). This will continue until there is one prize left (the top of the pyramid) and one qualifying hand left on the pyramid base.

The Casino will display the Poker Pyramid board (with qualifying hands and prizes) prominently near the eligible gaming tables. Eligibility Requirements

This gaming activity will be open to all players who are seated and playing at any of the above listed controlled games during the pre-determined specified hours posted for the gaming activity.

- Each game will have a corresponding pyramid for payouts. Each above mentioned controlled game will be independent of the other controlled games. Each of the above mentioned controlled games will have its own pyramid board.
 - If multiple tables of the same controlled game are in play, all tables for the controlled game will be eligible for the promotion.
- Backline bettors cannot participate in the promotion nor win a prize even if the base game rules allow backline betting.
- During a round of play, if multiple players have qualified with eligible hands, prizes awarded will be to each player per the value on the board.
 - For Texas Hold'em, a hand containing five cards is required for the promotion regardless of the sequence the round of play ends at.
 - When a pyramid prize row has differing prizes to award, the first prize awarded is to the active player closest to where the action of base game payouts begins.

EXAMPLE: *If multiple patrons achieve a qualifying hand, the first prize awarded will be to the patron closest to where the action begins per the base game rules, and then the next prize awarded will be to the next patron closest to the action and so forth.*

Poker Pyramid Promotion

- During a round of play, if multiple players achieve a qualifying hand, the board will have the number of pyramid prizes and matching hands removed from the board matching the number of players paid.
- Players may win an unlimited number of times during the promotion.
- Two players minimum are required for Texas Hold'em.
- Two players minimum are required for the above mentioned controlled California games, the player and player-dealer.
 - Patrons who assume the player-dealer position are eligible to win a prize.
- For Three Card Poker 6 Card Bonus, the patron in the player-dealer position will make their hand using the player-dealer's hand and the first player's hand according to the placement of the "action button." Essentially, if the player with the action button wins, so will the patron in the player-dealer position.
 - In addition, if two players make the exact same hand, the two patrons will share the posted prize.
 - However, if three players make a qualifying hand, the odd number of chips will be awarded to the patron closest to the action button.

EXAMPLE: *If two players have a pair of kings each, and the player-dealer has three 7s, the prize is split between the two players and only the one awarded prize and the one qualifying hand is removed from the pyramid.*

- Third Party Provider of Proposition Player Services, on and off duty, will not be eligible to participate in the promotion.
- Off-duty, out of uniform employees are eligible to participate in the promotion and win.
- Tournament games do not qualify for the promotion.

Prize

The promotion has a fixed prize with amounts ranging in value from \$10 to \$10,000. Payout for prizes may be in the form of cash, live casino chips, merchandise, trips, poker tournament entries, or electronics. The merchandise, trips, poker tournament entries, or electronics will be of equivalent value as to the dollar amount listed on the pyramid. The actual prize amount will depend on the amount on the pyramid prize structure and its seeded amounts. After the hand/round is over and the qualifying hands are verified, the awarded prizes are immediately paid. In all instances, the Parkwest Casino Lodi will at all times conspicuously post the prizes.

Prize Payout Structure

Players, who attain a qualifying hand, as designated above, will be eligible to win the corresponding prize determined by the pyramid. After each eligible achieved qualifying hand, the hand will be removed from the list of eligible hands on the base of the pyramid. After each prize is paid, the prize is removed, and the next prize in order is awarded for the next qualifying hand. Awarded prizes are from left to right, and then from bottom to top of the pyramid, (a row of prizes must be won before the next row of prizes will be offered); different players at different tables can win the prizes and qualifying hands. This will continue until there is one prize left (the top of the pyramid) and one qualifying hand left on the pyramid base. Once the final achieved hand and prize is awarded, a new Poker Pyramid may be used.

Poker Pyramid Promotion

After a casino representative confirms the winning hand, the player with the qualifying hand will immediately receive the posted prize amount; the casino representative removes the prize and the qualifying hand from the list of eligible hands at the base of the pyramid.

In the event multiple players have qualified with eligible hands, prizes will be awarded to each player per the value on the board. When a pyramid prize row has differing prizes to award, the first prize awarded is to the active player closest to where the action of base game payouts begins.

Funding

Parkwest Casino Lodi will fund the Poker Pyramid Promotion. There will be no additional jackpot fees or collection fees taken in order to fund this gaming activity or for players to participate.

Administrative Fees

Parkwest Casino Lodi will not retain any administrative fees for this gaming activity as it is house funded.

No Purchase Necessary

The Poker Pyramid Promotion will be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**, to patrons who wish to participate in a No Purchase Necessary game. The Casino will provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material will state "No Purchase Necessary" when referencing the Poker Pyramid Promotion. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

Secondary Bad-Beat Jackpots

Bureau Requirements

Advertising

The Lodi Casino may advertise various names for this gaming activity. Should the Lodi Casino advertise a different name, the BGC ID (GEGA-000259) shall be referenced on all advertisements relating to the Secondary Bad Beat Jackpot.

Furthermore, all rules and procedures for this jackpot, including but not limited to the following, shall be prominently displayed in the Lodi Casino at all times the jackpot is being offered:

- Eligible games and time periods.
- Qualifying winning and losing hands.
- Prize payout structure.
- Jackpot prize amount.
- Any No Purchase Necessary opportunity.
- Any other restrictions that apply to this jackpot.

Eligible Controlled Game

The Secondary Bad Beat Jackpot shall be attached to the following Bureau approved controlled game offered at the Lodi Casino, as shown below, at all times that this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

- Texas Hold'em (GEGA-000255)

Object and Summary

The Secondary Bad Beat Jackpot features a progressive jackpot prize, which is awarded to players participating in an eligible controlled game when a designated second hand is beaten by a better qualifying hand at the showdown. The Secondary Bad Beat Jackpot pays \$100-\$25,000 during pre-determined and posted hours. When the winning and losing hands are confirmed by a floor person, those players with the qualifying jackpot hands shall receive the posted percentage of the progressive jackpot prize. Additionally, a posted percentage of the jackpot prize, known as the table share, shall be evenly distributed amongst all players who were sitting at the Texas Hold'em table that were actively playing when the bad-beat was "hit," as shown below.

Qualifying Hands

Players that make the following advertised qualifying hands shall be eligible to win their share of the Secondary Bad Beat Jackpot prize amount, as shown below. Only winning and losing hands that have been Bureau approved, pre-determined, and designated by the Lodi Casino are eligible. In order to qualify for the jackpots, both the winning and losing hands must use two hole cards. Only one of these qualifying hand options shall be offered at any one time for the Secondary Bad Beat Jackpot. No combination of the qualifying hand options shall be offered together at any time that this gaming activity is being offered

Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at an above listed controlled game during the pre-determined and specified hours designated and posted for the gaming activity.

- Players with qualifying winning and losing hands must play through the final betting round in order to qualify for the jackpot. If a player with one of the qualifying hands folds prior to the final betting round, the table will be in-eligible for the jackpot.
- When a qualifying hand is announced, a floor person shall verify that both hands qualify. Any deviation from a standard deck will nullify the jackpot.
- Both hole cards must play for the losing and winning hands in order for the table to qualify for the jackpot.
- A minimum of five seated players are required to be dealt in during a Texas Hold'em game in order for players to be eligible, the jackpot fee to be taken, and the table to qualify for the Bad Beat Jackpot prize amount.
- Only off duty, out of uniform, Casino employees are eligible to participate in this gaming activity.
- On and off duty Third Party Players are not eligible to participate in this gaming activity.
- Tournament games do not qualify for this promotion.

Prize

The jackpot prize is progressive with a minimum value of \$100 and a maximum value of \$25,000. The bad-beat jackpot will be seeded at \$100 and will increase by up to \$25 per day until it reaches its maximum limit of \$25,000. When the jackpot has been hit, the payout will be paid according to the chart listed above. The jackpot prize shall be paid in the form of cash. The actual progressive jackpot prize amount shall depend on the amount the jackpot was originally seeded at, as well as how many days have transpired in order for the posted jackpot prize to increase progressively each day by the number of jackpot collection fees dropped the previous day.

Prize Payout Structure

Players that make the advertised qualifying hands shall be eligible to win their share of the posted Secondary Bad Beat Jackpot progressive prize amount, according to the payout, as shown below.

Secondary Bad-Beat Jackpots

Funding

The Secondary Bad Beat Jackpot utilizes a progressive prize pool that is player funded through the \$1 jackpot collection fee which is taken from the pot after the flop is dealt. The jackpot prize will increase every morning up to \$25 per day until it reaches its maximum limit of \$25,000.

Once the maximum amount has been reached, a reserve account will start. The progressive jackpot prize pool shall be initially seeded in the amount of \$100 to \$25,000 by the casino. The casino will be refunded the seed amount once it's collected. The amount collected during a day shall be posted the next day. If more than \$25 has been collected each day, the excess money will immediately go into the reserve. The progressive jackpot prize pool shall then increase daily based solely on the number of jackpot collection fees collected and dropped during live play at all approved tables during the previous day. Once the jackpot is hit, the progressive jackpot prize pool will be reseeded in the amount of \$100 from the jackpot fund. The jackpot collection shall be kept in separate drop boxes apart from the regular table collection.

Administrative Fees

The Lodi Casino shall retain an administrative fee of \$4 per table hour from the jackpot prize pool, which will be retained by the Casino. The fee will be used to cover the cost of marketing and operating the jackpot.

No Purchase Necessary

A NPN player can request to play, at no cost to themselves, for the displayed and advertised jackpot prize. Within a reasonable amount of time of the request, the card room shall have a poker table set up where the NPN player can choose a seat and the dealer will deal cards to simulate a full game. The NPN player will play his/her hand as if it were a live game and the other hands (all seats are dealt a hand to simulate a full game thus offering the NPN the optimum chance to win) will be monitored/played, by the dealer. If the player makes one of the qualifying hands for the jackpot and the dealer the other, the NPN player will be awarded their share as currently displayed and approved per the gaming activity. There will be no live wagering and no live chips played at the NPN table. The NPN player shall have no restrictions placed on them and shall be able to play on an indiscriminate and unlimited basis. All advertisement material shall state "No Purchase Necessary" when referencing the Secondary Bad Beat Jackpot gaming activity. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

“Match Play Coupon”

The Casino will offer match play coupons having a face value from \$5 to \$500 per coupon. This will be clearly stated on the coupon. Patrons are awarded match play coupons via advertisements in magazines, websites, mailing advertisements, winning a Bureau approved promotion, winning or signing up for a Bureau approved tournament, etc. When a patron receives a coupon he/she may use it in any of the controlled games listed above. Each coupon will state the specific qualifying game(s) that the voucher may be used on.

EXAMPLE: A person receives a match play voucher with a value of \$5.00 that specifically states it may be used to place a wager on the Pai Gow Poker table. The person would place the voucher on the gaming table; place a bet that matches the amount on the voucher, and pay the posted collection (if applicable) for a single hand of play. If the player wins the hand, he/she will receive \$10.00 just as if they had placed a \$10.00 bet and the player/dealer will collect the voucher. The player/dealer will then have a key employee sign the voucher verifying that it has been won. All winning vouchers are verified and signed by a key employee. Winning vouchers are taken to the cage by the key employee, logged, and exchanged for the value listed on the coupon(s). If a player loses, the money part of the

wager is collected by the player/dealer, and the voucher is voided and collected as well. If the player pushes (receives no action), the voucher may be played again until the player wins or loses a hand.

“Free Play Chip(s)”

The Casino will offer free play chips having a face value from \$5.00 to \$500.00 per chip. The chips are used in live games exactly like regular chips, the difference being that they cannot be exchanged for cash.

The free play chips are initially in the form of a coupon which will be offered to all patrons that wish to come into the Casino and use them to play. Patrons may be awarded free play coupons via advertisements in magazines, websites, mailing advertisements, winning a Bureau approved promotion, winning or signing up for a Bureau approved tournament, etc. When a patron receives a free play coupon he/she shall take the coupon to the cage for verification, logging, and redemption of the free play chip(s) to be used in a live game. Each coupon will state the specific qualifying game(s) that the free play chip(s) may be used on.

Promotional chips are used as the player’s bet and placed on the betting circle. Promotional chips are never taken into the dealer’s tray, nor are they ever paid from the dealer’s tray.

EXAMPLE: A person receives a free play chip coupon for \$10.00 that specifically states it can be used to place a wager on the No Bust Blackjack table. The player would take the coupon to the cage. Cage personnel would log the redemption code of the coupon and exchange the coupon for a promotional free play chip. The player would then place the free play chip on the gaming table, pay the posted collection (if applicable), and the game would play. If the player wins the hand, he/she would be paid \$10.00 by the person in the player/dealer position just as if he/she had placed a \$10 bet. The free play chip will be collected by the person in the player/dealer position. The player/dealer will then have a key employee verify that the chip has been played. All played free play chips are verified by a key employee. The free play chip is taken to the cage by a key employee, logged, and exchanged for the value listed on the chip. If the player loses the hand, the free play chip is forfeited and will be collected by the casino dealer and dropped in the drop box for accounting purposes. If the player pushes (receives no action), the chip may be played again until the player wins or loses a hand.

8. Explain any prize distribution including prizes given to the winner, loser, or any other player or patron.

If a player wins a hand on a base game where they have played a match play coupon or free play chip, he/she will be awarded 100% of the face value on the coupon or chip.

Once the original seeded amount is depleted the funds may be re-seeded by the Casino. Appropriate records will be kept and available for inspection as required by law.

Gaming Activities Offered During California Tournament Play

The Parkwest Casino Lodi is not approved to offer gaming activities during the play of California Games Tournaments at their gambling establishment.

Tournament Variations

Freeroll Tournament

- It shall be predetermined and posted when a freeroll tournament shall be offered.
- Entry is gained by playing in a selected amount of tournaments or play in live games during a predetermined time period. The Parkwest Casino Lodi may also offer freeroll tournaments to selected players based on their discretion.
- The freeroll tournament prize pool is funded by the Parkwest Casino Lodi.

Tournament Entry

- Tournament entry shall be open to all customers.
- The specific structure shall be on any and all advertisements and must be made available to patrons prior to the start of the tournament. The structure of a tournament shall not change once sign-ups begin.
- **Promotional materials will not advertise gender-based discounts nor imply a gender-based entrance policy.**
- Patrons may enter a tournament by paying the buy-in, entry fee, and any other applicable fees as determined by the Parkwest Casino Lodi, as approved in these rules. All fees, prices charged, and the amount of tournament chips provided shall be equal and posted for all players.
- Entry may be earned by winning a previous tournament. Entry may also be earned through other promotions offered at the Parkwest Casino Lodi. All gaming activities and/or promotions shall be approved by the Bureau prior to being offered for play.
- More than one method of entry for a specific tournament may be utilized.

**The Service Fee shall be retained by the Parkwest Casino Lodi and used exclusively to pay tournament staff, make upgrades to equipment and advertisements that directly benefit the tournament area and/or its presentation. This is an optional fee that tournament entrants may pay in exchange for additional tournament chips. This fee shall not be included in the tournament prize pool.

***The Dealer Appreciation Fee shall be retained by the Parkwest Casino Lodi and used exclusively to pay tournament dealers. This shall be an optional fee that tournament entrants may pay in exchange for additional tournament chips. This fee shall not be included in the tournament prize pool.

Tournament Prize Amounts & Source of Funds

- Procedures for purchasing the VIP Prime Membership
- Monthly price of membership
- The date(s) and time(s) the promotion shall be offered
- Any limits to the amount of prizes a VIP Prime Member may win during the promotional period.
- Any limitations to the quantity of a prize.
- The games eligible for the promotion
- Eligible prizes, prize quantities, and prize values
- Any other restrictions that apply to this gaming activity

Eligible Controlled Games

The VIP Prime Membership promotion shall be attached to all Bureau approved California games offered at Parkwest Casino Lodi at all times the gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

Object and Summary

The VIP Prime Membership promotion is an enhancement to the Customer Incentive Program (GEGA-004483). The VIP Prime Membership will offer patrons who sign up and pay a monthly fee, the opportunity to participate and win prizes that are both complimentary and independent to those awarded in the Customer Incentive Program and other gaming activities.

In order to participate in the VIP Prime Membership promotion patrons need to first be members of the Customer Incentive Program. They will then sign-up and pay a corresponding monthly fee. A VIP Prime Member Card will be given to members to represent their membership status in the Customer Incentive Program and the VIP Prime Membership.

Eligibility Requirements

This gaming activity shall be open to all players 21 years of age and older with valid I.D.

- This gaming activity is restricted to Customer Incentive Program members (GEGA-004483).
- Participants may sign up for the Customer Incentive Program and the VIP Prime Membership on the same day.
- Participants must pay the monthly fee on time.
- Participants may pay the monthly fee with credit card, cash, live casino chips, or Customer Incentive Program points.
- All VIP Prime Members are subject to the same monthly fee.
- VIP Prime Members will be guaranteed at least one opportunity to participate and win a prize per month.

VIP Prime Membership

- Promotional periods in this gaming activity are equal to one month.
- A VIP Prime Membership card will have the player's name and membership number. If the card is lost or stolen, a replacement will be replaced free of charge.
- The VIP Prime Membership is non-transferable.
- Casino employees are not eligible to participate in this promotion.
- Third-Party Providers of Proposition Player Services (TPPPS), on or off duty, shall not be eligible to participate in this promotion.
- A VIP Prime Member is eligible to participate in this promotion while in the player-dealer position.
- There is no limit to how many VIP Prime Membership prizes a player may win during the life of their membership.
- Any limit to the amount of prizes a VIP Prime Member may win during a promotional period will be predetermined and posted.
- A participant in this promotion must claim any advertised prizes within the posted promotional periods
 - A prize will not be awarded to participants after a promotional period has ended, regardless if the monthly fee was paid.
- Tournament games are eligible for this gaming activity.

Prize

The VIP Prime Membership offers fixed prizes which range in value from \$1 to \$500,000. The eligible prizes are grouped into two categories; Complimentary Prizes and Independent Prizes.

Complimentary Prizes

Complimentary prizes are prizes that compliment a currently active gaming activity. These prizes will be awarded in addition to the prize awarded by the gaming activity. These prizes consist of receiving additional:

- Bonus Chips for buying into the Bonus Chip Promotion (GEGA-004403)
- Points during the Customer Incentive Program (GEGA-004483)
- Drawing Tickets for participating in the Cash and Prize Drawing Promotion (GEAR-001243)
- Free Play Chips when participating in the Match Play Coupon Promotion (GEGA-002343)

Example of a Complimentary Prize: *Every Mondays in the month of August, patrons who participate in the Bonus Chip promotion by buying into an eligible game for \$2,000 will receive \$250 in Bonus Chips. All VIP Prime Members who buy-in to the Bonus Chip promotion for \$2,000 will receive an additional \$100 in Bonus Chips for a total of \$350 in Bonus Chips.*

Independent Prizes

Independent prizes are awarded independent of any currently active gaming activities and consist of; cash, live casino chips, merchandise, food, California Games Tournament Entries (GEGA-002747), gift cards, electronics, limousine service, event tickets, private dining, shoe shine service, valet and preferred parking, private events, ride share service, and car wash service.

Example of an Independent Prize: *During the month of August all VIP Prime Members will receive free Valet Parking.*

VIP Prime Membership

Participants in this gaming activity must claim their prize within the posted promotional period using their VIP Prime Membership card. Some prizes may be offered in limited quantities. In the event an offered prize is unavailable or exhausted, a substitute prize or prizes will be offered to all remaining VIP Prime Members within the posted promotional period.

Funding

The VIP Prime Membership shall be fully funded by Parkwest Casino Lodi.

Membership Fees

Parkwest Casino Lodi shall charge patrons a monthly membership fee to participate in the gaming activity. The monthly fee shall be a fixed amount ranging from \$50 to \$500. The price of the monthly fee will be advertised and posted. Participants must pay the monthly fee on time. If a patron does not pay the monthly fee within the month's five day grace period, the membership will be cancelled. In addition, to accommodate a customer, per casino management's discretion, the monthly fee can be waived. Participants may pay the monthly fee with credit card, cash, live casino chips, or Customer Incentive Program points.

Administrative Fees

Parkwest Casino Lodi shall not retain an administrative fee for this promotion as it is house funded

No Purchase Necessary

The VIP Prime Membership does not contain the element of chance. Therefore, it does not constitute an illegal lottery and does not require a No Purchase Necessary table to be offered while conducting this gaming activity.

Multi-Game Jackpot

Bureau Requirements

Advertising

The Parkwest Casino Lodi may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEAR-001089) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in the Parkwest Casino Lodi at all times the gaming activity is being offered for play:

- Eligible games and time periods
- Qualifying hands and corresponding prizes
- Jackpot fee required
- The prize amount awarded and how it should be distributed between all eligible players
- The prize pool will be increased daily at predetermined and designated times with an amount ranging from \$5 to \$10,000 based on the amount collected
- Any No Purchase Necessary opportunity
- Any other restrictions that apply to this gaming activity

Object and Summary

The Multi-Game Jackpot features a fixed and a progressive jackpot prize. Players must pay an optional \$1 jackpot fee in order to be eligible to win the prize and achieve a designated qualifying hand as listed below.

California Games

A prize is awarded to players, who have paid the optional \$1 jackpot fee, in any of the eligible California Games referenced above, when the player-dealer has been dealt a qualifying hand as listed below. After the hand is confirmed, those players who have paid the jackpot fee shall receive the posted prize from the progressive jackpot or the fixed prize jackpot dependent on the qualifying hand.

Multi-Game Jackpot

Poker Games

A prize is awarded to players, whom have paid the optional \$1 jackpot fee, in any of the eligible Poker games referenced above, based on the community cards dealt as listed below. The \$1 jackpot fee will be placed on the betting circle in front of each seat at the table. After the hand is confirmed, those players who have paid the jackpot fee shall receive the posted prize from the progressive jackpot or the fixed prize jackpot dependent on the qualifying hand.

Qualifying Hands

California Games

When the player-dealer makes one of the following advertised qualifying hands during the play of an eligible California Game, as listed above, all players who paid the jackpot fee shall be eligible to win their share of the posted Multi-Game Jackpot prize amount, as shown below. Only the hands that have Bureau approved and designated by the Casino are eligible. All qualifying hands within a chart must be offered together at all times.

Poker Games

When a qualifying hand is made from the community cards on an eligible poker game, as listed above, all players who paid the jackpot fee shall be eligible to win their share of the posted Multi-Game Jackpot prize amount, as shown below. Only the hands that have Bureau approved, predetermined, and designated by the Casino are eligible. All qualifying hands within a chart must be offered together at all times.

* The hand must be achieved using the cards in the flop (the first three community cards), in order to be eligible for the fixed prize in the poker games.

California Game Example: Prior to the play of the hand, five players placed a jackpot wager. The jackpot hand is made by the player-dealer, and the posted prize is \$42,000. Each of the five players would then receive \$8,400.

Poker Game Example: Prior to playing the hand, eight players placed a jackpot wager. A royal flush jackpot hand is made with the five community cards, and the posted prize is \$40,000. Each of the eight players would receive \$5,000.

Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours posted for the gaming activity.

- Any deviation from a standard deck will nullify the jackpot.
- There is a minimum of two players (player and player-dealer for California Games) required to be dealt in during an eligible game in order for the players to qualify for the jackpot prize.
- The optional \$1 jackpot fee shall be placed on the designated betting circle for both California and Poker games.
 - The fee will be collected at the completion of every hand. When a qualifying hand is announced, a casino representative shall verify that the hand qualifies.
- Players are eligible to win this promotion more than once.
- Casino employees who are off duty, and out of uniform, shall be eligible to participate to win in the Multi-Game Jackpot Promotion.

California Game Specific

- Backline bettors are eligible to participate in this jackpot. However, the base game rules must allow for backline betting and there must be an open backline betting position.
- Third-Party Providers of Proposition Players Services (TPPPS) shall not be eligible to participate and win in the California games of the Multi-Game Jackpot.
- A patron in the player-dealer position shall be eligible to win their share of the fixed/progressive prize, so as long as they pay the jackpot fee and achieves a qualifying hand.
- California Tournament Games are not eligible for this promotion.

Poker Game Specific

- Poker proposition players are eligible to participate in this jackpot.

Multi-Game Jackpot

- Poker Tournament Games are not eligible for this promotion.

Prize

The jackpot prize is a fixed and a progressive jackpot with a minimum value of \$5 and a maximum of \$1,000,000. Every eligible game has the opportunity to win either the progressive or the fixed prize, depending on the qualifying hand.

The fixed jackpot prize shall be paid out in the form of cash, live casino chips, merchandise, trips, tournament entries (GEGA-002747, GEGA-000653), and electronics. If the value of the prize is lower than the advertised fixed jackpot, the Casino will make up the difference with another form of prize listed above.

The progressive prize will be paid out in live casino chips, or cash, and the amount shall depend on the amount the jackpot was originally seeded at, as well as how much time was accumulated in order for the jackpot to increase progressively each day.

Prize Payout Structure

There is only one prize pool. The California games patrons and Poker games patrons will be playing for the same progressive and fixed prizes. The payout shall be split evenly for the posted progressive amount among the players who placed a jackpot bet and have qualifying hands. If a qualifying hand is made with a fixed prize amount, each player who placed a jackpot bet will receive the entire posted amount.

- For California Games, payouts will be made to each active player and any backline positions for this position, then payout to the next active position and backline bettor, and continue in this procedure.

Funding

The Multi-Game Jackpot gaming activity utilizes one jackpot account and shall be funded by the \$1 jackpot collection fee. The jackpot collection fee shall be dropped into a separate drop box marked as "jackpot".

The prize pool shall be initially seeded at a minimum of \$5,000. The jackpot has a cap of \$1,000,000. If the jackpot reaches the cap amount, all other jackpot fees collected shall be placed in the jackpot reserve account.

The prize pool will be increased daily at predetermined and designated times with an amount ranging from \$5 to \$10,000 based on the amount collected. After increasing the progressive prize pool, any extra amount accumulated that day will be added to the reserve fund. When a qualifying jackpot hand is achieved and paid out, the jackpot amount will be reseeded by Parkwest Casino Lodi with an amount ranging from \$5,000 to \$50,000.

- The fixed prize will be taken from the reserve account.
- The Casino shall initially seed the jackpot.
 - The Casino will be reimbursed when the reserve account has sufficient funds.
- The Casino will cover any shortfall.
 - The Casino shall be refunded by the reserve account when there are sufficient funds.
- If there are insufficient funds in the reserve account, the Casino shall absorb the cost until there are sufficient funds in the reserve account.

Multi-Game Jackpot

Administrative Fees

Parkwest Casino Lodi shall retain an administrative fee of \$5-\$10 per table per hour from all eligible California and Poker games and will be taken from the reserve account. This fee will be used to cover advertising for the jackpot prize, security to pull and count the boxes, accounting, equipment, surveillance, and the cost of the gambling establishment personnel that administer the jackpot.

No Purchase Necessary

The Multi-Game Jackpot shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the Multi-Game Jackpot. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.
