

## 21<sup>st</sup> Century Blackjack Questions

1. 21<sup>st</sup> Century Blackjack bonus hands
2. 21<sup>st</sup> Century Blackjack
3. If a player achieves any of the following three (3) bonus hands, the corresponding payout will be made:
  - 7-7-7 all of the same suit: **\$777.**
  - 8-7-6- all of the same suit: **\$200.**
  - 7 Card Charlie(7 cards that total 21 or less): **\$100**
4. The prizes are cash and they are not progressive but fixed
5. The bonuses are house funded.
6. There are no special fees or collections attached to these bonuses.
7. The Casino will fund all bonus hand payouts. Winning players will be paid upon floor verification of the bonus hands.
8. The bonuses will be immediately reseeded upon payment of the qualifying hand.
9. A minimum of one (1) player needs to be at the table for the bonuses to be active.
10. The house does not retain any fees for the operation of this promotion/bonus.
11. As with all bonus opportunities our No Purchase Necessary Policy would be in effect allowing patrons the opportunity to participate in this activity without placing a live wager or paying any table fees.
12. Promotional literature is attached.
13. No other person or entity other than those licensed as the house is involved in this gaming activity.
14. This bonus is offered for 21<sup>st</sup> Century Blackjack and the game is played on a standard blackjack table with an automatic shuffling machine and a house dealer.

# The 101 Casino

## 21<sup>st</sup> Century Blackjack Bonuses

(1) The specific bonuses are to be paid if the Player's hand achieves any of the following hard to hit sequences, with the associated payout for each occurrence.

(2) These bonuses are not available to the Player-Dealer's hand.

### General Rules for Bonuses and Demonstration Tables

(1) There is no extra collection for these bonuses. These bonuses will be funded by the casino.

(2) The bonuses will be immediately reseeded upon payment of the qualifying hand.

(3) If there is more than one player wagering on the seat which received a hand that qualified for the bonus, the bonus will be divided evenly between all players with wagers on that seat.

(4) If more than one seat receives a qualifying hand on the same round of play, each qualifying hand will receive the full amount of the bonus that is designated for that qualifying hand.

(5) These bonuses will be available to all customers, whether or not they are actively playing 21<sup>st</sup> Century Blackjack games.

- A "demonstration table" will be available at all times to insure that customers not actively playing 21<sup>st</sup> Century Blackjack games are eligible for the bonuses.
- Per Section 19984 of the Gambling Control Act, Third Party Prop Players are not eligible for these bonuses.

(6) This promotion is not in effect during the dealing of any hands in tournaments for that particular game.

(7) The casino reserves the right to cancel the promotion at any time without written notice.

(8) The rules for the demonstration table remain the same as with the other promotions in the casino.

- Demonstration Tables will be made available to customers during any time that the casino is open, and there is a live Blackjack game, for an indiscriminate length of time, simply by making a request to the floor supervisor.
- To participate at a Demonstration Table requires no buy-in, no purchase of chips and no collections.
- Players at these tables will use Demonstration chips that have no cash value.
- There is no minimum number of players for the "Demonstration Table". Hands will be dealt at the approximate pace of a regular 21<sup>st</sup> Century Blackjack game.
- If there are more patrons wanting to play at the "Demonstration" table than the normal seats available, a "waiting list" will be established as in any other casino game.

(9) The 101 Casino will follow the regular game procedure for no purchase necessary tables. The player-dealer button will rotate around the table after every second hand. Players have the opportunity to decline to act as player-dealer. To the extent that a house dealer is playing the hand for a vacant seat, she will accept the opportunity to act as player-dealer and will play all hands House Way (basic strategy for 21<sup>st</sup> Century Blackjack).

(10) The 101 Casino will do everything possible to make a no purchase necessary table available to patrons within fifteen minutes of a request. If no other patrons are available to participate in a no purchase necessary table within fifteen minutes of a request, The 101 Casino will provide a table where the no purchase necessary player will play only one hand and the casino dealer will play the remaining hands according to House Way (basic strategy for 21<sup>st</sup> Century Blackjack).

## Aces Cracked Jackpot

### General Rules

#### GEGA-000682

The gaming activity involves no other entity other than the house. There is no copyright, patent, or license involved with this activity.

Standard poker tables will be utilized for this activity. A standard 52 card poker deck will also be utilized as well as licensed, professional dealers. Our tables are equipped with Shuffle Master in table shuffling machines.

This bonus, jackpot, is paid to a player in a Texas Hold'em poker game if that player;

- Receives two aces as his/her first two cards that are dealt face down.
- Completes play on all four rounds of the hand, pre-flop, flop, turn and river, and does not fold the hand.
- Completes the applicable bets on each round. If the player goes "all-in" this is considered to have completed all bets.
- Loses the hand on the "showdown", after the final round of betting.

The cash prize for the bonus jackpot will be:

Ace – Ace (Same Color)	Range between \$25 to \$100
Ace – Ace (Any Color)	Range between \$25 to \$100
King – King (Any Color)	Range between \$50 to \$100
Queen – Queen (Any Color)	Range between \$50 to \$100

The jackpot amounts will be pre-determined and posted by the casino.

The player holding "pocket aces", "pocket kings," or "pocket queens" can make no sign or gesture, whether verbal, visual, or otherwise to any other player that he/she holds the qualifying hand. Any signs or gestures will invalidate that hand for the jackpot. There will be no extra collection taken for this bonus, jackpot. This activity is house funded

If more than one seat receives a qualifying hand on the same round of play, each qualifying hand will receive the full amount of the jackpot. The jackpot will not be valid during tournament play and is only valid during "live" game play.

**No Purchase Necessary:** The Aces Cracked Jackpot will be offered for free, on a general and indiscriminate basis, with no restrictions to patrons who wish to participate in a No Purchase Necessary (NPN) game. The 101 Casino will provide NPN tables for all patrons who request to participate in the jackpot without paying a table fee or placing a wager. The NPN player must adhere to all rules as the live player. All advertisements shall state "No purchase Necessary" for the Aces Cracked Jackpot.

This promotion will be offered during selective hours at the Casino's discretion. The hours will be clearly posted within the Casino. The 101 Casino reserves the right to cancel this promotion at any time without written notice.

**Change from Player to House Funded**

- **No extra collection or drop box will be used**
- **This gaming activity is completely house funded**
- **A report shall be submitted to the DOJ Game Review Unit bi-weekly to show the progress of the current fund (funded by the players) is being distributed**
- **This gaming activity will continue with house funding and the rules and winning events remaining the same**
- **Signage shall be prominently displayed in the poker area that the promotions will be house funded once approved by BGC**

*When players buy into any listed promotional game for a pre-designated dollar amount ranging from \$40 to \$1,000, The 101 Casino will add additional chips ranging from \$20 to \$200, to their chip stack. There would be a minimum of two (2) hours of play (or the player would return the bonus UNLESS s/he went busted/lost their money), unless stated and posted otherwise. The range of cash required, the bonus chips given and the playing time requirement will all be pre-designated and posted before the promotion begins in a clear and conspicuous area. A player is only eligible for this promotion once per day.*

4. If a cash prize is involved, is the amount of the prize progressive (increases) or a fixed amount?

*Fixed amount.*

5. Explain if the gaming activity is house funded or player funded.

*House funded.*

*When a player buys in during the designated promotional time period with the conditional buy-in amount, they will receive a listed bonus amount of chips.*

*For example, The 101 Casino decides to offer a \$60 for \$40 in our \$2-\$4 Texas Hold'em game between the hours of 10a and 11a. The bonus will be paid up front to any player who plays for a minimum of two hours.*

*In the event that a player busts out before the required play hours are up, then The 101 Casino will incur the loss of the bonus chips. In the event that a customer has to leave before the required amount of play has been met, then that customer will need to pay back the bonus chips, as long as they have enough left in play. The 101 Casino will **not** require a customer to owe the money at a future time. The time of play will be tracked by a Casino employee.*

*For example, a player buys in during the above mentioned \$2-\$4 promotional time. He buys in for \$40 and receives \$60 in chips (\$20 in bonus chips). An hour later, the player has an emergency at home and has to leave but only has \$15 left in front of him. The 101 Casino will pick up the \$15 as these are still bonus chips. However, The 101 Casino will **not** expect the customer to pay the balance of \$5 on the customer's next visit. Once again, The 101 Casino will incur the losses for these scenarios for the sake of this promotion.*

*There are no winners or losers in this promotion as it is not a promotion of chance. All patrons who meet the posted criteria are eligible for the bonus chips.*

### Rules of Play

The Bonus Chip Promotion will be open to all patrons who buy-in to a pre-determined game for a pre-determined amount ranging from \$10 to \$100,000. Participants will receive a specific amount of Bonus Chips in any controlled game listed above.

## **Bonus Chip Promotion**

### **Purchasing Bonus Chips**

Players may purchase bonus chips at the cage at pre-determined and posted times. When patrons buy-in to a pre-determined game for a pre-determined and posted amount ranging from \$10 to \$100,000, they will receive an amount ranging from \$1 to \$10,000 in bonus chips for buying into a predetermined game.

### **Bonus Chips:**

The prize shall be awarded to a player when he/she redeems one of the aforementioned advertisements. The player will receive the advertised amount of bonus chips. The bonus chips are of a different style and design from the standard casino chip. The bonus chips can not be exchanged for cash and must be played on the gaming table. Once the bonus chip has been placed as a wager the following applies:

- If the wager wins, the player will receive live chips for his/her bet from the player-dealer. The player retains the bonus chip and can reuse the bonus chips on another wager.
- If the player pushes, the bonus chips will remain with the player until the hand loses.
- If the bet loses, the bonus chips are given to the player-dealer. The losing bonus chips are verified by the casino's Floor Service Representative and redeemed at the cage by the casino cage staff members for the player-dealer. The casino's Floor Service Representative will exchange the Bonus Chips with live casino chips for the player-dealer.
- Players may wager the Bonus Chips on Bonus Bets.
- Bonus chips shall not be used to pay collections.

### **Eligibility**

The Bonus Chip Promotion will be open to players who buy into a pre-determined game and who will receive a specific amount of Bonus Chips.

- Players shall not exchange Bonus Chips for live chips.
- The Bonus Chips are non-transferable between players.
- The Players can take home the Bonus Chips and use them at a later date.
- The Bonus chips do not expire.
- The Bonus Chips have no cash value and can not be redeemed for cash at anytime.
- There is no minimum or maximum number of players required to play in order to be eligible for the promotion.
- The bonus chips shall only be redeemed by the player-dealer after having been played and verified by the Casino's Floor Service Representative.
- Casino Employees off duty and out of uniform are eligible for the promotion.
- Third Party Provider or Proposition Player Services, TPPPPS, are not eligible to participate in the promotion.
- Tournaments games are not eligible to participate in the promotion.

### **Prize Amount**

The prize will be a fixed amount ranging from \$10 to \$10,000 in the form of bonus chips.

### **Funding**

The Bonus Chip Promotion will be fully funded by the 101 Casino. There will be no additional fees or collections taken for this gaming activity.

### **Administrative Fee**

There will be no administrative fee(s) collected by the 101 Casino for this promotion.

## **Bonus Chip Promotion**

### **No Purchase Necessary**

The Bonus Chip Promotion does not contain the element of chance. Therefore, it does not constitute an illegal lottery and does not require No Purchase Necessary tables to be offered while conducting this gaming activity.

# California Games Jackpot

## **Bureau Requirements**

### **Advertising**

The Parkwest Casino Sonoma may advertise various names for this gaming activity. Should Parkwest Casino Sonoma advertise a different name, the BGC ID (GEGA-004607) shall be referenced on all advertisements relating to the California Games Jackpot.

Furthermore, all rules and procedures for this gaming activity, including but not limited to the following, shall be prominently displayed in Parkwest Casino Sonoma at all times this gaming activity is being offered for play:

- Eligible games and time periods.
- Qualifying hands and corresponding prizes.
- Amount of jackpot fee.
- The prize amount that shall be awarded and how it shall be distributed between all eligible players.
- No Purchase Necessary opportunity.
- Any other restrictions that apply to this gaming activity.

### **Rules of Play**

The California Games Jackpot gaming activity features a fixed and progressive jackpot prize. A prize is awarded to players, who have paid the \$1 jackpot fee, in any designated California game, when the player-dealer has been dealt a qualifying hand. After the hand has been confirmed, those players who paid the jackpot fee shall receive the posted prize from the progressive jackpot.

### **Qualifying Hands and Prize Payout**

When the player-dealer makes one of the following advertised qualifying hands during the play of an eligible California game, all players who paid the jackpot fee shall be eligible to win their share of the posted California Games Jackpot progressive prize amount, as shown below. The payout shall be split evenly for the posted progressive amount among the players who placed a jackpot bet and the posted fixed amount will be given to each player who placed a jackpot bet. Only the following hands that have been Bureau approved, pre-determined, and designated by the Casino are eligible. The qualifying hands within the chart below must be offered together at all times.

*Example: Prior to the play of the hand, five players placed a jackpot wager. The jackpot hand was made by the player-dealer and the posted prize is \$42,000. Each of the five players would then receive \$8,400.*

### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at an above listed controlled game during the pre-determined and specified hours designated and posted for the gaming activity.

- When a qualifying hand is announced, a floor person shall verify that the hand qualifies. Any deviation from a standard deck will nullify the jackpot.
- There is no minimum or maximum number of players required to be dealt in during an eligible game in order for players to be eligible and the tables to qualify for the California Games Jackpots prize amount.
- Players are eligible to win this promotion more than once.
- Only off duty, out of uniform, Casino employees shall be eligible to participate in the California Games Jackpots promotion.
- Third Party Provider of Proposition Player Services, on and off duty, shall not be eligible to participate in the CA Games Jackpots promotion.
- Patrons playing in tournament games are not eligible to participate in the promotion.

### **Prize**

The jackpot prize is fixed and progressive with a minimum value of \$500 and a maximum of \$500,000. The jackpot prize shall be paid in the form of cash, casino chips, merchandise, trips, poker tournament entries, electronics, or other prizes. The actual progressive jackpot prize amount shall depend on the amount the jackpot was originally seeded at, as well as how much time was accumulated in order for the jackpot to increase progressively each day.

### **Funding**

The California Games Jackpot gaming activity utilizes one Jackpot account which shall be funded by a \$1 jackpot collection which shall be dropped in a separate drop box marked as "Jackpot." The prize pool shall be initially seeded at a minimum of \$5,000 by Parkwest Casino Sonoma. Parkwest Casino Sonoma will not be reimbursed the seed amount. When the \$1 jackpot collection has been taken, a portion of the fee will go to the main jackpot account and the rest shall be placed in the reserve account. The prize pool shall be initially seeded at a minimum of \$5,000 by Parkwest Casino Sonoma. The jackpot has a \$500,000 cap. Once the jackpot reaches the cap amount, all other jackpot collection fees collected shall be placed in the jackpot reserve account. All fixed prizes will be taken from the reserve account. The prize pool will be increased daily at predetermined and designated times with an amount ranging from \$5 to \$10,000 based on the amount collected. When a qualifying jackpot hand is made, it will be re-seeded by the reserve account with an amount ranging from \$5,000 to \$50,000. The Parkwest Casino Sonoma shall cover any shortfall and shall be refunded by the reserve.

## California Games Jackpot

### **Administrative Fees**

The Parkwest Casino Sonoma shall retain an administrative fee of \$5-\$10 per table per hour from all approved California games. This fee will be used to cover security to pull and count the boxes, accounting, equipment, surveillance, and the cost of the gambling establishment personnel that administer the jackpot.

### **No Purchase Necessary**

The California Game Jackpots Promotion gaming activity shall be offered for free, on a general and indiscriminate basis, with no restrictions, to patrons who wish to participate in a No Purchase Necessary (NPN) game. The Parkwest Casino Sonoma shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. Within a reasonable amount of time of a No Purchase Necessary player requesting to play one of the specific games within the gaming activity, a No Purchase Necessary table will be made available. The casino dealer will deal a hand to the No Purchase Necessary player and to all other seated positions, including what would be the player-dealer position. The casino dealer will play/monitor all of the hands dealt except for the No Purchase Necessary player's. If the player-dealer makes one of the qualifying hand(s), listed above, they will be awarded that associated prize or their portion thereof. There shall be no time restriction placed on the No Purchase Necessary player regarding the number of hands dealt. There shall be no live wagering or cash/casino chips used at this table. All advertisement material shall state "No Purchase Necessary" when referencing the California Games Jackpots gaming activity. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

Furthermore, all rules and procedures for California Games Tournaments, including but not limited to the following, shall be prominently displayed in the 101 Casino at all times that a California Games Tournament is offered for play:

- How a player may enter the tournament.
- The game(s) that will be offered during the play of the tournament.
- The fees that will be charged for entering the tournament, including a description for each fee charged and whether it shall be retained by the 101 Casino, added directly into the tournament prize pool, or any other method of retention or distribution.

#### **Object and Summary**

The Cash and Prize Drawing Promotion is house funded and awards players with 1-20 drawing tickets for achieving a designated qualifying hand or for playing in designated games for a predetermined amount of time. Players shall have their time tracked via the Customer Incentive Program (GEGA-004494). The drawing tickets allow players to win predetermined and posted prizes during a drawing to be held at a later time.

#### **Bonus Tickets**

During predetermined and posted time periods, the Casino may award players who achieve a qualifying hand or meet the minimum amount of time played with an additional 1-20 “bonus” tickets. Players will be given ample notice of time periods and controlled games that are eligible for bonus tickets.

## **Bureau Requirements**

### **Advertising**

The 101 Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEGA-004494) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for this gaming activity, including but not limited to the following, shall be prominently displayed in The 101 Casino at all times the gaming activity is being offered:

- Corresponding time played and points earned or awarded.
- The date(s) and time(s) the gaming activity shall be offered.
- The number of points earned corresponding to the prize amount.
- The time frame in which the points earned are valid.
- The possible prize(s) offered for meeting the requirements of the gaming activity.
- When the bonus prize(s) will be offered throughout the promotion.
- Availability of No Purchase Necessary.
- Any other applicable restrictions.

### **Eligible Controlled Games**

The Customer Incentive Program shall be attached to all Bureau approved California and Poker controlled games offered at The 101 Casino at all times this gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

### **Rules of Play**

The Customer Incentive Program features a promotional element attached to the games listed above. This gaming activity is a loyalty reward program open to all 101 Casino patrons. This promotion will reward players with points based on time of play at designated table games during pre-determined and eligible periods ranging from 10 minutes to 90 days.

### **Player's Card and Computer System Description**

The Player's Card shall include the Casino name on the card, some descriptive language regarding restrictions for the card, and the problem gambling phone number. It shall also include a bar-code. This card will look different from the card used for the Player Loyalty Rewards Program (GEGA-003084).

- The card shall be non-transferable and can only be used by the player who the card is assigned.
- If a player's card has been lost or stolen, they can ask a Floor Service Representative for a new one at no cost to the player.
- Player information shall be maintained in a secure database accessed only by casino management. Access to the database shall also be tracked by casino management.
- Player's time played is tracked by having their card scanned. They will receive a player's card once they sign up for the Customer Incentive Program at the cashier. An iTouch, iPad, or similar tablet computer device, with a bar code reader, will be affixed to the gaming table and a gambling establishment employee will scan the player's card. The gambling establishment employee will then input the player's average wager and time played into the computer tablet device.

## Customer Incentive Program

- Player information shall be maintained in a secure database accessed only by casino management. Access to the database shall also be tracked by casino management. No one except the network administrator(s) has access to the back-end systems where the data is stored. Access to the data is by user level with multiple levels based on what the user will be doing. Marketing managers will have access to customer data for marketing purposes (i.e., emails, texts, mass mailing, etc.)
- A printable record of the amount of time a player has accumulated during the period of time that the gaming activity is being offered, shall be available at anytime at their request.

### **How Player Rewards Points are Earned Based on Time Played**

Points shall be earned based on the amount of time played. Each player that plays a certain table game during live play will, at certain times, receive points, which will gain them eligibility to win pre-determined and designated prizes. The range of points will be 1 to 200,000 points for each hour of play. The 101 Casino may offer bonus rates (for example, double points) on play during off-peak hours or in specific games, within the range as shown above. Patrons will be given ample notice of how many points will be awarded, as well as, the amount of time required to earn points for each eligible game.

Example: A player signs up for the Customer Incentive Program at the cashier and receives a player's card. The player presents the card to the gambling establishment employee at the gaming table. The gambling establishment employee scans the player's card using a bar code reader on the computer tablet device and will then input the average wager per hand of the player in fifteen minute increments. At the end of the gaming session, the player will be logged out by the gambling establishment employee. The program tabulates the amount of points the player has earned and records it in the player's account. The player may check their point balance and redeem points with a gambling establishment employee at any time during the promotion.

### **How Player Rewards Points are Redeemed**

Players may either redeem their points at any time during the promotion or at the end of the promotional period. The redemption period will be displayed in The 101 Casino to give players ample notice. Points not redeemed by the end of the promotional period will expire within 30 days of the promotional period. All prizes shall have a pre-determined and designated value. The point to dollars ratio for the rewards program is 1 point is worth \$0.10 - \$100. After a player has accumulated a pre-determined and specific amount of points, based on time of play, a player may redeem the accrued points for a pre-determined and designated prize.

- After a player has been awarded a prize, they may also be eligible for second and subsequent prize(s) until the end of the promotion.
- Players may redeem their points for multiple prizes as long as the total amount of points required for the prizes are within the player's point balance.
- Once the points are redeemed, these points will be subtracted from their point balance.
- Upon request, a player may check their point balance with a Casino Floor Services Representative at any time during the promotion.
- Points are non-transferrable, and can only be used by the player who earned them.

The bonus prize will range from \$1 - \$100,000. In all instances, the actual prize(s) that players are eligible to redeem their points for shall be pre-determined and conspicuously posted in The 101 Casino at all times that this gaming activity is being offered.

### **Eligibility**

This gaming activity shall be open to all players 21 years of age and older with valid I.D. who sign up for a Player Reward Card and participate in an eligible game for a designated period of time to earn points. When the player chooses to exchange their accrued points, they shall win a corresponding prize.

The 101 Casino shall not retain an administrative fee for operating the Customer Incentive Program gaming activity.

### **No Purchase Necessary**

The Customer Incentive Program does not contain the element of chance. Therefore, it does not constitute an illegal lottery and does not require No Purchase Necessary tables to be offered while conducting this gaming activity.

### **Advertising Requirements:**

The 101 Casino may advertise various names for this program. Should the Casino advertise a different name, the BGC ID (GEGA-004107) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for this gaming activity, including but not limited to the following, shall be displayed conspicuously and prominently in The 101 Casino at all times the gaming activity is being offered:

- The date(s) and time(s) the gaming activity shall be offered.
- The prize(s) offered for meeting the requirements of the gaming activity.
- Time required to earn food.
- How time will be tracked.
- Procedures for players having their card stamped.
- Any other applicable restrictions.

### **Summary:**

Based on customer demand and industry trends, The 101 Casino proposes to add a gaming activity for all currently approved controlled games. The promotion will allow a player to eat for free/or at a substantially discounted rate from a selected menu when they play for a qualifying period of time, which is tracked through their Player Rewards Card or on a log if they do not have a players' rewards card. In all instances, patrons shall be provided with ample advance notice of the amount of time that a player must play in order to be eligible for the "Player's Menu." Furthermore, the time requirements and "Player's Menu" shall be displayed prominently within The 101 Casino at all times this gaming activity is being offered for play.

### **Controlled Game:**

The Food Reward Program shall be associated with all currently approved BGC games offered at The 101 Casino.

### **Prize:**

The prize will be allowing a player to eat a menu item for free/or at a substantially discounted rate from a selected "Player's Menu." For players that complete the time requirement, certain items on the "Player's Menu" with a value of \$1 - \$25 will be offered for free.

### **Funding:**

This promotion will be solely funded by the 101 Casino. There will be no extra collection or fees of any kind assessed to the players.

### **Eligibility to Win:**

All players who wish to participate will be tracked by a casino employee. Once a player has played a pre-designated and posted time period ranging from 10 minutes to 4 hours, their time will be verified and then they will be awarded by eating for free/or at a substantially discounted rate from the "Player's Menu." The 101 Casino, upon the Bureau's review and approval, plan on running an additional high hand promotion with the parameters/rules listed below:

#### High Hand Progressive Promotion

- The promotion can run anytime (as long as its posted and pre-determined)
- The qualifiers will be Full House and Four of a Kind (again any hand as long as it is pre-determined and posted)
- The 101 will seed the promotion at \$100, and progress by \$100 each day during promotional period until cap of \$1000 is reached
- The high hand will be verified and added to a posted board notifying all customers of the winner. Winner need not be present to win. The player will have the winning amount in an envelope held at the cage. If the winner doesn't collect his/her prize/money within 60 days, they will forfeit the prize amount. This amount will be added to the next promo period.
- If there is no qualifying hand made during promo period, the current promo amount will be added to the next promo period.
- Both hole cards must be used. No minimum or maximum number of players needed to be eligible.



Hold'em Bargain Bonus
2. Name each controlled game that is associated with this gaming activity:  
This bargain is attached to \$3/\$6, Limit Texas Hold'em
3. Describe any jackpot or any other type of prize awarded:  
This bargain is for weekday and weekend morning players. We will give the first nine players or all players seated by 8:30 am a bonus of \$20 in chips if they buy-in for at least \$40 and play for two hours. If a player loses his chips he is released from the two hour play requirement and if he cashes out prior to the two hours and has more chips than he originally purchased, he is required to return the \$20 bargain.
4. If a cash prize is involved, is the amount of the prize progressive (increases) or a fixed amount:  
The amount of the bargain is always \$20.

The bonus is house funded

wager is collected by the player/dealer, and the voucher is voided and collected as well. If the player pushes (receives no action), the voucher may be played again until the player wins or loses a hand.

**“Free Play Chip(s)”**

The Casino will offer free play chips having a face value from \$5.00 to \$500.00 per chip. The chips are used in live games exactly like regular chips, the difference being that they cannot be exchanged for cash.

The free play chips are initially in the form of a coupon which will be offered to all patrons that wish to come into the Casino and use them to play. All played free play chips are verified by a key employee. The free play chip is taken to the cage by a key employee, logged, and exchanged for the value listed on the chip. If the player loses the hand, the free play chip is forfeited and will be collected by the casino dealer and dropped in the drop box for accounting purposes. If the player pushes (receives no action), the chip may be played again until the player wins or loses a hand.

*California Game Example: Prior to the play of the hand, five players placed a jackpot wager. The jackpot hand was made by the player-dealer, and the posted prize is \$42,000. Each of the five players would then receive \$8,400.*

*Poker Game Example: Prior to the play of the hand, eight players placed a jackpot wager. A royal flush jackpot hand is made with the five community cards, and the posted prize is \$40,000. Each of the eight players would then receive \$5,000.*

### **Eligibility Requirements (Common to California and Poker Games)**

This gaming activity shall be open to all players who are seated and playing at an above listed controlled game during the pre-determined and specified hours designated and posted for the gaming activity and have paid the \$1 jackpot fee. 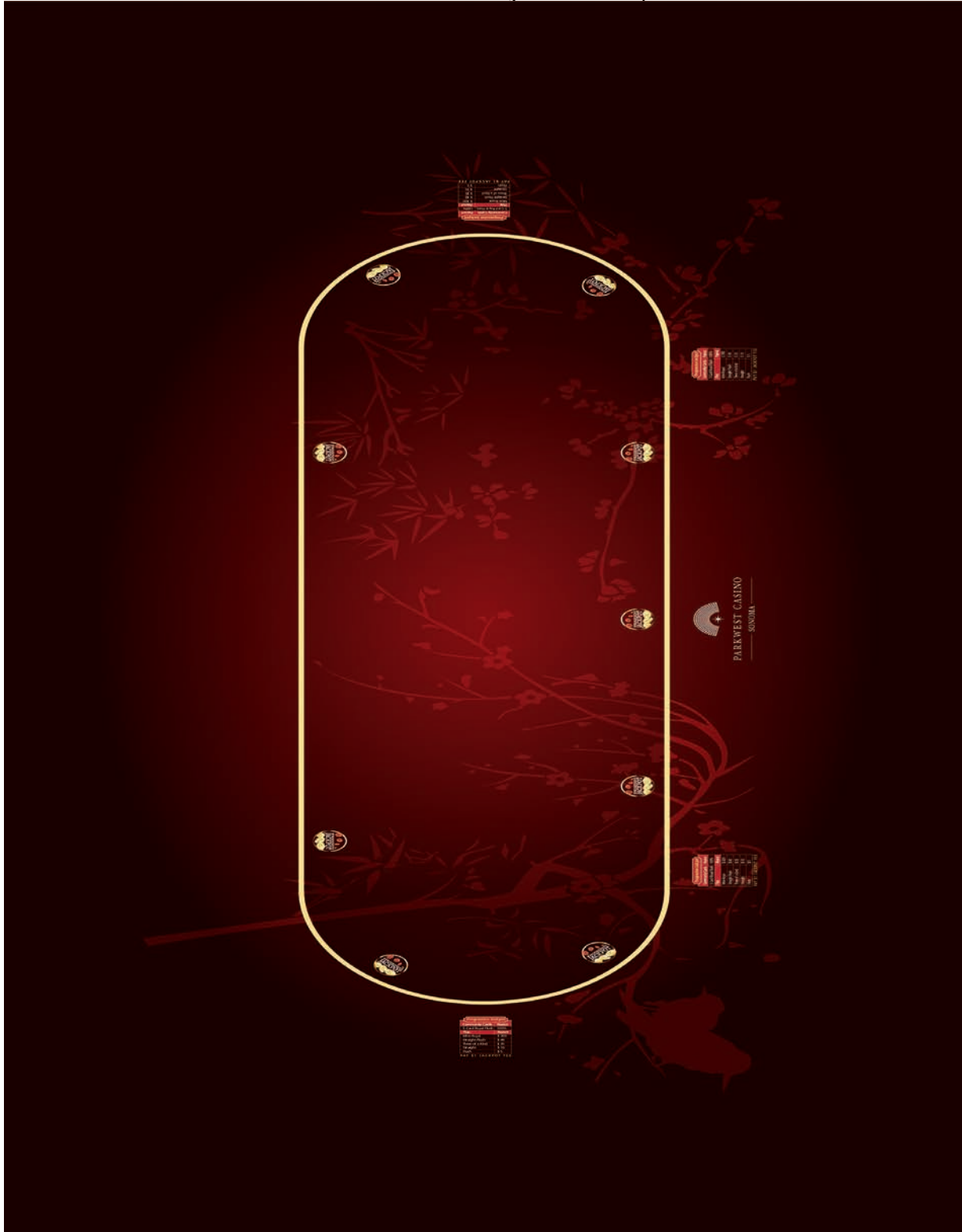

Additionally, a posted percentage of the jackpot prize, known as the table share, shall be evenly distributed amongst all other players at the qualifying table who have participated in the designated game, as shown below.

### **Qualifying Hands**

Players that make the following advertised hands shall be eligible to win their share of the Omaha Bad Beat Jackpot prize amount, as shown below. Only a winning and losing hand that has been Bureau approved and pre-determined and designated by the Parkwest Casino Sonoma is eligible. In order to qualify for the jackpot, both the winning and losing hands must use two hole cards and three board cards. Once the jackpot has been hit, the Parkwest Casino Sonoma may choose another qualifying hand from the options, as provided below. ### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at an above listed game during the pre-determined and specified hours designated and posted for the gaming activity.

- \$ In order to qualify for the jackpot, both the winning and losing hands must use two hole cards and three board cards.
- \$ A minimum of four players must be dealt into the game in order for the table to qualify for the jackpot.
- \$ Players with qualifying winning and losing hands must play through the final betting round, after the river, in order to qualify for the jackpot. If a player with one of the qualifying hands folds prior to the final betting round and the showdown, the table shall be in-eligible for the jackpot.
- \$ In the event that during a round of play, two or more players have qualifying losing or winning hands, only the players with the highest qualifying losing and winning poker hand shall receive the posted prize percentage of the jackpot for the losing and winning hands. The remaining players, which do not include players that received a qualifying losing or winning hand, shall receive the posted prize percentage of the table share.
- \$ When a qualifying hand is announced, a floor person shall verify that the hand qualifies. Any deviation from a standard deck shall nullify the hand.
- \$ Casino Employees are eligible to participate while off duty and out of uniform.
- \$ Third Party Proposition Players, on or off duty, shall not be eligible to participate in this promotion.
- \$ Tournament games are not eligible for this promotion.

### **Prize**

The jackpot prize amount shall range in value from \$100 to \$500,000. All jackpots shall be paid in the form of cash. The actual prize amount shall depend on the amount the jackpot was originally seeded at as well as, how much time has accumulated in order for the progressive jackpot prize pool to increase progressively each day by the number of jackpot collections fees collected each day.

### **Prize Payout Structure**

Players that make the qualifying winning and losing hands, as pre-determined and designated by the Parkwest Casino Sonoma and approved by the Bureau, as shown above, shall be eligible to win their share of the Omaha Bad Beat Jackpot prize amount, based on the payout table shown below.

### **Funding**

The Omaha Bad Beat Jackpot utilizes a progressive prize pool which shall be funded by the Parkwest Casino Sonoma. The Parkwest Casino Sonoma shall initially seed the jackpot prize pool with an amount ranging from \$1 - \$1000. The jackpot prize pool shall increase in an amount ranging from \$1 - \$100 until the jackpot cap of \$101,000 has been reached. The jackpot will increase at 8:00 a.m. on the day following an Omaha game. When a qualifying jackpot hand is made, it shall be re-seeded by the Parkwest Casino Sonoma with an amount ranging from \$1 - \$1000. Under no circumstances will the cap be decreased once it has been set and posted. The cap shall remain the same until the jackpot has been won. Additionally, if the jackpot reaches the cap amount, the casino will stop placing money into the jackpot account. There shall not be a reserve account for this jackpot.

### **Administrative Fees**

The Parkwest Casino Sonoma shall not retain any additional fees as this jackpot is house-funded.

### **No Purchase Necessary**

A no purchase necessary (NPN) option is available to any person who requests it. Any person wishing to participate without a purchase or live chips will have the same opportunity to play for the Promotional Prize as the player participating in the live game. All requests for a NPN table will be honored within 15 minutes of such request. The dealer will deal to the NPN player and then to empty spots on the rest of the table to simulate a full game; offering the NPN participant the optimal opportunity to qualify for the gaming activity. Advertisements will advise all patrons that there is a general and indiscriminate opportunity to participate in an NPN game to qualify for the Promotional prize.

Seven cards the highest of which is a 10, with no straights, flushes, pairs or aces): **\$100.**
4. The prizes are cash and they are not progressive but fixed
5. The bonuses are house funded.
6. There are no special fees or collections attached to these bonuses.
7. The Casino will fund all bonus hand payouts. Winning players will be paid upon floor verification of the bonus hands.
8. The bonuses will be immediately reseeded upon payment of the qualifying hand.
9. A minimum of one (1) player needs to be at the table for the bonuses to be active.
10. The house does not retain any fees for the operation of this promotion/bonus.
11. As with all bonus opportunities our No Purchase Necessary Policy would be in effect allowing patrons the opportunity to participate in this activity without placing a live wager or paying any table fees.
12. Promotional literature is attached.
13. No other person or entity other than those licensed as the house is involved in this gaming activity.
14. This bonus is offered for Pai Gow, Double Hand Poker, and the game is played on either a standard pai gow table or a "bat-wing" table. The house supplies a dealer.

- (1) The specific bonuses outlined below are to be paid if the Player's hand achieves any of the following hard to hit sequences, with the associated payout for each occurrence.

### General Rules for Bonuses and Demonstration Table

- (1) There is no extra collection for these bonuses. These bonuses will be funded by the casino.
- (2) The bonuses will be immediately reseeded upon payment of the qualifying hand.
- (3) If there is more than one player wagering on the seat which received a hand that qualified for the bonus, the bonus will be divided evenly between all players with wagers on that seat.
- (4) If more than one seat receives a qualifying hand on the same round of play, each qualifying hand will receive the full amount of the bonus that is designated for that qualifying hand.
- (5) These bonuses will be available to all customers, whether or not they are actively playing Pai Gow, Double Hand Poker games.

- If there are more patrons wanting to play at the "Demonstration" table than the normal seats available, a "waiting list" will be established as in any other casino game.

(9) The 101 Casino will follow the regular game procedure for no purchase necessary tables. The player-banker button will rotate around the table after every second hand. Players have the opportunity to decline to act as player-banker. To the extent that a house dealer is playing the hand for a vacant seat, she will accept the opportunity to act as player-banker and will play all hands House Way (basic strategy as posted for Pai Gow).

(10) The 101 Casino will do everything possible to make a no purchase necessary table available to patrons within fifteen minutes of a request. If no other patrons are available to participate in a no purchase necessary table within fifteen minutes of a request, The 101 Casino will provide a table where the no purchase necessary player will play only one hand and the casino dealer will play the remaining hands according to House Way (basic strategy for 21<sup>st</sup> Century Blackjack).

The promotion will award players who play a predetermined amount of time at The 101 Casino in a particular game.

#### **PRIZE**

This promotion will reward players with points based on the amount of time played at designated table games during pre-determined and posted eligible periods or based on pre-determined and posted designated qualifying hands. Players that make any of the following pre-determined and posted hands will be awarded points. Please see attached chart of qualifying hands. The range of points will be from one (1) to one hundred (100) points per hour of play.

The casino may offer pre-determined and posted bonus earn rates, schedules (double, triple, etc.) on play during off-peak hours or in specific games, within the range, as shown above.

Players will be given ample notice of how many points will be awarded, as well as the amount of time required to earn points of which pre-determined and posted qualifying hands will be eligible to earn points for each eligible game.

## **Bureau Requirements**

### **Advertising**

The Parkwest Casino Sonoma may advertise various names for this gaming activity. Should Parkwest Casino Sonoma advertise a different name, the BGC ID (GEGA-004605) shall be referenced on all advertisements relating to the Poker Games Jackpot.

Furthermore, all rules and procedures for this gaming activity, including but not limited to the following, shall be prominently displayed in Parkwest Casino Sonoma at all times this gaming activity is being offered for play:

- Eligible games and time periods.
- Qualifying hands and corresponding prizes.
- Jackpot fee required.
- The prize amount that shall be awarded and how it shall be distributed between all eligible players.
- Any No Purchase Necessary opportunity.
- Any other restrictions that apply to this gaming activity.

### **Eligible Controlled Games**

The Poker Games Jackpot gaming activity shall be attached to the following Bureau approved controlled games offered at the Parkwest Casino Sonoma, as shown below, at all times that this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

### **Object and Summary**

The Poker Games Jackpot gaming activity features a fixed and progressive jackpot prize. A prize is awarded to all players, who are playing at a predetermined and posted Poker table, and paid the \$1 jackpot fee. At the final round of play, if the community cards make a qualifying hand, as shown in the chart below, all players who were dealt in at the beginning of that round of play and paid the \$1 jackpot fee shall receive the posted prize.

### **Qualifying Hands**

When a qualifying hand is made in an eligible poker game, all players who paid the \$1 jackpot fee shall be eligible to win their share of the posted Poker Games Jackpot progressive prize amount, as shown below. The payout shall be split evenly for the posted progressive amount among the players who were dealt into the hand and the posted fixed amount will be given to each eligible player. Only the following hands that have been Bureau approved, pre-determined, and designated by the Casino are eligible. The qualifying hands within the chart below must be offered together at all times.

*Example: At the beginning of a round of play, five players are dealt into a poker game where each player paid the \$1 jackpot fee. The qualifying community cards were dealt and the posted prize is \$42,000. Each of the five players would then receive \$8,400.*

### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at an above listed controlled game during the pre-determined and specified hours designated and posted for the gaming activity.

- When a qualifying hand is announced, a floor person shall verify that the hand qualifies. Any deviation from a standard deck will nullify the jackpot.
- There is no minimum or maximum number of players required to be dealt in during an eligible game in order for players to be eligible and the tables to qualify for the Poker Games Jackpots prize amount.
- Players are eligible to win this gaming activity more than once.
- Only off duty, out of uniform, Casino employees shall be eligible to participate in the Poker Games Jackpots gaming activity.
- Third Party Provider of Proposition Player Services, on and off duty, shall not be eligible to participate in the CA Games Jackpots gaming activity.
- Tournament Games are not eligible to participate in the gaming activity.

### **Prize**

The jackpot prize is fixed and progressive with a minimum value of \$5 and a maximum of \$500,000. The jackpot prize shall be paid in the form of cash, casino chips, merchandise, trips, poker tournament entries, electronics, or other prizes. The actual progressive jackpot prize amount shall depend on the amount the jackpot was originally seeded at, as well as how much time was accumulated in order for the jackpot to increase progressively each day.

### **Funding**

The Poker Games Jackpot gaming activity utilizes one jackpot account which shall be funded by a \$1 jackpot collection fee that is dropped in a separate drop box marked as "Jackpot." The prize pool shall be initially seeded at a minimum of \$5,000 by Parkwest Casino Sonoma. Parkwest Casino Sonoma will not be reimbursed the seed amount. When the \$1 jackpot collection has been taken, a portion of the fee will go to the main jackpot account and the rest shall be placed in the reserve account. The jackpot has a \$500,000 cap. Once the jackpot reaches the cap amount, all other jackpot collection fees collected shall be placed in the jackpot reserve account. All fixed prizes will be taken from the reserve account. The prize pool will be increased daily at predetermined and designated times with an amount ranging from \$5 to \$10,000 based on the amount collected. When a qualifying jackpot hand is made, it will be re-seeded by the reserve account with an amount ranging from \$5,000 to \$50,000. The Parkwest Casino Sonoma shall cover any shortfall and shall be refunded by the reserve.



## **Poker Games Jackpot**

### **Administrative Fees**

The Parkwest Casino Sonoma shall retain an administrative fee of \$5-\$10 per table per hour from the poker tables where the jackpot is offered. This fee will be used to cover security to pull and count the boxes, accounting, equipment, surveillance, and the cost of the gambling establishment personnel that administer the jackpot.

### **No Purchase Necessary**

The Poker Games Jackpot Promotion gaming activity shall be offered for free, on a general and indiscriminate basis, with no restrictions, to patrons who wish to participate in a No Purchase Necessary (NPN) game. The Parkwest Casino Sonoma shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. Within a reasonable amount of time of a No Purchase Necessary player requesting to play one of the specific games within the gaming activity, a No Purchase Necessary table will be made available. The casino dealer will deal a hand to the No Purchase Necessary player and to all other seated positions. The casino dealer will play/monitor all of the hands dealt except for the No Purchase Necessary player's. If one of the qualifying hand(s) is dealt in the community, as listed above, the player will be awarded that associated prize or their portion thereof. There shall be no time restriction placed on the No Purchase Necessary player regarding the number of hands dealt. There shall be no live wagering or cash/casino chips used at this table. All advertisement material shall state "No Purchase Necessary" when referencing the Poker Games Jackpots gaming activity. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

## The 101 Casino Tournament Rules

1. The Tournament Director is to consider the best interest of the game and fairness as the top priority in the decision-making process. Unusual circumstances can, on occasion, dictate that the technical interpretation of the rules be ignored in the interest of fairness. The Tournament Director's decision is final.
2. **Chip Race Rule:** When it is time to color-up chips, they will be races off with a maximum of one chip going to any player. The chip race will always start in the No.1 seat. A player cannot be raced out of a tournament. In the event that a player has only one chip left, the regular race procedure will take place. If that player loses the race, he/she will be given one chip of the smallest denomination still in play. After the chips have been converted to a higher denomination, any odd chips will receive one card face up for each remaining chip. Each player will receive all of his or her designated cards at the same time. High cards are determined by suit.
3. **Odd Chips:** The odd chip(s) will go to the high hand. In flop games, when there are two or more high hands or two or more low hands, the odd chip(s) will go to the left of the button. In stud-type games, the odd chip will go to the high card by suit. There will be an exception to this rule: an attempt will be made in identical hand situations to split the pot as evenly as possible. Example: a wheel in Omah/8.
4. **Side Pots:** Each side pot will be split as a separate pot. They will not be mixed together before they are split.
5. **Calling for the Clock Procedures:** Once a reasonable amount of time has passed and a clock is called for, a player will be given one minute to make a decision. If action has not been taken by the time the minute is over, there will be a 10-second countdown. If a player has not acted on his or her hand by that time the countdown is over, the hand will be dead.
6. **Dead Button:** Tournament play will use a dead button. When it comes necessary to adjust the placement of the button and blinds because of a player elimination, a player cannot miss the big blind. Because of this, the button may remain in the same position for more than one hand.
7. **Penalties:** A penalty **MAY** be invoked if a player exposes any card with action pending, if a card(s) goes off the table, if soft-play occurs, or similar incidents take place. Penalties **WILL** be invoked in cases of abuse, disruptive behavior, or similar incidents.
8. A player must be at the table by the time all players have complete hands in order to have his or her hand live. Players must be at the table to call time.
9. All cards will be turned face up once a player is all in and all action is complete.
10. If a player crosses the line with chips in their hand- all those chips play (unless a verbal declaration has been made), 'THIS IS DEALER ENFORCED'.
11. In limit games, an oversized chip will be constituted to be a call if the player does not announce a raise. In No-Limit, an oversized chip before the flop is a call; after the flop, an oversized chip by the initial better put in the pot will constitute the size of the bet. In pot-limit and no-limit, if a player states the raise and throws

an oversized chip, the raise will be the maximum amount allowable up to the size of the chip.

12. The one-player-to-a-hand rule will be enforced.
13. Tournament and satellite seats will be randomly assigned.
14. The English-only rule will be enforced during the play of hands.
15. A player who wants to use a cellular phone must step away from the table. The 101 Casino requests that all cell phones be turned off or put on vibrate while in the club.
16. There will be no foreign chips on the table except for a maximum of one card cap.
17. When time has elapsed in a round and a new round is announced, the new limits apply to the next hand. A hand has begun when dealer pushes green button.
18. A player may not miss a hand. If a player announces the intent to re-buy before the first card is dealt, that player is playing behind and is obligated to make the re-buy.
19. Players must keep their highest denomination chips visible at all times.
20. Verbal declarations as to the content of a player's hand are not binding; however at management's discretion, any player deliberately miscalling his hand may be penalized.
21. No rabbit hunting is allowed, i.e. a player cannot ask to see the next card in the deck after action had been completed.
22. All chips must be visibly played at all times. Players may not have tournament chips in their pockets at any time. A player who has chips in their pocket will forfeit the chips. The forfeited chips will be taken out of play for the tournament.
23. Moving players: In flop games, players will be moved to the same position or as close as possible.
24. If a dealer kills an unprotected hand, the player will have no redress and will not be entitled to his money back. An exception would be if a player raised and his or her raise had not been called yet, he or she would be entitled to receive their money back.
25. Dealers cannot kill a winning hand that was turned face up and was obviously the winning hand.
26. Verbal declarations in turn are binding. Action out of turn may be binding. At The 101 Casino, acting out of turn during tournaments will follow the same rules as in the ring games.
27. Management reserves the right to cancel or alter any event at its sole discretion in the best interest of the casino or its players.
28. Players going from a broken table to fill in seats assume the rights and responsibilities of the seat. They can get the big blind, the small blind, or the button. The only place they cannot get a hand is between the small blind and the button. A player moved to balance tables will take the worst position. A dead button situation may occur.
29. There is no more ½ bet raise rule in No-Limit Tournaments.
30. Players, whether in the hand or not, may not discuss the hands until the action is complete. Players are obligated to protect the other players in the tournament at all times. Discussing cards discarded or hand possibilities are not allowed. A penalty may be given for discussion of hands during the play.

31. A player who exposes his cards during the play may incur a penalty, but will not have his or her hand killed.
32. In NL or PL, when raising a player *must* either put the amount of the raise out in one motion or state your raise amount. By stating the word raise, a player protects their right to raise, but the raise must be made in one additional motion unless he states the amount. If you make a forward motion of your hand containing chips, those chips are in play. The Half Bet rule still applies relative to a raise. If the excess chips are less than half a minimum raise, then the excess chips are not in play. If the excess chips are one half or more of the minimum raise, then the raise must be completed.
33. In No-Limit and Pot-Limit, less than a full raise does not reopen the betting to a player who already has acted.
34. Players must act in turn at all times. Action out of turn may or may not be binding. If a player acts out of turn and the action does not change, when it comes to the player who acted out of turn, the player's action is binding. Action changes only if a player makes an initial bet or raise before it gets to the player who acted out of turn. Action does not change when the player in front of a player acting out of turn checks, calls or folds. If a player acts out of turn and the action changes, the player who acted out of turn may change their action, by calling, raising or folding and having their chips returned to them. A player may not intentionally act out of turn to influence play before them.

#### **Addendum and No-Limit Rules**

1. When two (2) players are left, the small blind is on the button.
2. In No-Limit, to qualify as a raise must be at least the size of the original bet or the largest previous raise of that betting round.
  - Before the flop, a raise has to be at least twice the size of the big blind.
  - After the flop, a player may bring in for any amount equal to or greater than the big blind.
3. In No-Limit there is not limitation on the number of raises.
4. In No-Limit, the minimum bet after the flop has to be the size of the big blind.

#### **Tournament Procedures (The 101 Casino)**

1. Games will be broken using the seating cards.
  - Tournament Director will utilize the seating cards from vacant seats to fill open seats and break tables.
  - When a seat opens, that seating card should be separated to indicate the open seat.
  - Once enough seats are open at the remaining tables to break a game, the associated seating cards will be shuffled and drawn face down among the tables on the break table. Those players must then go to the seat indicated on the card they have drawn.

- Prior position, such as just having had the big blind has no bearing upon that player's seat at the next table. They are obligated to go to the seat and table corresponding to the drawn card, and may not miss any blinds.
2. The table maximum will be ten players.
  3. A "running clock" will be used while seating players at new tables and with limit changes.
  4. **Dead Button:** When it becomes necessary to adjust the placement of the button and blinds because of player elimination, a player cannot miss the big blind. Because of this, the button may remain in the same position for more than one hand.  
The "dead button" eliminates having two big blinds etc, if one of the blinds is eliminated.

#### **Scenarios:**

1. If the big blind is eliminated on the first hand, the second hand will contain a big blind and a button. There is not small blind on the second hand. On the subsequent third hand, the button will be moved to the open seat, with a small and big blind and a "dead" button. The "dead" button is not dealt a hand.
2. If the small blind is eliminated on the first hand, the button will be moved to that open seat on the second hand, and there is a small blind and a big blind and a "dead" button.
3. If both the big blind and the small blind are eliminated on the first hand, the button will be "dead" for the two consecutive following hands. In the second hand, there will be a big blind and a "dead" button. On the third hand there will be both blinds and the "dead" button. In the third hand, it is possible for one player to have acted last three hands in a row.
4. Note: If a table is broken, a player may move into the big blind, the small blind or the dealer's position (See rule #28).

- For a Jackpot hand to be valid a minimum of four (4) live players must be dealt in at the start of the hand.
- For a player to be included in the payout of a Jackpot he must be an active player at the table; an active player is defined as a player who does not have a missed blind button. Players with hold buttons will be included as long as they have not been gone over the 15 minute allotted time period.
- The Jackpot will not be valid in any Tournament games.
- Casino employees are eligible to participate in the Jackpot as long as they are playing on off-duty hours.
- All winners must have one of the following forms of valid identification: Current Drivers License; Current I. D. Card; Current Military I.D. or Current Passport.
- All winnings in excess of \$600 will require the completion of IRS form W2G. Winnings in excess of \$5,002 will be subject to 25% IRS withholdings. W2G form requires current, valid I.D. and S.S. Number
- Players must refrain from conversations regarding a possible jackpot while a potential jackpot hand is in progress.

#### Collection for Super Bad Beat Jackpot:

- There will be no collection taken from the players for the Super Bad Beat Jackpot as the Jackpot will be house funded.

#### Casino Administrative Fee:

- The Casino will not charge an administrative fee, as the jackpot will be house funded.

#### Super Bad Beat Jackpot Funding:

- The Jackpot will increase daily at 8:00AM at a range of \$1 to \$500 until the cap is reached.
- The amount of the Jackpot will have a cap of **\$101,000**.
- When the Jackpot is awarded, the Jackpot will reseed at a range of \$10,000 to \$101,000. The jackpot is house funded

#### Qualifying Hand:

- Players that make the following advertised hands will be eligible to win their share of the Super Bad Beat Jackpot.
- Only a winning and losing hand that has been pre-determined and designated by The 101 Casino is eligible.

# **THE 101 CASINO SUPER BAD BEAT JACKPOT General Rules**

**1. Name of the Proposed Gaming Activity.**

Super Bad Beat Jackpot

**2. Name each controlled game that is associated with this gaming activity.**

All approved Texas Hold'em, Limit or No-Limit

**3. Describe any jackpot or any other type of prize awarded.**

The Jackpot will start and be seeded and amount ranging between \$10,000 and \$101,000.

**4. If a cash prize is involved, is the amount of the prize progressive (increases) or a fixed amount?**

The Jackpot is progressive and will have a cap of \$101,000. The Jackpot will increase daily at a range of \$1 to \$500 until the cap is reached. All subsequent monies will go toward the initial funding and/or the backup reserve.

**5. Explain if the gaming activity is house funded or player funded.**

The Jackpot is house funded.

**6. Describe any special fee collection involved in this gaming activity, for example, a jackpot fee collection.**

There will be no administrative fee taken.

**7. Describe how the jackpot will be seeded and how any prizes will be awarded.**

The Jackpot will re-seed at a range of \$10,000 to \$101,000 if the Jackpot is won.

The payout percentages are as follows:

- 45% to the losing hand
- 25% to the winning hand
- 20% split amongst the balance of eligible players at the table
- 10% to all qualified players in approved Hold'em games being played in the casino at the time the jackpot is awarded

Each player that participates in the Jackpot hand will be awarded up to \$2,000 in cash and the balance of their payment in the form of a Casino issued check.

**9. Explain any re-seeding of the fund once the prize is won.**

The Jackpot will re-seed at a range of \$10,000 to \$101,000 if the Jackpot is won. All subsequent Jackpots will cap at \$101,000. The Jackpot will increase daily at a range of \$1 to \$500 until the cap is reached.

**10. Explain any minimum or maximum number of players required to be dealt into the game for the table to be eligible for the gaming activity and prize.**

For a Jackpot hand to be valid a minimum of four (4) live players must be dealt in at the start of the hand.

**11. Explain if the house is retaining any administrative or any other type of fee for operating the gaming activity.**

There will be no administrative fee taken, as the Jackpot is house funded.

**12. Describe any opportunity(s) for a person to play for the prize without placing any live wagers or paying any table fees.**

A person may participate for free in this promotion via our demonstration table. The demonstration table is part of our "No Purchase Necessary" policy.

The jackpot will be offered to customers who wish to participate for free, on a general and indiscriminate basis. The 101 Casino will offer a demonstration table for all customers requesting to participate in the jackpot game without requiring them to pay a table fee or collection of any type. There will not be any live wagering at this table. Participants in the demonstration or "No Purchase Necessary" table will be eligible to win their portion of the bad beat jackpot if they receive the qualifying hand. They will receive the portion of the jackpot they have qualified for and any balance of the jackpot will remain in the jackpot fund.

**13. Provide copies of any published/proposed promotion or advertisement literature.**

Advertisements will be created upon approval of this promotion.

**14. Identify any entity or person other than those licensed as the house involved in the gaming activity.**

The gaming activity involves no other entity other than the house. There is no copyright, patent, or license involved with this activity.

**15. Describe the type of table and equipment utilized for the gaming activity.**

Standard poker tables will be utilized for this activity. A standard 52 card poker deck will also be utilized as well as licensed, professional dealers. Our tables are equipped with Shuffle Master in table shuffling machines.

# Ticket Drawing Promotion

## Bureau Requirements

### **Advertising**

The Parkwest Casino Sonoma may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID listed above shall be referenced on all advertisements relating to this gaming activity. Furthermore, all rules and procedures for this gaming activity, including but not limited to the following, shall be prominently displayed in Parkwest Casino Sonoma at all times that the gaming activity is being offered for play:

- Drawing dates and times.
- Eligible games and time periods.
- Prize Amount.
- Availability of No Purchase Necessary.
- Any other restrictions that apply to this gaming activity.

### **Eligible Controlled Games**

The Ticket Drawing Promotion shall be attached to all Bureau approved games for Parkwest Casino Sonoma. This gaming activity shall be attached to the play of each controlled game while the games are being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

### **Object and Summary**

Players who achieve “qualifying” hands will receive an entry to a tournament or ticket into a drawing. Tickets will be placed in a locked container maintained on the gaming floor and under constant surveillance by security and the casino’s surveillance system. Each ticket shall be filled out with the player’s name, table number, time, and game played, then placed into a barrel or other non-electronic randomizer. The player whose ticket is drawn will be awarded a pre-determined and designated prize

### **Qualifying Hands**

Players that make one of the following advertised qualifying hands shall be eligible to win the posted prize. The qualifying hand(s) within the chart shall be offered together at all times that this gaming activity is being offered. Furthermore, the qualifying hands, and corresponding prize, shall be displayed prominently within Parkwest Casino Sonoma at all times the Ticket Drawing Promotion is being offered for play.

### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the pre-determined and specified hours designated and posted for the gaming activity.

- There is a 2 player minimum that must be seated and playing at a table in order for the table to be eligible for the drawing.
- Tournament game tables are not eligible for this gaming activity.
- Casino employees are not eligible to participate in this promotion at any time.
- Third Party Provider of Proposition Player Services (TPPPS) are not eligible to participate in this gaming activity.
- Drawing tickets are non-transferrable and can only be used by the player who earned them. The winning player will have their ID checked by Casino personnel.
- The player whose ticket is drawn will be awarded the prize at the time the ticket is drawn if they are present and up to five days, after the ticket has been drawn if they are not present.
- Players are not required to be present to win.
- If the prize is not claimed within those five days the prize will be go back into the prize pool.
- The tickets are discarded after the drawing has been completed, and a winner has been awarded the prize.

### **Prize**

The Ticket Drawing Promotion features a fixed prize element. Any player who qualifies will receive an entry to a tournament or a drawing ticket to be entered into a drawing where the winner of the drawing will be awarded a prize. The cumulative value of any and all prizes won shall range from \$10 to \$25,000 per promotional period. Prizes include, but not limited to: cash, bonus chips, free play chips, event tickets, entry(ies) to tournament(s), vehicles, and gift cards. ### **Funding**

### **Administrative Fees**

The Casino shall not retain an administrative fee as this promotion is house funded.

## Ticket Drawing Promotion

### **No Purchase Necessary Table Requirement**

The ticket drawing or entry to a tournament shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with no restrictions, to patrons who wish to participate in a No Purchase Necessary game. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the promotion without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the Drawing. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.
