The Lucky Derby Casino (LDC) is requesting a new promotion in our Blackjack and Joker's Wild Pai Gow Poker game. The new promotion is called "Car Giveaway." LDC will be giving away a brand new or used car every 4 months in our Blackjack and Joker's Wild Pai Gow Poker game. The drawing will be held on the last Wednesday of every 4<sup>th</sup> month. "Car Giveaway" dates and times will be posted throughout the casino. The estimated value of the car will be in the price range from \$15,000-\$100,000. The car will be on display at the LDC at all times until the car is given away on the 4<sup>th</sup> month. LDC will fund the car (LDC will pay for all applicable sales tax on the car, licensing and registration fees) and any cash given away for the "Car Giveaway." The amount of the car's value can change due to business conditions. LDC will give ample notice to the patrons of the Casino relating to the change.

The "Car Giveaway" will begin at 6:00pm continuing on until 12am. Ten (10) names will be drawn between 6:00pm and 12am. Drawing times will be posted in the casino for the duration of the "Car Giveaway" promotion. Drawing times may change due to business conditions. The last drawing for the night will be held at 12am. After the last drawing, the ten (10) car key winners will then try to start the car. There will only be one (1) winner that will take home the car on the drawing night. The car on display at the LDC will be the car won by the winner. The other nine (9) car key winners will receive \$300 cash for winning a car key. Players must be present at the drawing in order to win any "Car Giveaway" prizes. Winning tickets not claimed within 1 minute after the winners name is called will be dismissed and another drawing will be held. Players can win more than one (1) prize in the "Car Giveaway" drawings.

Players can earn tickets to the "Car Giveaway" drawing by receiving a Joker-Joker or Joker-Ace in all Blackjack table games and limits and/or by playing at the No Purchase Necessary table. Players can earn tickets to the "Car Giveaway" drawing by receiving a Four-of-a-kind or better (Joker can be used) in all Joker's Wild Pai Gow Poker games and/or by playing at the No Purchase Necessary table. Each player betting on the Qualifying Hand (Joker-Joker or Joker-Ace in Blackjack or Four-of-a-kind or better, Joker can be used, in Joker's Wild Pai Gow Poker) will receive an entry ticket to the "Car Giveaway" drawing.

Winning entry tickets cannot be transferred to another player. Players do not need to pay a table fee collection to be eligible for a drawing ticket in Blackjack or may play at no charge at our instructional table for an indiscriminate amount of time as described below in the No Purchase Necessary Procedures. Players must pay a table fee collection in Joker's Wild Pai Gow Poker to be eligible for a drawing ticket or may play at no charge at our instructional table for an indiscriminate amount of time as described below in the No Purchase Necessary Procedures. Floor Persons and/or Management will verify the Qualifying Hands in the Blackjack and Joker's Wild Pai Gow Poker games. The entry tickets will be dispensed into a raffle box located in the Blackjack and Pai Gow room by the Floor Person and/or Management. The raffle box will be under twenty-four (24) hour camera surveillance and will be visible to all players and casino personnel. Employees of the LDC and Third party proposition employees are not eligible to win the car or any money for the "Car Giveaway."


Players must fill out a 1099 form for any prize or cash that is \$600 dollars or more. All taxes on prizes and incidental expenses not mentioned herein are the responsibility of the winner, if applicable.

**No Purchase Necessary Procedures:**

"Car Giveaway" will be offered for free to all persons who wish to participate at a No Purchase Necessary table. LDC will provide a free instructional table for all patrons who wish to participate in the "Car Giveaway" without paying a table fee or a Jackpot Collection. Patrons may play at no charge at our instructional table for an indiscriminate amount of time. There will not be live wagers at this table. Participants in the No Purchase Necessary free instructional table will be eligible to win the full-posted Jackpot prize if they participate in a game where a player obtains the designated Jackpot Hand.

## **Aces Cracked**

### **Bureau Requirements**

#### **Advertising**

The Saloon at Stones Gambling Hall may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEGA-004179) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in The Saloon at Stones Gambling Hall at all times the gaming activity is being offered for play:

- Eligible games and time periods
- Qualifying winning and losing hands
- Prize amount and prize type
- Availability of No Purchase Necessary
- Any other restrictions that apply to this gaming activity

#### **Eligible Controlled Games**

The Aces Cracked gaming activity shall be attached to the following Bureau approved controlled games offered at The Saloon at Stones Gambling Hall, as shown below, at all times this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

- Texas Hold'em (GEGA-001551)

#### **Object and Summary**

The Aces Cracked gaming activity features a fixed jackpot element attached to the eligible controlled game listed above. A prize is awarded to players participating in a jackpot game when a hand containing a Pair of aces is beaten by a better hand at the showdown. In all instances, patrons shall be provided with ample advance notice of the rules and restrictions in order to qualify for the Aces Cracked gaming activity.

#### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours posted for the gaming activity.

- There is a minimum of two players required to be dealt in during a qualifying game in order for players to be eligible and the table to qualify for the promotional prize.
- When a qualifying hand is made, a casino representative will verify that the hand qualifies. Any deviation from a standard deck will nullify the promotion.
- In order to qualify for the promotion, the player must complete the applicable bets on each round. If the player goes all-in, this is considered to have completed all bets.
- The player must lose the hand at the showdown, after the final round of betting.
- In the event that during a round of play, two players have the same qualifying losing hand, each player will split the posted prize amount.

The Lucky Derby Casino (LDC) is requesting approval for the following promotion:

**SECTION III – JACKPOTS, CASHPOTS, BONUSES, PROMOTIONS, etc.**

1. *Name of Proposed Gaming Activity:*

Bonus Chip Coupon

2. *Name each controlled game that is associated with this gaming activity:*

All games approved for play at Lucky Derby Casino. Lucky Derby Casino reserves the right to be able to target specific games depending upon marketing needs.

3. *Describe any jackpot or any other type of prize awarded:*

Coupons will be placed in advertisements for players. Coupons will be for amounts ranging from \$1-\$500 in total chips. Coupons are generally for 1st time players or for special event coupons for current players such as for birthdays or for blackjack specials. Players are required to buy-in for an amount in the range of \$1-\$500 in order to receive the bonus chips. Time requirements also apply to the coupon for players redeeming the coupon in the range of 15 minutes of play to 6 hours of play based on the amount and promotion criteria of the coupon.

4. *If a cash prize is involved, is the amount of the prize progressive or a fixed amount?*

Fixed. If the player busts before the required playing time has elapsed, the player owes nothing to the casino. If the player leaves before the required time has past, they will owe the full amount of bonus chips awarded, or the remainder of their chips if they have less than the amount of bonus chips received remaining. A patron will never owe money at a future date. In these instances, the Casino will incur all losses, and the player will not be responsible to make up the difference.

7. *Describe how the jackpot will be seeded and how any prizes will be awarded:*

Sample A: Players will bring in a coupon from an advertisement and will buy in to a game for \$25 and they will receive another \$25 from the casino to play in the game. The player will have a time requirement of 2 hours of play or until their \$50 is gone.

Sample B: Players will bring in a birthday coupon during their birthday month and will buy in to a game for \$25 and they will receive another \$25 from the casino to play the game. The player will have a time requirement of 2 hours of play or until their \$50 is gone.

Sample C: The First 9 players between the hours of 9am and 10am in the 4x8 Hold Em game that buy in for \$100 will receive another \$20 from the casino to play in the game. The player will have a time requirement of 2 hours to play or until their \$120 is gone.

Sample D: Blackjack Match-Play coupons. Match-play coupons will be in \$5 increments. Coupons must be used in conjunction with a bet of \$5 or higher. A winning bet will result in an additional payout equal to the denomination listed on the coupon. Match-play coupons are not legal tender and are for promotional use only. Match-play coupons may only be used one time and must be relinquished to the dealer on a winning or losing bet.

Players will sign their promotional coupon and present it at the kiosk, where the coupon and the player's info, including full name and driver's license number, will be verified and logged in a binder. The binder will always be checked before any bonus chips are issued.

Amounts of coupons, buy ins, and time requirements may vary based on the ranges listed in number 3, but will be printed on each coupon.

## Bonus Hand

### **Bureau Requirements**

#### **Advertising**

The Saloon at Stones Gambling Hall may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEAR-001235) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in The Saloon at Stones Gambling Hall at all times the gaming activity is being offered for play:

- Eligible controlled games and time periods
- Qualifying Hole Cards
- Prize amounts and descriptions
- Number of times a player may win within a promotional period
- Availability of No Purchase Necessary

#### **Object and Summary**

The hole cards do not have to be used by the player in order to be eligible for a winning hand. The predetermined set of hole cards and prize will be announced and prominently displayed in the Casino. In the event that two or more players have qualifying hole cards and winning hands (split pot), the prize shall be equally split amongst each eligible player. In all instances, patrons shall be provided with ample notice of the rules and restrictions in order to qualify for the Bonus Hand gaming activity.

***Example 1:*** Win with 7, 2 while playing Texas Hold'em and receive a \$100 bonus in addition to the pot.

***Example 2:*** Between the hours of 12am and 12pm, Texas Hold'em live game players that show a winning hand with hole cards 7, 2, will win \$100, in addition to the pot in play.

***Example 3:*** During the month of February, 2020, any Texas Hold'em player showing a winning hand of 2, 2 will win \$222, in addition to the pot in play.

#### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours posted for the gaming activity.



## **Bonus Hand**

- There must be a minimum of two active players dealt into the base game for the players to qualify for this promotion.
- Once a player is dealt the set of predetermined hole cards, he or she will have the opportunity to play for the Bonus Hand gaming activity. The player with those hole cards must win the hand during the round of play. The player does not need to use the hole cards in their winning hand.
- In order to qualify for the promotion, the pot must be 20x the big blind including the collection fee. (i.e. In a 1-2 No Limit Hold'em there has to be \$40 in the pot for the hand to be eligible, in a 2-5 No Limit Hold'em the pot must be \$100).

### Advertisement Requirements

Furthermore, all rules and procedures for California Tournaments, including but not limited to the following, shall be prominently displayed in the Lucky Derby Casino at all times that a California Tournament is offered for play:

- How a player may enter the tournament.
- The game(s) that will be offered during the play of the tournament.

- **Promotional materials shall not advertise gender-based discounts nor imply a gender-based entrance policy.**
- Patrons may enter a tournament by paying the buy-in and entry fee. **All fees, prices charged, and the amount of tournament chips provided shall be equal and posted for all players.**

Below are the previous Qualifying Hands and payouts for "Caribbean Stud Jackpot."

**Flush** – 5 cards of the same suit in no specific order (3♦5♦7♦9♦2♦) player wins \$50 from posted Jackpot.

**Full House** – 3 cards of the same rank with 2 cards of the same rank (3♦3♠3♣2♠2♣) player wins \$250 from posted Jackpot.

**Four-of-a-kind** – 4 cards of the same rank (2♠2♣2♥2♦4♦) player wins \$500 from posted Jackpot.

**Straight Flush** – 5 cards of the same suit in sequence (2♠3♠4♠5♠6♠) player wins \$1,000 from posted Jackpot.



Easy Way Jackpots

2. *Name each controlled game that is associated with this gaming activity:*

All Texas Hold'em Poker Games and Limits approved for play at Lucky Derby Casino are eligible to qualify for the Easy Way Jackpots.

3. *Describe any jackpot or any other type of prize awarded:*

We would like to add an Easy Way Jackpot in which players can win a prize for losing with a pre-determined hand.

A prize is awarded to players participating in a jackpot game when a designated second hand is beaten by a better qualifying hand at the showdown. There will be a range of qualifying hands as listed below. Only one of these qualifying hands options may be offered at any given time. They will not be offered together at any time nor may a combination of the options be offered together at any time that this gaming activity is being offered. Furthermore, the qualifying hand option that is being offered shall only be offered for the qualifying controlled game, as listed above. All of the above restrictions, as shown below, shall apply to all of the qualifying hand options, as listed below.

In order to qualify for the jackpot, the winning and losing hands must use two (2) "hole" cards and three (3) community cards from "the board."

Players with qualifying winning and losing hands must play through the final betting round, which is after "the river," in order to qualify for the jackpot. If a player with one of the qualifying hands folds prior to the final betting round, the table will be in-eligible for the jackpot.

The possibility could also occur that a player would qualify to win an Easy Way Jackpots during the same hand in which Jackpot A or Jackpot B is won; In these cases, Jackpot A and Jackpot B take precedent and the Easy Way Jackpot would not be paid.

However, if Jackpot B is won and awarded and then re-seeded at the minimum amount, and then the Easy Way Jackpots hand is achieved, the posted progressive jackpot prize amount would not be reduced by the Easy Way Jackpots prize amount, it would simply be paid by the house. For example, say the Jackpot B is won and reseeded at \$20,000, and then Option 1: Pocket Pair of Aces Beat is being offered and the prize amount is \$1,000, and the Easy Way Jackpots hand is achieved, the Easy Way Jackpots (Option 1: Pocket Pair of Aces Beat) would be paid out, according to the payout option being used, but the posted progressive jackpot amount for Jackpot B would remain at \$20,000. In the case where the posted progressive jackpot prize amount increases past the re-seed amount, then the difference would be deducted from the posted progressive prize pool and the other portion would be paid by the house. - "Hockey Puck" discs will be attached to the table in front of each betting position. These discs have a sensor and will detect when a casino chip is placed on them. Players must place the optional jackpot fee on the sensor. The sensor will then light up.

<b>Full House</b>	A hand that consists of a Three of a Kind and a Pair. Three aces and two kings is the highest ranked Full House and three 2s and two 3s is the lowest ranked Full House.

### Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours designated and posted for the gaming activity.

- Only seated players who are dealt a designated hand are eligible for payouts.
- A minimum of two players are required to play for the progressive jackpot.

## Face Up Pai Gow Poker and Fortune Pai Gow Poker Progressive Jackpot

### **Funding**

The Casino will initially seed the jackpot at a range from \$1,000 - \$50,000. Once there are sufficient monies in the reserve fund, the initial seed will be reimbursed to the Casino and shall be documented in the accounting records. After the progressive jackpot is hit, it will be re-seeded by the reserve fund in the amount ranging from \$1,000 - \$50,000.

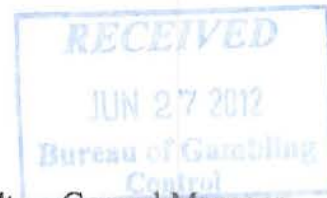

- A minimum of two active players are required to be dealt in during a qualifying game in order for the players and the table to qualify for the jackpot or the bonus prize if offered.
- Tournament games do not qualify for the jackpot.

All prizes shall be paid in the form of cash, live casino chips, or check. All prizes shall be predetermined and posted in the Casino at all times this jackpot is offered for play. The prize shall be paid immediately by a casino representative after the winning and losing hands are confirmed. Once the jackpot is hit, it will be reseeded by the Casino in an amount ranging between \$1,000 to \$1,000,000.

Additionally, the Casino may offer a multiplier for the current posted prize during predetermined and posted time periods ranging from one half hour to one month. The jackpot amount may be multiplied by 2x to a maximum of 10x. Bonus prizes shall range in value per the approved rules in each gaming activity. Bonus prizes shall be awarded in the form of Player's Club Promotion points (GEGA-004227), entry into the Lucky Seat Promo (GEGA-004192), and Pot Splashers (GEGA-002586).

If the prize to be awarded is in the form of Player's Club Promotion points (GEGA-004227), all seated players at each eligible bonus table will receive the predetermined and posted number of points. If players do not possess a Player's Club card, they can see a casino representative to enroll and receive the points. If the prize to be awarded is in the form of entry into the Lucky Seat Promotion (GEGA-004192), the promotion will be run on each eligible bonus table according to the approved rules for the gaming activity. If the prize to be awarded is in the form of the Pot Splashers promotion (GEGA-002586), the promotion will be run on each eligible bonus table according to the approved rules for the gaming activity.

### **Prize Payout Structure**

Players that make the designated qualifying hands will be eligible to win their share of the Hold'em Bad Beat Jackpot C prize amount, based on the payout table being used, as shown below. Only one of these prize payout structure options shall be offered at any one time that the Hold'em Bad Beat Jackpot C is being offered for play. They shall not be offered together at any time nor may any combination of the prize payout structure options be offered together at any time that this gaming activity is being offered. Patrons shall be provided with ample advance notice of which prize payout structure option is being offered for play. Once a prize payout structure option is designated by the Casino, the payout structure shall not be adjusted or changed until the jackpot has been hit and awarded. Furthermore, the prize payout structure will be displayed prominently via printed flyers, digital display, and any other forms of advertisements.

\*The Table Share shall be evenly distributed among all other players at the table who are participating in a designated game that is eligible for the jackpot when the jackpot is awarded. In the event there is an uneven amount to share among eligible players, the prize amount shall be rounded up to the nearest dollar to ensure each player is paid the same amount.

### **Funding**

The Hold'em Bad Beat Jackpot C prize pools shall be fully funded by The Saloon at Stones Gambling Hall. Therefore, there shall be no additional jackpot or collection fees taken for this promotion.

Furthermore, all rules and procedures for this gaming activity, including but not limited to the following, shall be prominently displayed in the Saloon at Stones Gambling Hall at all times the promotion is being offered:

- Eligible games and limits.
- Eligible time frame in use.
- Eligible number of player(s) paid out.
- Specific number of prizes to be paid.
- Specific prizes and/or prize amounts.
- Availability of No Purchase Necessary.
- Any other restrictions that apply to this gaming activity.

#### **Eligible Controlled Games**

The Live One Chip Event shall be attached to the following Bureau approved Poker controlled games offered at the Saloon at Stones Gambling Hall at all times that the gaming activity is being offered for play as shown below. All controlled game rules shall be played as approved by the Bureau.

#### **Object and Summary**

The Live One Chip Event features a fixed prize element. A prize is awarded at the end of a designated time frame to a designated number of players based on the number of Live One Chips won at a specified game or table. Players will be awarded a Live One Chip for every hand they win in a predetermined and posted game or table during a designated time frame. In a predetermined game, the player with the winning hand shall win the pot and shall also win a Live One Chip during a designated timeframe. In the event of a tie and the pot is split, each player who split the main pot (side pot splits are not eligible) shall receive a Live One Chip. The casino dealer or the game attendant will give the Live One Chips to the winning player at the table. Players must keep their Live One Chips stacked in a chip rack, on the table, in view of a camera, never to be put in their pocket or concealed. If a player moves from table to table, they shall then take their chip rack with them. At the end of a designated timeframe, all Live One Chips shall be returned and the casino will keep inventory and balance the inventory at the end of the designated timeframe. The Live One Chip will be a generic chip that states something similar to "Live One Chip" with the Stones Gambling Hall logo. Furthermore, all rules and procedures for this gaming activity, including but not limited to the following, shall be prominently displayed in the Saloon at Stones Gambling Hall at all times that the gaming activity is being offered for play:

- Specific drawing dates and times.
- Specific tournament dates and times.
- Eligible games and time periods.
- Qualifying hands & corresponding number of tickets to be earned.
- Prize Amount.
- Availability of No Purchase Necessary Information.
- Any other restrictions that apply to this gaming activity.

#### **Eligible Controlled Games**

#### **Object and Summary**

The Saloon at Stones Gambling Hall will run a promotion where patrons qualify through three successive stages to win the opportunity to make a qualifying hand by choosing five envelopes from a predetermined number of envelopes; each envelope contains one playing card. The cards that are placed in the envelopes will be randomly chosen, then placed in the envelopes by the Poker Game Attendant and/or Casino Shift Manager. Players are required to use their Player's Reward Card when participating in this event. Once a qualifying event takes place, the Poker Game Attendant will confirm the qualifying event and ensure the qualifying player has used their Player's Reward Card. ### Stage 2 – Poker Tournament

### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the pre-determined and specified hours designated and posted for the gaming activity.

- There is no minimum number of players that must be seated and playing at a table in order for the table to be eligible for the Lucky Choices promotion, other than what is required for game play.
- Casino employees are not eligible to participate in this promotion.
- A Third Party Provider of Proposition Player Services (TPPPS) is not eligible to participate in this gaming activity at any time.

The Lucky Choices promotion shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with no restrictions, to patrons who wish to participate in a No Purchase Necessary game. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the jackpot without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the Lucky Choices. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers. Eligibility



## **Lucky Seat Promotion**

### **Bureau Requirements**

#### **Advertising**

The Saloon at Stones Gambling Hall may advertise various names for this gaming activity. Should The Saloon at Stones Gambling Hall advertise a different name, the BGC ID (GEGA-004192) listed below will be referenced on all advertisements relating to the Lucky Seat Promotion.

Furthermore, all rules and procedures for this promotion, including but not limited to the following, will be prominently displayed in The Saloon at Stones Gambling Hall at all times the promotion is being offered:

- Eligible games and time periods
- Eligible Dates and Times
- Specific Prize Amounts
- Opportunity for No Purchase Necessary
- Any other applicable restrictions

#### **Eligible Controlled Games**

The Lucky Seat Promotion may be attached to all Bureau approved games for The Saloon at Stones Gambling Hall. All base game rules will be played as previously approved by the Bureau of Gambling Control.

#### **Object and Summary**

The Lucky Seat Promotion is a bonus prize promotion that awards players who are dealt in a card game a chance for their seat to be drawn and for that person to win a predetermined prize. The Saloon at Stones Gambling Hall will choose one of the two predetermined qualifying options, listed below, as the method to qualify for the prize.

#### **Option 1 – Pick a Seat/Pick a Table**

Lucky Seat placards or balls corresponding to a seat will be placed in a drum or similar device by a casino employee. The placards or balls will be mixed blindly by hand in a drawing box or manually spun around in a drawing drum or manual bingo cage. After mixing, the numbered placards or balls will be drawn manually from a drum, or a similar non-electronic device, and announce the eligible “Lucky Seat” number.

Once a Lucky Seat has been determined, it will be announced on the casino floor followed by a drawing for a table number. Table number placards or balls corresponding to the table numbers for all ACTIVE (at least two players for poker games and at least one player and one player-dealer for California games at the table) live tables will be placed in a drum or similar device. If the selected Lucky Seat number for the selected table is empty, the patron is not being tracked with their Player’s Club Card, or the patron did not take a hand before the announcement of the draw, an alternative table will be redrawn.

## Lucky Seat Promotion

### **Option 2 – Pick a Seat/All Tables Win**

Lucky Seat placards or balls corresponding to a seat will be placed in a drum or similar device by a casino employee. The placards or balls will be mixed blindly by hand in a drawing box or manually spun around in a drawing drum or manual bingo cage. After mixing, the numbered placards or balls will be drawn manually from a drum, or a similar non-electronic device, and a casino employee will announce the eligible Lucky Seat number. All patrons occupying those Lucky Seats at every eligible live gambling table will win the prize if they are in their seat, they are being tracked with their Player's Club Card (GEGA-004227) and they took a hand before the announcement of the draw. If the selected Lucky Seat number is empty, the patron is not being tracked with their Player's Club Card (GEGA-004227), or the patron did not take a hand before the announcement of the draw, no prize will be awarded to that specific seat.

### **Eligibility Requirements**

This gaming activity will be open to all players who are seated and playing at any of the above listed controlled games during the pre-determined specified hours designated and posted for the gaming activity.

- Players must be seated and playing at a designated table in order to qualify for the promotion.
- Players must be present to win a prize.
- This promotion is restricted to Player's Club Members (GEGA-004227). Players are eligible to participate and receive prizes via concurrent promotions connected to the Player's Reward Program (GEGA-004227).
- Players must be using their Player's Club Card (GEGA-004227) on the table at the time of the announcement of the draw in order to be eligible for promotion.
- Players must have taken a hand before the announcement of the draw to be eligible for this promotion.

The Lucky Seat Promotion will be fully funded by The Saloon at Stones Gambling Hall.

### **Administrative Fees**

The Saloon at Stones Gambling Hall will not retain an administrative fee, as this gaming activity is house funded.

### **No Purchase Necessary Procedures**

The Lucky Seat Promotion will be offered to customers who wish to participate for free, on a general and indiscriminate basis, with no restrictions, to patrons who wish to participate in a No Purchase Necessary game. The patrons who wish to participate in The Lucky Seat Promotion will pick an active seat number and an active table number and will fill out a form with the Casino Shift Manager with this information. If active seat number and active table number are selected, the patron will win the same prize. All advertisement material will state "No Purchase Necessary" when referencing the Lucky Seat Promotion. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

## Lucky Derby Casino Omaha Royal Flush Jackpot

### **Advertisement Requirements**

The Lucky Derby Casino may advertise various names for this gaming activity. Should the Lucky Derby Casino advertise a different name, the BGC ID listed below shall be referenced on all advertisements relating to the Omaha Royal Flush Promotion.

Furthermore, all rules and procedures for this gaming activity, including but not limited to the following, shall be prominently displayed in the Lucky Derby Casino at all times that the gaming activity is being offered:

- Qualifying games.
- Eligible dates and time periods.
- Qualifying hand and corresponding prize amount.
- Availability of No Purchase Necessary.
- Any other restrictions that apply.

### **Controlled Game**

The Omaha Royal Flush Hand shall be attached to all limits and versions of the currently approved games offered at The Lucky Derby Casino, as shown below.

- All Approved Omaha Games

All controlled game rules will be played as previously approved by the Bureau.

### **Rules of Play**

Players that receive the qualifying hand of a Royal Flush, during a pre-determined and posted time period, will win a pre-determined and posted prize ranging in value of a minimum of \$5 with no maximum amount.

### **Qualifying Hands**

The qualifying hands will be Royal Flushes with each suit progressing separately. Two of the four hole cards must be used in the qualifying five-card hand.

### **Prize**

When players make the qualifying hand of a Royal Flush in a certain suit, the prize shall be a progressive amount ranging in value from a minimum of \$5 with an unlimited maximum. The prize shall be awarded in the form of cash, chips or prizes such as merchandise including: jewelry, electronics, clothing, vehicles, watercraft, gift certificates, sporting and concert tickets, food comps, entry into tournaments and travel. All prizes for this gaming activity shall be pre-determined and posted in advance, throughout the gaming floor and in all literature promoting such an event.

## **Lucky Derby Casino Omaha Royal Flush Jackpot**

### **Eligibility**

The gaming activity shall be open to all players who are seated and playing at any Omaha poker table during the pre-determined and specified hours designated for this gaming activity.

- Players must be seated and playing at a designated table in order to qualify for the promotion.

- In order to qualify for the promotion, the player must win the hand on the showdown, after the final round of betting.
- All procedures, promotion times, and prize amounts must be displayed prominently at all times that the Omaha Royal Flush Promotion is being offered for play via any form of advertising that the Lucky Derby Casino wishes to use, including but not limited to posters, printed flyers, digital display, the Casino's website, etc.

### **Funding**

The Omaha Royal Flush Hand Promotion utilizes four progressive prize pools which shall be funded by the Lucky Derby Casino. Each prize pool shall be initially seeded in an amount ranging from \$5 - \$500, and the prize pools shall each increase daily in an amount ranging from \$5 - \$1,000. A player may win a progressive or fixed jackpot prize by paying the \$1 jackpot fee and making a predetermined qualifying hand listed below. Also, a player paying the \$1 jackpot fee qualifies to win an envy payout.

- To begin each round, players must make their regular base game wager. They may optionally place any bonus bets along with the jackpot fee of \$1.
- A minimum of two players, a player and a player-dealer, are required to play for the progressive jackpot.
- "Hockey Puck" discs will be attached to the table in front of each betting position. These discs have a sensor and will detect when a casino chip is placed on them. Players must place the optional jackpot fee on the sensor. The sensor will then light up.
- Once all players place their bets and/or jackpot fee, the house dealer will press "Coin In" on the keypad. The sensors will then light up, indicating participation in the progressive jackpot. The house dealer will then remove all jackpot fees from the table. The jackpot fees are dropped in a separate and locked jackpot collection box affixed to the gaming table.
- The house dealer then follows standard approved procedures for dealing the base game.



**Qualifying Hands**

When a player is dealt an ace, king and queen of spades, the player is paid from the progressive jackpot shown on the progressive meter. When a player is dealt an ace, king and queen of either hearts, diamonds or clubs, the player is paid 10% of the progressive jackpot shown on the progressive meter. Any straight flush, a hand consisting of three cards of the same suit in consecutive ranking, other than ace, king and queen, receives a fixed prize amount, paid from the reserve fund, according to the pay table below. The fixed prize payout does not get deducted from the amount shown on the meter.

**Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the pre-determined specified hours designated and posted for the gaming activity. The eligibility requirements are as follows:

- Only players seated at the table and dealt a designated hand are eligible to win.
- Backline bettors are not eligible to place a jackpot fee nor receive the prize amount for a designated hand.
- There is no limit to the number of times a player can win either the progressive or fixed jackpots.
- When a qualifying hand is announced, a Casino representative will verify the hand qualifies. Any deviation from a standard deck will nullify the hand.
- When a player is dealt a qualifying designated hand, the player will receive 100% of the prize amount.
- Tournament games are not eligible for this promotion.
- Casino employees are eligible for the Three Card Poker progressive and/or fixed prize only when off duty and out of uniform.
- A Third-Party Player of Proposition Services (TPPPS) is not eligible to place a jackpot collection fee and become eligible for the prize when either in the player-dealer or player capacity.

**Prize**

**Progressive Prize**

- When a player is dealt an ace, king, queen of spades, the player is awarded 100% of the progressive jackpot shown on the progressive meter. When a player is dealt an ace, king, queen of either hearts, diamonds or clubs they are paid 10% of the posted progressive jackpot shown on the progressive meter.
- All other hands are paid from the reserve fund. They do not get deducted from the amount shown on the meter.
- In the event more than one progressive meter pay or any other qualifying hand hits during the same round, all winning players will be paid the posted progressive prize.



- When more than one progressive prize payout hits, one progressive prize payout will be paid from the meter and the others will be paid from the reserve fund. The Casino will cover any shortfalls and be reimbursed once the reserve account has sufficient funds.
- All progressive prize payouts will be paid by a Casino representative. Once the proper paperwork has been filled out, the Casino representative will pay the winner(s) in live casino chips. The progressive prize payouts will not be made from the house dealer's tray.

### **Fixed Prize**

- When a player is dealt a straight flush, they are paid a fixed prize amount according to the payout table above.
- All fixed prize payouts will be paid by a Casino representative. Once the proper paperwork has been filled out, the Casino representative will pay the winner(s) in live casino chips. The payouts will not be made from the house dealer's tray. All fixed prize payouts will be deducted from the amount in the reserve fund.

### **Envy Bonus**

- A player paying the \$1 jackpot fee qualifies to win an envy payout. If another player at the table hits a hand associated with an envy pay, all other players who paid the \$1 jackpot fee will win the envy pay. The player hitting the hand receives the normal prize pay only, but does NOT receive the envy pay.
- If a player's hand triggers an envy payout, the house dealer will leave the hand face-up on the layout; otherwise, the house dealer will lock up the cards. The house dealer will then move on to the next player.
- All Envy Bonus payouts will be paid by a Casino representative at the end of the round. Once the proper paperwork has been filled out, the Casino representative will pay the winner(s) in live casino chips. The payouts will not be made from the house dealer's tray. All Envy Bonus payouts will be deducted from the amount in the reserve fund.

### **Prize Payout Structure**

Players who achieve an ace, king and queen of spades will be awarded 100% of the posted progressive jackpot prize. Players who achieve an ace, king and queen of either hearts, clubs or diamonds will awarded 10% of the posted progressive jackpot prize. Players who achieve a Straight Flush will be awarded \$100 fixed jackpot prize. If a player achieves a Royal Flush progressive prize, all other players who paid the jackpot fee will be awarded \$100 Envy Bonus.

The Casino has the option of running the progressive and fixed jackpots by multipliers of 1-10 times. The multiplier must be added to both the fixed and progressive jackpots. Days and times for the multiplier will be clearly defined and advertised in literature and casino signage. The Casino would use money from the Three Card Poker Progressive Jackpot reserve fund only to increase the jackpot for certain periods of time.

The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the Three Card Poker Progressive Jackpot. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

### **Equipment**

- The electronic software and digital reader related to and used in conjunction with this jackpot, which is used on each table eligible for this jackpot, has been tested, approved, and certified by the Gaming Laboratories International, LLC (GLI).
- When a player has a progressive winner, the house dealer shall press the appropriate hand button on the keypad.



- The house dealer shall then contact a Casino representative.
- Once the casino verifies the progressive win, the Casino representative shall insert the key and rotate it to “JPH” and then press “J-pot” button. This records the win onto the Game Manager. House procedures are then followed for paying the prize.
- Returning the key to the “Run” position will restore normal operation of the table, and adjust the meter appropriately for the prize won.

1. To begin each round, players must make their regular base game wager. They may optionally place any bonus bets along with the optional jackpot fee of \$1. A minimum of two players are required to play for the progressive jackpot.
2. "Hockey Puck" discs will be attached to the table in front of each betting position. These discs have a sensor and will detect when a casino chip is placed on them. Players must place the optional jackpot fee on the sensor. The sensor will then light up.
3. Once all players place their bets and/or jackpot fee, the house dealer will press "Coin In" on the keypad. The sensors will then light up, indicating participation in the progressive jackpot. The house dealer will then remove all jackpot fees from the table. The jackpot fees are dropped in a separate and locked jackpot collection box affixed to the left side of the gaming table.

- Backline bettors are not eligible to earn tickets for the Cash and Merchandise Drawing.

All fee collections and table limits are for the designated controlled games and are Bureau approved, predetermined and posted at each table.

### **Administrative Fees**

The Saloon at Stones Gambling Hall shall not retain an administrative fee as this promotion is house funded.

## Cash and Merchandise Drawing Promotion

### **No Purchase Necessary**

The Cash and Merchandise Drawing Promotion shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the Cash and Merchandise Drawing Promotion. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

## **Player's Club Promotion**

### **Bureau Requirements**

#### **Advertising**

The Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEGA-004227) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for this gaming activity, including but not limited to the following, shall be readily available to guests and prominently displayed in The Saloon at Stones Gambling Hall at all times the gaming activity is being offered:

- Corresponding time played and possible points to accrue
- The date(s) and time(s) the gaming activity shall be offered
- The corresponding points and prize amount
- The prize(s) offered to players meeting the requirements of the gaming activity
- Player Card Tier levels and corresponding tier points required at each level
- Any other applicable restrictions

#### **Eligible Controlled Games**

The Players Club Promotion shall be attached to all Bureau approved games offered at The Saloon at Stones Gambling Hall at all times this gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

#### **Object and Summary**

The Players Club Promotion features a promotional element attached to Bureau approved games offered at the Casino. This gaming activity is a player reward loyalty program open to all casino patrons. This promotion will reward players with points based on time played and /or average wagers at designated table games during predetermined and eligible periods.

#### **How Prizes and Tiers are Earned Based on Time Played and/or Average Wagers**

Prizes shall be earned by the amount of time played and/or the average amount of money wagered per seat. Each player that plays a Bureau approved game shall have a designated casino representative swipe, scan, tap, or otherwise track their Player's Club Card or card number and have their hours played and average wagers tracked. The Casino may create 1 – 16 tiers, in which players can earn between 1 to 150,000 points at different rates and/or be eligible for different tiers and prizes. Each hour will account for 1 to 10,000 points. Each point will be worth \$.005 to \$1 per point. The Casino may select one or more of the following thresholds to create multiple tiers, ranging from the following minimum points:

9. 25,000+ Points earned in 3-6 months
10. 30,000+ Points earned in 3-6 months
11. 40,000+ Points earned in 3-6 months

## Player's Club Promotion

12. 50,000+ Points earned in 3-6 months
13. 75,000+ Points earned in 3-6 months
14. 100,000+ Points earned in 3-6 months
15. 125,000+ Points earned in 3-6 months
16. 150,000+ Points earned in 3-6 months

For example, the Casino may choose to offer a bronze and silver tier in the Players Club Promotion and designate the bronze tier at threshold #1 and the silver tier at threshold #6 for a 4-month earning period. Players earning 10,000+ points during the period would earn a silver tier.

### How Prizes are to be Redeemed

Players may redeem their points for prizes at any time during the promotion. All prizes shall have a predetermined and designated value. Prizes shall be earned by the amount of time played and/or the value of the wager during the promotional period. After a player has accumulated a predetermined and specific amount of points, a player may redeem the accrued points for a predetermined and designated prize(s).

- After a player has been awarded a prize, they may also be eligible for multiple and subsequent prize(s) until the end of the promotion.

### Player's Club Card Computer System Description

It shall also include a RFID chip, magnetic strip, bar code, or other technology used to identify the unique player card number for each player in The Saloon at Stones Gambling Hall player tracking system.

- The card shall be non-transferable, and revocable at management's discretion.
- The Player may use an electronic version of the card located on their mobile device through the Casino's mobile application.

Access to the data is by user level with multiple levels based on what the user will be doing. Marketing manager will have access to customer data for marketing purposes (i.e., emails, texts, mass mailing, etc.) The Compliance Department will have access to information necessary for reviewing transactions in compliance with Title 31 requirements and any other applicable federal or state laws.
- A printable record of the amount of time and/or average wagers a player has accumulated during the period of time that the gaming activity is being offered, shall be available at any time, upon their request.
- All data is backed up to an on-site computer. All data is stored on a system so that single hard drive failures won't affect it. The system is backed up every 24 hours.

### **Eligibility Requirements**

This gaming activity shall be open to all players 21 years of age and older with valid I.D. who sign up for a Player's Club Card and participate in an eligible game for a designated period of time to earn points. When the player chooses to exchange their accrued points, they shall win a corresponding prize.

- Eligible time periods will range from one minute to ten thousand hours.
- Eligible dates will range from one day to one year.
- At least two players shall be playing at a Poker game or California game in order for the players at the table to be eligible for this promotion.

### **No Purchase Necessary**

The Players Club Promotion does not contain the element of chance. Therefore, it does not constitute an illegal lottery and does not require a No Purchase Necessary table to be offered while conducting this promotion.
