1. *Name of Proposed Gaming Activity:*

Bargain Buy-In Promotion.

2. *Name each controlled game that is associated with this gaming activity.*

All approved games.

3. *Describe any jackpot or any other type of prize awarded.*

When players buy into any listed promotional game for a pre-designated dollar amount ranging from \$10 to \$100, Towers Casino will add additional chips ranging from \$10 to \$100, to their chip stack. There will be a minimum of amount of time required to play, never to exceed three (3) hours, (or the player would return the bonus UNLESS they busted or lost their money), depending on the amount of Bargain Buy-In being offered. The range of cash required, the Bargain Buy-In given and the playing time requirement will all be pre-designated and posted before the promotion begins in a clear and conspicuous area. A player is only eligible for this promotion once per day. Players will be listed on a daily sign-in sheet when they receive their Bargain Buy-In. A day starts when the casino opens and concludes when the casino closes. If the casino should be open for a full 24 hours, then a day will be determined as calendar days (midnight to midnight).

4. *If a cash prize is involved, is the amount of the prize progressive (increases) or a fixed amount?*

Fixed amount.

5. *Explain if the gaming activity is house funded or player funded.*

House funded.

6. *Describe any special fee collection involved in this gaming activity, for example, a jackpot fee collection.*

No additional fees.

7. *Describe how the jackpot will be seeded and how many prizes will be awarded.*

When a player buys in during the designated promotional time period with the conditional buy-in amount, they will receive a bonus amount of chips.

For example, Towers Casino offers a \$60 for \$40 bonus. The bonus will be paid up front to any player who buys in for at least the minimum amount required for the promotion. In the event that a player busts out before the required play hours are up, the player will not have to re-imburse the Towers Casino for the Bargain Buy-In. In the event that a customer has to leave before the required amount of playing time has been met, that customer will need

to give back the Bargain Buy-In, or what ever portion of Bargain Buy-In are left in play. Towers Casino will never require a customer to owe the money at a future time. The time of play will be tracked by a Towers Casino employee.

**Example:** A player buys in during the above mentioned promotional time. He buys in for \$40 and receives \$60 in chips (\$20 in Bargain Buy-In) with a two (2) hour minimum playing time required. An hour later, the player has an emergency at home and has to leave but only has \$15 left in front of him. The Casino will pick up the \$15 as these are still Bargain Buy-In chips. However, Towers Casino will not expect the customer to pay the balance of \$5 on the customer's next visit. Once again, Towers Casino will incur the losses for these scenarios for the sake of this promotion.

8. *Explain any prize distribution including prizes given to the winner, loser, or any other player or patron.*

There are no winners or losers in this promotion as it is not a promotion of chance. All patrons who meet the posted criteria are eligible for the Bargain Buy-In.

9. *Explain any re-seeding of the fund once the prize is won.*

10. *Explain any minimum or maximum number of players required to be dealt into the game for the table to be eligible for the gaming activity and prize.*

No minimum or maximum.

"Bingo Style" Prize Card Promotion.

2. *Name each controlled game that is associated with this gaming activity.*

All approved games for Towers Casino. All house rules would apply.

3. *Describe any jackpot or any other type of prize awarded.*

Prizes will range in value from \$1 - \$2,500, depending on the type of the promotion in use. Prizes will consist of cash, casino chips or merchandise, such as, gift certificates for dinner at local restaurants, T-Shirts, hats, chip protectors, pens, etc. Prizes will be a fixed amount ranging in value from \$1 minimum - \$2,500 maximum. There could also be non-cash prizes such as gift certificates for dinner at local restaurants, T-Shirts, hats, chip protectors, pens, etc. The prizes will all be house funded.

4. *If a cash prize is involved, is the amount of the prize progressive (increases) or a fixed amount?*

Fixed amounts.

5. *Explain if the gaming activity is house funded or player funded.*

House funded.

6. *Describe any special fee collection involved in this gaming activity, for example, a jackpot fee collection.*

No additional fees.

7. *Describe how the jackpot will be seeded and how many prizes will be awarded.*

The Towers Casino "Bingo Style" Prize Card consists of 36 squares on a card with different hands, play times, play lengths, etc. Once the player achieves the activity of the specific square on the card, it gets punched by the floor (as one would mark off a "bingo square". 1 card stays at casino (Official) one card leaves with player. Different prizes awarded for across / diagonal/ etc. "Grand Prize" is for the Black Out where all squares are punched out. There will be one prize awarded for each vertical and horizontal row, both diagonal rows, and full card black out achieved in the same manner as bingo, on a first come basis. As with real "bingo", the first player to achieve the winner and come forward to management will be awarded the prize. There will be a large size "player game board" posted and the winner's name will be listed and the corresponding "jackpot" won will be marked off so other players will know that prize is no longer available. (This is not real Bingo, it's just "bingo-like"). During this promotion, players can request a card from a casino floor person. Each card will be individually numbered and have an exact duplicate

that is kept by the casino. One card per person. Players will to show a valid form of identification to receive a card, and will also need to show identification when claiming a prize. The card numbers and player's names will be kept in a log at the casino.

8. *Explain any prize distribution including prizes given to the winner, loser, or any other player or patron.*

Prizes will range in value from \$1 - \$2,500. Prizes will consist of cash, casino chips or merchandise, such as, gift certificates for dinner at local restaurants, T-Shirts, hats, chip protectors, pens, etc. The prizes will all be house funded. This promotion is for all Towers Casino players.

9. *Explain any re-seeding of the fund once the prize is won.*

The prize amount and prizes will be on a weekly, or monthly basis. If a specific prize category is not achieved within a month, the prizes will return to the general pool. The grand prize per month "Black-out" will roll over to the next month.

Example: If the "Black-out Jackpot" is valued at \$2,500 for February, and no one achieves "Black-out" then the \$2,500 prize will carry over to March. So, March would be equal to \$5,000 (\$2,500 Feb + \$2,500 March). If still, no one hits "Black-out" the April jackpot would be worth \$7,500 (\$2,500 Feb + \$2,500 March + \$2,500 April). And so forth.

10. *Explain any minimum or maximum number of players required to be dealt into the game for the table to be eligible for the gaming activity and prize.*

There is no minimum number of players required.

11. *Explain if the house is retaining any administrative or any other type of fee for operating the gaming activity.*

No additional fees retained by the house.

12. *Describe any opportunity(s) for a person to play for the prize without placing any live wagers or paying any table fees.*

Any person wishing to participate in this gaming activity may do so by simply asking a Floor Person that they would like to participate in the gaming activity on a No Purchase Necessary basis. The Floor Person will set up a demonstration table where the dealer will deal the cards as simulating a full game which will give the person an opportunity to be eligible for the promotion. The person will not be required to pay any fees, collection or a buy-in. All participation will be general and indiscriminate and will simulate a live game. The No Purchase Necessary player will play by the same rules as a player in a live game. If a No Purchase Necessary player qualifies for a prize, they will be awarded the full posted amount for that prize.

All approved games for Texas Hold'em Limit and No-Limit

3. *Describe any jackpot or any other type of prize awarded.*

The prize will be a fixed cash amount ranging from \$10.00 to \$500.00 for players who participate in all limits of Texas Hold'em games. In the case of a tie, each tied player will receive the full posted prize amount.

4. *If a cash prize is involved, is the amount of the prize progressive (increases) or a fixed amount?*

The cash prize is a fixed amount.

5. *Explain if the gaming activity is house funded or player funded.*

House funded.

6. *Describe any special fee collection involved in this gaming activity, for example, a jackpot fee collection.*

No additional fees.

7. *Describe how the jackpot will be seeded and how many prizes will be awarded.*

The prize will be a fixed cash amount of \$10.00 to \$500.00 for players who buy-in to a Texas Hold'em Limit or Non-Limit poker game offered at the establishment. The player does not need to be present to win. However they do need to come to Towers again to pick up their prize or money within 60 days. When someone becomes High Hand of the day, we will immediately take their Name, Address and Phone number. If their high hand holds up for the "qualifying period" they win. If they have already left the building they will be notified via phone and in writing within 48 hours by Towers Casino. They will have 60 days to get back to Towers to Claim their prize. If they do not make it back within 60 (from the date of the letter) they will forfeit their prize. We will put in CLAIM PRIZE BY: dd-mm-yy, on their letter.

8. *Explain any prize distribution including prizes given to the winner, loser, or any other player or patron.*

At pre-determined times of the day, the high hand of the day will be given away.

9. *Explain any re-seeding of the fund once the prize is won.*

The prize amount will immediately be reestablished when it is awarded.

10. *Explain any minimum or maximum number of players required to be dealt into the game for the table to be eligible for the gaming activity and prize.*

A standard Texas Hold'em game of at least five (5) players must be involved in the game for the hand to qualify.

11. *Explain if the house is retaining any administrative or any other type of fee for operating the gaming activity.*

No additional fees retained by the house.

12. *Describe any opportunity(s) for a person to play for the prize without placing any live wagers or paying any table fees.*

Any person wishing to participate in this gaming activity may do so by simply asking a Towers Casino Floor Person. (see NO PURCHASE NECESSARY BELOW)

Advertisements will be created upon approval of the promotion.

## **SUMMARY**

Towers Casino proposes to add a gaming activity to all currently approved wagering limits of Texas Hold'em. The promotion will award players who make the highest ranking hand within a specified time period. This promotion will be house funded. High hands will be tracked on a white board centrally located in the Poker area of the casino, indicating the player's name and the hand

## **PRIZE**

The prize will be a fixed cash (paid in casino chips) amount ranging from \$10.00 to \$500.00. The monies will be offered to players who are participating in a Texas Hold'em game, limit or no limit.



## FUNDING

This promotion will be house funded. There will be no collection or fees of any kind assessed to the poker players.

## NO PURCHASE NECESSARY

Any person wishing to participate in this gaming activity may do so by simply asking a Floor Person. The Floor Person will set up a demonstration table where the dealer will deal a card as simulating a full game which will give the person an opportunity to be eligible for the promotion. The person will not be required to pay any fees, collection or a buy-in. All participation will be general and indiscriminate and will simulate a live game. If a player makes a high hand for that designated time period they will be awarded the posted prize.

## ELIGIBILITY

The promotion will be open to all players who play in a Texas Hold'em game during specified eligible time periods. During the eligible time periods, the Floor Person will monitor and track all verified high hands on a white board (or similar) located in a prominent location in the Poker area.

The following details are offered:

Eligible time periods will range from one (1) to twelve (12) hours.

- At least five (5) players must be playing a Texas Hold'em game to qualify
- The Floor Person must verify the high hand prior to it being posted on the white board located in the poker area
- The player must use both of their two hole cards to qualify
- In the case that two or more players have the same hand, then each player will be awarded the posted prize.
- All procedures, times and cash amounts will be displayed prominently via printed flyers, digital display and any other forms of advertisements
- All High Hand prizes will be awarded in Towers Casino gaming chips
- Hand rank is as follows:

\* Royal Flush and Full House are ranked by suit Highest to lowest - spades; hearts; diamonds; and clubs.

\*\*Once Four of a Kind is hit, a HIGHER hand must be dealt to beat out the existing 4 of a kind. Rank highest to lowest is: A, K, Q, J, 10, 9, 8, 7, 6, 5, 4, 3, 2.

**Example: J,J,J,J is only beat by Q,Q,Q,Q or better. The first person to hit the hand takes precedence. If a second player hits Four Jacks – the first players hand stands. It must be a**

higher hand to qualify. However, if two players have equal hands at the same time, at the same or different tables, will constitute a tie.

Must use both of your two hole cards to qualify.

The funding for any Tournament gaming activities may be player funded, or house funded. What ever method is used will be pre-determined and posted before the tournament begins.

**6. Tournament structure (Including Buy-ins, Re-buys, Add-ons, etc.).**

Method of entry: Patrons may enter a tournament by paying a buy-in plus entry fee, winning a previous tournament, or winning their entry from a promotion at the casino. If time restrictions are used, they will be posted in advance of the start of the tournament.

Buy-in: \$0 - \$500,000

Re-buy: \$0 - \$500,000 / 1 time – unlimited times with time restrictions

Add-on: \$0 - \$500,000 / 1 time – 3 times with time restrictions

**7. Prize amount; source of funds.**

When the prize amount is guaranteed the payouts will be a cash value ranging from \$100 - \$10,000. The cash will be paid to players from the buy-ins, re-buys, and add-ons. If there is not enough cash to cover the guaranteed prize amount, the casino will fund the difference. If the prize pool is larger than the posted guaranteed amount, the excess funds will be added to the prize pool and the payouts will be calculated from the increased amount.

Other prizes may consist of entry into the World Series of Poker Tournament (W.S.O.P.). Rather than the first place tournament winner receiving a percentage of the prize pool, they will receive entry into the W.S.O.P. In addition, the Casino will pay for the winner's hotel accommodations while at the W.S.O.P. event in Las Vegas. The player must make his or her own travel arrangements for getting to/from Las Vegas. During this tournament, there will be only one winner.

The cash prize is a fixed amount ranging from \$25 minimum - \$1,000 maximum. The prize amount s on the prize wheel may vary, within the approved prize range, depending on the day of the week and time of the day. This promotion is for all Texas Hold'em Limit and No-Limit players. All prize amounts will be posted well in advance.

4. *If a cash prize is involved, is the amount of the prize progressive (increases) or a fixed amount?*

Fixed amount.

5. *Explain if the gaming activity is house funded or player funded.*

House funded.

6. *Describe any special fee collection involved in this gaming activity, for example, a jackpot fee collection.*

The Towers Casino Spin the Wheel promotion will offer a player an opportunity to spin the prize wheel for a cash or chip prize ranging anywhere from a minimum of \$25 to a maximum of \$1,000. The player will have to have made a certain qualifying hand (any hand with pocket Aces) beaten by a better hand. The player will receive the prize amount in Casino chips. Player must be in the hand at the river and have called all bets. Both hands must be turned face up after all river bet action and calls have been played out. Both hole cards in the qualifying beaten hand must be used for the hand to be eligible.

The player with the beaten qualifying hand will receive 100% of the amount on the prize wheel. If multiple players have qualifying losing hands, each will receive a spin of the prize wheel. There is no limit on how many spins a player can receive, so long as they have a qualifying hand for each spin.

The prize pool is house funded. It will immediately be re-seeded.

Cards are not transferrable, and must only be used by the patron it was assigned to.

The VIP Players Tracking Card is used to track play and earn points. The moment a player's chips are "in play" the floor man will swipe their card into our player tracking system which will keep track of their Game/time/hours played. When the player leaves the table at the end of play (or for a break 30 minutes or longer), they will be logged out of the system with a swipe of the card. If they return to the game, they can easily be logged back in.

Players participating in a tournament will receive a set amount of playing time credit for entering the tournament. This amount will be pre-determined and clearly posted before the tournament begins.

The hours/time will translate that 1 hour of play = 10 points and be prorated thereof. (Example: a player plays 2.5 hours, they will get 10 points per hour, in this case, prorated to 25 points.)

Based upon the number of points accumulated on a monthly basis, they may redeem their points for the following: Cash prizes, as well as non-cash prizes such as gift certificates for dinner at local restaurants, T-Shirts, hats, chip protectors, pens, etc., ranging in value from \$1 - \$500 The prizes will all be house funded.

Points earned will not expire.

In the case of a malfunction with the time tracking equipment, each players playing time will be tracked manually

The VIP Players card may also be used to track hours of play for other promotions being offered at the Towers Casino.

Players are responsible for the accuracy of the hours and must ensure their cards get swiped and their play is tracked when they begin play. If a player forgets to hand over their card, Towers Casino is unable to go back and change the "start time" for tracking play.



At any time, a player can ask a floorperson to give them the total amount of points that they have on their card.

The prize amount and prizes will be fully funded by the Towers Casino, and will be pre-determined and clearly posted before the start of the promotional period.
